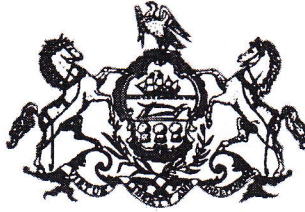

RE: Re-introduction of Legislation

Please find requests of co-sponsorship for eleven (11) pieces of legislation, which I plan on reintroducing in the coming weeks.

**Former HB697-** Amends Title 66 (Public Utilities) and provides for electricity supplied to seasonal businesses.

PREVIOUS CO-SPONSORS: CARROLL , CONKLIN , EVERETT , GEORGE , HALUSKA , HARRIS , HELM , HESS , KORTZ , MAHONEY , ROAE and HORNAMAN

**Former HB923-** Amends the County Code and permits county officials to destroy original records if they are microfilmed or converted to electronic format and stored outside the office.

PREVIOUS CO-SPONSORS: BRENNAN , DENLINGER , DERMODY , HELM , KORTZ , MAHONEY , PICKETT , YOUNGBLOOD and BROOKS

**Former HB924-** Amends the County Code and provides for board of visitors for charitable reform and penal institutions.

PREVIOUS CO-SPONSORS: BRENNAN , CONKLIN , EVERETT , KORTZ and MAHONEY

**Former HB1666-** Amends Title 66 (Public Utilities) and requires public utilities to provide customers with an itemized statement that estimates installation charges.

PREVIOUS CO-SPONSORS: CALTAGIRONE , FREEMAN , MAHONEY , YOUNGBLOOD and HESS

**Former HB2028-** Amends Title 75 (Vehicles) and adds antique, classic and collectible vehicles to seasonal registration.

PREVIOUS CO-SPONSORS: BRENNAN , CONKLIN , DENLINGER , EVERETT , HESS , HORNAMAN , KULA , LONGIETTI , MAJOR , SAINATO , STABACK and YOUNGBLOOD

**Former HB2051-** Amends the Administrative Code of 1929 and provides for submission of budget recommendations by standing committees.

PREVIOUS CO-SPONSORS: CONKLIN , CUTLER , DeLUCA , ELLIS , EVERETT , KORTZ , READSHAW , SHAPIRO , STEVENSON , SWANGER , MIRABITO and SAMUELSON

**Former HB2086-** Amends Title 75 (Vehicles) and provides for regulation and operation of kei class light duty trucks.

PREVIOUS CO-SPONSORS: KULA, MAHONEY and MURT

**Former HB2104-** Amends Title 75 (Vehicles) and provides for exhaust systems, mufflers and noise control.

PREVIOUS CO-SPONSOR: BRIGGS

**Former HB2181-** Amends the Workers' Compensation Act and provides for reimbursements to host municipalities for emergency services. It requires reimbursement seven days prior to the premium due date.

PREVIOUS CO-SPONSORS: BOYD, CARROLL, CONKLIN, EVERETT, FABRIZIO, GEORGE and GERGELY

**Former HB2613-** Amends the Oil and Gas Act and provides for protection of water supplies. It enhances water supply protection to within 5,000 feet and extends the deadline to one year after the completion of drilling or alteration.

PREVIOUS CO-SPONSORS: MIRABITO, BRADFORD, BRIGGS, CALTAGIRONE , HESS, JOSEPHS , KORTZ , MAHONEY , MARSHALL , METZGAR, MURPHY, PAYTON , ROEBUCK , STABACK , WAGNER , WHITE and READSHAW

**Former HB2646-** Amends Title 75 (Vehicles) and allows for security required for maintenance of highways and bridges to be \$250,000 per linear mile.
