Proposed Legislation - Increased Penalties for Involvement with Stolen

Guns (Prior HB 853)

DATE:

I am preparing to re-introduce legislation to address the serious problem of stolen guns. This bill targets those who knowingly possess stolen guns as well as those who engage in the business of dealing stolen guns.

Presently, the existing penalty for knowing possession of a stolen gun depends on the value of the gun. 18 Pa.C.S. § 3903(b). The penalty is a mere misdemeanor unless the prosecution can prove that the value of the stolen gun exceeds \$2,000. This penalty is clearly inadequate given the seriousness of the offense. Furthermore, information regarding the value can be difficult and time-consuming to gather and prove in court.

My bill will make the penalty for knowingly possessing a stolen gun the same as the existing penalty for stealing a gun. Currently, the crime of stealing a gun is appropriately graded as a second-degree felony. 18 Pa.C.S. § 3903(a)(2). Thus, my bill eliminates the illogical distinction between those criminals who steal guns and those who knowingly possess them, making both offenses second-degree felonies.

In addition, my bill will further punish persons who are engaged in the business of dealing stolen guns. The current penalty – a second-degree felony – is insufficient to reflect our dedication to attacking the stolen gun trade. By raising the grade of this crime to a first-degree felony, my bill will give judges the power to impose more appropriates sentence on stolen gun dealers.

We must take every step to deter people from knowingly possessing or dealing stolen guns, and also to give judges the ability to deal harshly with those who do. This is why I'm proposing to raise the penalties for these crimes.
