**Former HB 358**- Mandatory Physical-Education in Public Schools: An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in terms and courses of study, further providing for physical education.

*Previous co-sponsors:* YOUNGBLOOD , KIRKLAND , READSHAW , MELIO , SIPTROTH , SABATINA , SEIP , VEREB , M. SMITH , PRESTON , HANNA , MURT , HARHAI and WALKO

**Former HB 360**- Prohibiting Certain Attire in Public Schools: An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, further providing for uniforms and prohibited attire.

*Previous co-sponsors:* YOUNGBLOOD , READSHAW , SABATINA , THOMAS , MAHONEY , K. SMITH and CLYMER

**Former HB 361**- Diabetes Testing Prior to Admission to Schools: An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, further providing for immunization required and penalty; and requiring children to be tested for diabetes prior to admission.

*Previous co-sponsors:* YOUNGBLOOD , FRANKEL , SIPTROTH , KIRKLAND , READSHAW , PHILLIPS , STABACK , D. COSTA , GEORGE , JOSEPHS and K. SMITH

**Former HB 363**- Prohibiting Cell Phones in Public Schools: An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, further prohibiting possession of telephone pagers and certain electronic devices.

*Previous co-sponsors:* YOUNGBLOOD , MUSTIO , KORTZ , REICHLEY , READSHAW , SABATINA , SIPTROTH and THOMAS

**Former HB 365**- Valid License to Operate State Vehicle: An Act amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, requiring public officials and public employees who use government vehicles to provide proof of holding a valid driver's license.

**Former HB 366**- Community Service In lieu of 50% of Fines: An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in penalties and disposition of fines, further providing for inability to pay fine and costs.

*Previous co-sponsors: YOUNGBLOOD , BOYD , SIPTROTH , M. O'BRIEN , LONGIETTI , KIRKLAND , THOMAS , BROWN and GIBBONS*

**Former HB 376-** Video Cameras in Day Care Facilities: An Act requiring certain facilities and persons that provide child day care to install video camera surveillance systems; and conferring powers and duties on the Department of Public Welfare.

*Previous co-sponsors: YOUNGBLOOD and CONKLIN*

**Former HB 532-** Prohibit Cell Phones When Dispensing Fuel: An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in miscellaneous offenses, providing for the offense of wireless communications device use while dispensing liquid fuel.

*Previous co-sponsors: YOUNGBLOOD , M. O'BRIEN , SIPTROTH , McGEEHAN , VULAKOVICH , MILNE , SWANGER and K. SMITH*

**Former HB 533-** Prohibit the Sale of Outdated Food and Goods: An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in trade and commerce, prohibiting the sale of food, nonprescription drugs and cosmetics under certain circumstances; and imposing penalties.

*Previous co-sponsors: YOUNGBLOOD , HORNAMAN , SIPTROTH , PARKER , M. O'BRIEN , JOSEPHS and MILNE*

**Former HB 534-** Murder of an Unborn Child: An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in authorized disposition of offenders, further providing for sentence for murder and murder of an unborn child; and, in crimes against unborn child, further providing for the offenses of murder of unborn child and voluntary manslaughter of unborn child.

**Former HB 570-** Unfair Trade Practices---Include Sales Tax in Price Listed: An Act amending the act of December 17, 1968 (P.L.1224, No.387), known as the Unfair Trade Practices and Consumer Protection Law, further defining "unfair methods of competition" and "unfair or deceptive acts or practices."

**Former HB 742-** Prohibiting Firearms in the Capitol Complex: An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, providing for the offense of carrying a firearm in the Capitol.

**Former HB 920-** Prohibit Turns in Parking Lots on Corners: An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in rules of the road in general, providing for limitation on use of parking lots and gas stations for turning.

**Former HB 1991-** Election Code---Failure to Vote: An Act amending Title 25 (Elections) of the Pennsylvania Consolidated Statutes, further providing for failure to vote.
