## MEMORANDUM

**TO:** All House Members

**FROM:** Representative Dom Costa *DC*

**SUBJECT:** Introduction of Legislation – Amend the Right to Know Law to Exempt from Access the Home Address of Public School Teachers and Employees

---

In the near future, I plan to introduce legislation that will further extend the Right to Know Law exceptions to the home addresses of any public school teacher or employee.

If passed, this legislation would exempt from public access the home address of any teacher, administrator, staff aids and assistants, and any other individual employed by a public school district within the Commonwealth of Pennsylvania. This exemption will protect a public school employee's right to privacy in their own home, and provide school employees with an additional layer of protect from potentially harmful individuals.

By prohibiting access to the home addresses of our public school employees, we can further protect those individuals who willingly give their time to our children nearly every day. ## AN ACT

1 Amending the act of February 14, 2008 (P.L.6, No.3), entitled  
2 "An act providing for access to public information, for a  
3 designated open-records officer in each Commonwealth agency,  
4 local agency, judicial agency and legislative agency, for  
5 procedure, for appeal of agency determination, for judicial  
6 review and for the Office of Open Records; imposing  
7 penalties; providing for reporting by State-related  
8 institutions; requiring the posting of certain State contract  
9 information on the Internet; and making related repeals,"  
10 further providing for exceptions for public records.

11 The General Assembly of the Commonwealth of Pennsylvania  
12 hereby enacts as follows:

13 Section 1. Section 708(b)(6) of the act of February 14, 2008  
14 (P.L.6, No.3), known as the Right-to-Know Law, is amended to  
15 read:

16 Section 708. Exceptions for public records.

17 \* \* \*

18 (b) Exceptions.--Except as provided in subsections (c) and  
19 (d), the following are exempt from access by a requester under  
20 this act:

21 \* \* \*

1 (6) (i) The following personal identification  
2 information:

3 (A) A record containing all or part of a  
4 person's Social Security number, driver's license  
5 number, personal financial information, home,  
6 cellular or personal telephone numbers, personal e-  
7 mail addresses, employee number or other confidential  
8 personal identification number.

9 (B) A spouse's name, marital status or  
10 beneficiary or dependent information.

11 (C) The home address of a law enforcement  
12 officer [or], judge or any individual employed by a  
13 public school district as defined in section 102 of  
14 the act of March 10, 1949 (P.L.30, No.14), known as  
15 the Public School Code of 1949.

16 (ii) Nothing in this paragraph shall preclude the  
17 release of the name, position, salary, actual  
18 compensation or other payments or expenses, employment  
19 contract, employment-related contract or agreement and  
20 length of service of a public official or an agency  
21 employee.

22 (iii) An agency may redact the name or other  
23 identifying information relating to an individual  
24 performing an undercover or covert law enforcement  
25 activity from a record.

27 Section 2. This act shall take effect in 60 days.
