Subject:

Co-sponsorship - Wheelchair-Accessible Taxicabs

In the near future, I plan to introduce legislation that would enable a more robust and appropriate complement of wheelchair-accessible taxicabs in the City of Philadelphia.

The Philadelphia Parking Authority (PPA) is the body responsible for the oversight and administration of taxicab certificates and medallions in Philadelphia. Title 53, Chapter 57, does not currently allow the PPA to issue additional certificates and medallions specifically for wheelchair-accessible taxicabs. Unfortunately, Philadelphia does not currently have adequate resources to ensure the transport of the disabled community who would benefit from this type of taxicab access.

My legislation would amend Title 53 (Municipalities Generally), adding §5717.1, authorizing the PPA to encourage the conversion of existing medallion taxicabs to wheelchair-accessible taxicabs. If four months after the effective date of the legislation the number of wheelchair-accessible taxicabs is fewer than 50, the authority will begin the process of issuing additional certificates and medallions to applicants to increase the complement to 50 in operation. These new medallions may be issued over a period of time authorized by the authority.

This language was passed as part of House Bill 2545 in the 2005-06 legislative session, but was vetoed by the Governor due to provisions in the bill unrelated to the wheelchair-accessible taxicab language. The standalone legislation is attached.

AN ACT

- 1 Amending Title 53 (Municipalities Generally) of the Pennsylvania
- 2 Consolidated Statutes, providing for wheelchair-accessible
- 3 service.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 53 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 5717.1. Wheelchair-accessible service.
- 9 (a) Issuance of certificates and medallions. -- The authority
- 10 may by order or regulation provide for special medallion fees,
- 11 rights, privileges and limitations to encourage conversion of
- 12 existing medallion taxicabs to wheelchair-accessible taxicabs.
- 13 If, four months after the effective date of this section, the
- 14 number of wheelchair-accessible taxicabs with citywide call or
- 15 demand rights in cities of the first class is fewer than 50, the
- 16 authority shall begin the process of issuing additional
- 17 certificates and corresponding medallions to applicants to
- 18 provide wheelchair-accessible taxicab service to increase the

- 1 number of wheelchair-accessible taxicabs to 50 operational
- 2 wheelchair-accessible taxicabs. These medallions shall only be
- 3 attached to wheelchair-accessible taxicabs and shall in the
- 4 <u>discretion of the authority be issued at a reasonable market</u>
- 5 price consistent with section 5717 (relating to additional
- 6 certificates and medallions) or through a competitive request
- 7 for proposal process open to any otherwise qualified person in
- 8 which factors in addition to market value may be considered in
- 9 the best interests of the public. The authority may in its
- 10 discretion issue these medallions in stages.
- 11 (b) Contract service. -- Any medallion taxicab providing
- 12 service in a wheelchair-accessible vehicle shall also be
- 13 permitted to provide contract service, consistent with the
- 14 Pennsylvania Public Utility Commission's rules and regulations.
- 15 The authority may limit the amount of contract service that may
- 16 be provided by medallion taxicabs using wheelchair-accessible
- 17 vehicles if it finds that the contract service is impairing the
- 18 taxicab industry's ability to provide common-carrier taxicab
- 19 service to people with disabilities. This contract service may
- 20 be provided under rates other than the approved rate for
- 21 exclusive service that applies to the common-carrier service
- 22 provided by medallion taxicabs.
- 23 (c) Age restriction. -- The vehicle age restrictions of
- 24 section 5714(a) (relating to certificate and medallion required)
- 25 shall not apply to wheelchair-accessible vehicles if the
- 26 vehicles meet all inspection requirements of this chapter and as
- 27 <u>established by the authority.</u>
- 28 Section 2. This act shall take effect in 60 days.
