Alzheimer Disease State Plan

In the near future, I plan to introduce legislation for a Pennsylvania Alzheimer Disease Plan. The plan is a comprehensive blueprint for how we will address the growing Alzheimer's crisis. It creates the infrastructure and accountability necessary to build dementia-capable programs and services for the nearly 400,000 currently diagnosed victims, with over 650,000 caregivers supporting them, resulting in 1 in 12 of Pennsylvanian families being affected. To date, 31 states have either published or are in the process of writing an Alzheimer Disease Plan.

The plan will prepare the Commonwealth to address a range of issues, including:

- dementia-capable support services for people at all stages of the disease;
- quantifying the number of individuals with Alzheimer's in the Commonwealth through a <u>Behavioral Risk Factor Surveillance System</u>;
- quality of long-term care;
- Medicaid coverage of long-term care for those who cannot afford it;
- availability of diagnostic services;
- and safety of persons who wander.

This initiative charges state agencies, legislators, residential and community care providers, professional and family caregivers, and persons with Alzheimer Disease to work together in-concert to create a plan that addresses the Alzheimer's epidemic with a thoughtful, integrated, and cost-effective approach.
