## MEMORANDUM

**SUBJECT:** Cosponsor – Public School Retiree Information

Keeping Pennsylvania residents abreast of the legislative activity the General Assembly is undertaking has long been a responsibility of each and every Member of both the House and Senate. Methods such as newsletters, website updates, e-mail and social media are prevalent examples of steps the General Assembly takes to make sure the public is informed regarding legislative activity. However, there is no doubt that more can be done to assist groups groups such as retirees to ensure that the actions of the General Assembly are readily known and accessible.

With this in mind, I will be introducing legislations which will amend Title 24 (Education) with the intent of aiding public school retirees regarding the existence of legislation, programs and other related information that may be of interest to them. As provided in my legislation, organizations that are comprised of retirees, such as the Pennsylvania Association of School Retirees (PASR) would be permitted to obtain information on individual retirees from PSERS for the purpose of promoting membership and examining relevant legislation proposals.
