1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated

Statutes, further defining "interactive wireless

3 communications device"; prohibiting use of interactive

- 4 wireless communications device; and further providing for
- duty of driver in construction and maintenance areas or on
- 6 highway safety corridors and for duty of driver in emergency
- 7 response areas.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. The definition of "interactive wireless
- 11 communications device" in section 102 of Title 75 of the
- 12 Pennsylvania Consolidated Statutes is amended to read:
- 13 § 102. Definitions.
- 14 Subject to additional definitions contained in subsequent
- 15 provisions of this title which are applicable to specific
- 16 provisions of this title, the following words and phrases when
- 17 used in this title shall have, unless the context clearly
- 18 indicates otherwise, the meanings given to them in this section:
- 19 * * *
- 20 "Interactive wireless communications device." A wireless

- 1 telephone, personal digital assistant, smart phone, portable or
- 2 mobile computer or similar device which can be used for voice
- 3 communication, texting, e-mailing, browsing the Internet or
- 4 instant messaging. The term does not include any of the
- 5 following:
- 6 (1) a device being used exclusively as a global
- 7 positioning or navigation system;
- 8 (2) a system or device that is physically or
- 9 electronically integrated into the vehicle; [or]
- 10 (3) a communications device that is affixed to a mass
- transit vehicle, bus or school bus[.]; or
- 12 <u>(4) an amateur radio or a citizens band radio.</u>

- 14 Section 2. Section 3316 of Title 75 is amended to read:
- 15 § 3316. Prohibiting [text-based communications] use of
- 16 <u>interactive wireless communications device</u>.
- 17 (a) Prohibition.--[No driver]
- 18 <u>(1) Except as provided in subsection (b), no person</u>
- 19 shall [operate] <u>drive</u> a motor vehicle on a [highway] roadway
- or trafficway in this Commonwealth while using an interactive
- 21 wireless communications device [to send, read or write a
- text-based communication while the vehicle is in motion. A
- person does not send, read or write a text-based
- communication when the person reads, selects or enters a
- 25 telephone number or name in an interactive wireless
- 26 communications device for the purpose of activating or
- 27 deactivating a voice communication or a telephone call.] <u>for</u>
- a purpose other than:
- 29 <u>(i) voice communication through the use of an</u>
- 30 <u>interactive wireless communications device while in</u>

2	(ii) reading, selecting or entering a telephone
3	number or name into an interactive wireless
4	communications device for the purpose of voice
5	communication; or
6	(iii) utilizing a global positioning or navigation

8	(2) No person with a learner's permit or junior driver's
9	license shall drive a motor vehicle upon a roadway or
10	trafficway in this Commonwealth while using an interactive
11	wireless communications device.
12	(b) [(Reserved).] <u>ExceptionsThis section shall not apply</u>
13	to:
14	(1) A person using an interactive wireless
15	communications device to contact a 911 system or wireless E-
16	911 service, as defined in 35 Pa.C.S. § 5302 (relating to
17	<pre>definitions).</pre>
18	(2) A person using an interactive wireless
19	communications device when the vehicle is stopped due to a
20	traffic obstruction and the motor vehicle transmission is in
21	neutral or park.
22	(3) Operators of emergency vehicles who use an
23	interactive wireless communications device for voice
24	communication for the purpose of responding to an emergency
25	while engaged in the performance of their official duties.
26	(4) Volunteer emergency responders who use an
27	interactive wireless communications device for voice
28	communication for the purpose of responding to an emergency
29	while engaged in the performance of their official duties.
30	(c) SeizureThe provisions of this section shall not be

- 1 construed as authorizing the seizure or forfeiture of an
- 2 interactive wireless communications device, unless otherwise
- 3 provided by law.
- 4 (d) Penalty.--
- 5 <u>(1)</u> A person who violates subsection (a) commits a
- 6 summary offense and shall, upon conviction, be sentenced to
- 7 pay a fine of \$50.
- 8 (2) A person who violates subsection (a) while passing
- 9 through a school zone, as defined and provided under the
- 10 regulations of the department, commits a summary offense and
- shall, upon conviction, be sentenced to pay a fine of \$100.
- 12 An official traffic-control device shall indicate the
- beginning and end of each school zone to traffic approaching
- in each direction. Establishment of a school zone, including
- its location and hours of operation, shall be approved by the
- 16 department.
- 17 (e) Preemption of local ordinances.--In accordance with
- 18 section 6101 (relating to applicability and uniformity of
- 19 title), this section supersedes and preempts all ordinances of
- 20 any municipality with regard to the use of an interactive
- 21 wireless communications device by the driver of a motor vehicle.
- 22 (e.1) Public education and awareness programs. -- The
- 23 department shall develop and maintain Statewide public education
- 24 and awareness programs to combat distracted driving and promote
- 25 awareness of the provisions of this section.
- 26 (f) [Definition.--As used in this section, the term "text-
- 27 based communication means a text message, instant message,
- 28 electronic mail or other written communication composed or
- 29 received on an interactive wireless communications device.]
- 30 Definitions. -- As used in this section, the following words and

- 1 phrases shall have the meanings given to them in this subsection
- 2 <u>unless the context clearly indicates otherwise</u>:
- 3 <u>"Hands-free mode."</u> The use of an interactive wireless
- 4 communications device that allows the user to engage in
- 5 communication without the use of either hand by means of an
- 6 <u>internal feature or function or an attachment or device.</u>
- 7 <u>"Volunteer emergency responder." Any of the following:</u>
- 8 (1) A member of a volunteer ambulance service as defined
- 9 in 35 Pa.C.S. § 7363 (relating to definitions).
- 10 (2) A member of a volunteer fire company as defined in
- 11 <u>35 Pa.C.S. § 7363.</u>
- 12 (3) A member of a volunteer rescue service as defined in
- 13 <u>35 Pa.C.S.</u> § 7363.
- 14 Section 3. Sections 3326(c) and 3327(e) of Title 75 are
- 15 amended to read:
- 16 § 3326. Duty of driver in construction and maintenance areas or

- 19 (c) Fines to be doubled.--For any of the following
- 20 violations, when committed in an active work zone manned by
- 21 workers acting in their official capacity or on a highway safety
- 22 corridor designated under section 6105.1 (relating to
- 23 designation of highway safety corridors), the fine shall be
- 24 double the usual amount:

- 28 (e) Fines to be doubled.--In addition to any penalty as
- 29 provided in subsection (b), the fine for any of the following
- 30 violations when committed in an emergency response area manned

- 1 by emergency service responders shall be double the usual
- 2 amount:
