AN ACT

- Amending the act of December 19, 1988 (P.L.1262, No.156), 1 entitled, as amended, "An act providing for the licensing of 2 eligible organizations to conduct games of chance, for the 3 licensing of persons to distribute games of chance, for the 4 registration of manufacturers of games of chance, and for 5 suspensions and revocations of licenses and permits; 6 requiring records; providing for local referendum by 7 electorate; and prescribing penalties, "further providing for 8 the definition of "games of chance"; and defining "coin 9 auction." 10
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. The definition of "games of chance" in section
- 14 103 of the act of December 19, 1988 (P.L.1262, No.156), known as
- 15 the Local Option Small Games of Chance Act, amended February 2,
- 16 2012 (P.L.7, No.2), is amended and the section is amended by
- 17 adding a definition to read:
- 18 Section 103. Definitions.
- 19 The following words and phrases when used in this act shall
- 20 have the meanings given to them in this section unless the
- 21 context clearly indicates otherwise:

- 1 * * *
- 2 "Coin auction." A game in which a participant buys a
- 3 <u>numbered paddle for a chance to bid on a donated prize with the</u>
- 4 winner determined by a random drawing of corresponding numbers.
- 5 * * *
- 6 "Games of chance." Punchboards, daily drawings, weekly
- 7 drawings, raffles, coin auctions and pull-tabs, as defined in
- 8 this act, provided that no such game shall be played by or with
- 9 the assistance of any mechanical or electrical devices or media
- 10 other than a dispensing machine or passive selection device and
- 11 further provided that the particular chance taken by any person
- 12 in any such game shall not be made contingent upon any other
- 13 occurrence or the winning of any other contest, but shall be
- 14 determined solely at the discretion of the purchaser. This
- 15 definition shall not be construed to authorize any other form of
- 16 gambling currently prohibited under any provision of Title 18 of
- 17 the Pennsylvania Consolidated Statutes (relating to crimes and
- 18 offenses) or authorized under 4 Pa.C.S. (relating to
- 19 amusements). Nothing in this act shall be construed to authorize
- 20 games commonly known as "slot machines" or "video poker."
- 21 * * *
- 22 Section 2. This act shall take effect in 60 days.
