- 1 Requiring certain facilities and persons that provide child day
- care to install video camera surveillance systems; and

- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Video Camera
- 9 Surveillance in Child Day-Care Facilities Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- "Child day care." Care in lieu of parental care given for
- 15 part of a 24-hour day to a child under 16 years of age away from
- 16 the child's home. The term does not include care in lieu of
- 17 parental care given to a child under 16 years of age in a place
- 18 of worship during religious services.

- 1 "Child day-care center." Any premises in which child day
- 2 care is provided simultaneously for seven or more children who
- 3 are not relatives of the provider, regardless of which article
- 4 of the act of June 13, 1967 (P.L.31, No.21), known as the Public
- 5 Welfare Code, applies to it.
- 6 "Department." The Department of Public Welfare of the
- 7 Commonwealth.
- 8 "Facility." Any of the following:
- 9 (1) Child day-care center.
- 10 (2) Family day-care home.
- "Family day-care home." A home in which child day care is
- 12 provided at any one time to four, five or six children who are
- 13 not relatives of the provider of the child day care and which is
- 14 required to be registered under the act of June 13, 1967 (P.L.
- 15 31, No.21), known as the Public Welfare Code.
- 16 Section 3. Video camera surveillance systems.
- 17 (a) Duty to install and maintain. -- Each facility shall
- 18 install and maintain video camera surveillance systems that meet
- 19 or exceed the specifications for such systems as established by
- 20 regulation of the department.
- 21 (b) Regulations. -- The department shall promulgate
- 22 regulations that provide specifications for video camera
- 23 surveillance systems in facilities and standards for the use of
- 24 such systems.
- 25 (c) Inspections.--The department may conduct inspections of
- 26 facilities to investigate compliance with this act.
- 27 Section 4. Applicability.
- This act shall apply to facilities that commence operations
- 29 after the effective date of this section.
- 30 Section 5. Effective date.

1 This act shall take effect in 60 days.
