## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto, " further providing for Office for Safe 5 Schools. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 1302-A(b) and (c) of the act of March 10, 9 1949 (P.L.30, No.14), known as the Public School Code of 1949, 10 amended November 17, 2010 (P.L.996, No.104), are amended to 11 12 read: Section 1302-A. Office for Safe Schools.--\* \* \* 13 The office shall have the power and duty to implement 14 (b) the following: 15 To coordinate antiviolence efforts between school, 16 (1)professional, parental, governmental, law enforcement and 17 community organizations and associations. 18 To collect, develop and disseminate information, 19 (2)

policies, strategies and other information to assist in the
 development of programs to impact school violence.

3 (2.1) To direct all school entities to submit annual school 4 violence statistics and reports to the office no later than July 5 31 of each year.

6 (3) To provide direct training to school employes, parents,
7 law enforcement officials and communities on effective measures
8 to prevent and combat school violence.

9 (4) To advise school entities and nonpublic schools on the 10 development of policies to be used regarding possession of 11 weapons by any person, acts of violence and protocols for 12 coordination with and reporting to law enforcement officials and 13 the Department of Education.

14 (4.1) To verify the existence of corrective action plans to
15 reduce incidents of violence as required in the No Child Left
16 Behind Act of 2001 (Public Law 107-110, 115 Stat. 1425).

17 (5) To develop forms to be used by school entities and 18 police departments for reporting incidents involving acts of 19 violence and possession of weapons on school property. The forms 20 shall be reviewed on a biennial basis and revised when 21 necessary.

(6) To verify that each school entity has a biennially updated and reexecuted memorandum of understanding with local law enforcement and has filed such memorandum with the office on a biennial basis.

(7) To publish and post on the Department of Education's Internet website a School Safety Annual Report no later than November 1 of each calendar year outlining all incidents required to be reported under section 1303-A and any school district that failed to submit a report under section 1303-A.

1 (8) Not later than January 2, 2013, to establish an antigang counseling program to provide materials, support and financial 2 assistance to participating school districts to establish pilot 3 programs designed to educate students and parents on the 4 following: 5 (i) The extent to which criminal gang activity exists in the 6 school district's community and the types of activity that\_ 7 criminal gangs engage in or promote. 8 (ii) The negative societal impacts that criminal gangs have 9 on a community, including criminal activity. 10 (iii) Methods to discourage participation in criminal gangs. 11 (iv) The consequences of criminal gang activity, including 12 consequences in the criminal justice system for participating in 13 14 criminal gangs. 15 (9) To encourage the use of community resources not directly affiliated with the school district, including the participation 16 of law enforcement officials in a pilot program under paragraph 17 (8). 18 \* \* \* 19 (c) In addition to the powers and duties set forth under 20 subsection (b), the office is authorized to make targeted grants 21 to school entities to fund programs which address school 22 violence, including: 23 Conflict resolution or dispute management, including 24 (1)25 restorative justice strategies. School-wide positive behavior support that includes 26 (1.1)primary or universal, secondary and tertiary supports and 27 interventions in school entities. 28 (1.2)School-based diversion programs. 29 30 (2) Peer helpers programs.

(3) Risk assessment, safety-related, violence prevention
 curricula, including, but not limited to, dating violence
 curricula and restorative justice strategies.

4 (4) Classroom management.

5 (5) Student codes of conduct.

6 (6) Training to undertake a districtwide assessment of risk
7 factors that increase the likelihood of problem behaviors among
8 students.

9 (7) Development and implementation of research-based 10 violence prevention programs that address risk factors to reduce 11 incidents of problem behaviors among students including, but not 12 limited to, bullying.

13 (8) Comprehensive, districtwide school safety and violence14 prevention plans.

Security planning, purchase of security-related 15 (9) 16 technology which may include metal detectors, protective 17 lighting, surveillance equipment, special emergency communications equipment, electronic locksets, deadbolts and 18 theft control devices and training in the use of security-19 related technology. Security planning and purchase of security-20 related technology shall be based on safety needs identified by 21 22 the school entity's board of directors.

(10) Institution of student, staff and visitor
identification systems, including criminal background check
software.

26 (11) Establishment or enhancement of school security27 personnel, including school resource officers.

(12) Provision of specialized staff and student training
programs, including training for Student Assistance Program team
members in elementary, middle and high schools in the referral

1 of students at risk of violent behavior to appropriate

2 community-based services, including mental health services.

3 (13) Alternative education programs provided for in Article4 XIX-C.

5 (14) Counseling services for students enrolled in6 alternative education programs.

7 (15) An Internet web-based system for the management of
8 student discipline, including misconduct and criminal offenses.

9 (16) Staff training programs in the use of positive behavior 10 supports, de-escalation techniques and appropriate responses to 11 student behavior that may require immediate intervention.

12 (17) Antigang pilot programs.
