- 7 Section 1. Section 4912 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 4912. Impersonating a public servant.
- 10 (a) Offenses defined. -- A person commits [a misdemeanor of
- 11 the second degree if he falsely] the offense of impersonating a
- 12 public servant if:
- 13 (1) The person pretends to hold a position in the public
- 14 service with intent to induce another to submit to such
- pretended official authority or otherwise to act in reliance
- upon that pretense [to his prejudice].
- 17 (2) The person pretends to be a law enforcement officer
- with intent to induce another to submit to such pretended
- 19 official authority or otherwise act in reliance upon that

- 1 pretense.
- 2 (b) Grading. --
- 3 (1) An offense under subsection (a) (1) is a misdemeanor
- 4 <u>of the second degree.</u>
- 5 (2) An offense under subsection (a)(2) is a felony of
- 6 the third degree.
- 7 (c) Definition.--As used in this section, the term "law
- 8 <u>enforcement officer" means any of the following:</u>
- 9 (1) A member of the Pennsylvania State Police.
- 10 (2) A liquor enforcement officer of the Pennsylvania
- 11 State Police.
- 12 (3) Any enforcement officer or investigator employed by
- the Pennsylvania Liquor Control Board.
- 14 (4) A parole agent, enforcement officer and investigator
- of the Pennsylvania Board of Probation and Parole.
- 16 <u>(5) A Capitol Police officer.</u>
- 17 (6) A Department of Conservation and Natural Resources
- 18 <u>ranger</u>.
- 19 (7) A drug enforcement agent of the Office of Attorney

- of Attorney General whose principal duty is the enforcement

- 24 (8) Any member of a port authority or other authority

11	Section 2. Section 4571 of Title 75 is amended by adding

13	§ 4571. Visual and audible signals on emergency vehicles.

15	(d.1) Sale of emergency vehicle
16	(1) A seller of an emergency vehicle equipped with
17	revolving or flashing lights or audible warning systems
18	identical or similar to those specified in subsections (a)
19	and (b) shall remove such lights or systems upon the sale of
20	the vehicle to a buyer who is not authorized by law or
21	regulation to operate an emergency vehicle with visual or
22	audible systems.
23	(2) A person who sells a vehicle equipped with visual or
24	audible warning systems in violation of this subsection
25	commits a summary offense and shall, upon conviction, be
26	sentenced to pay a fine of not less than \$500 nor more than
27	\$1,000.
28	(3) A person who sells a vehicle equipped with visual or
29	audible warning systems in violation of this subsection who
30	knows or should have known of the buyer's intent to use the

1	vehicle in violation of 18 Pa.C.S. § 4912(a)(2) (relating to
2	impersonating a public servant) commits a misdemeanor of the
3	third degree.
4	(d.2) ExceptionsSubsections (d) and (d.1) shall not apply
5	to any of the following:
6	(i) The sale or use of police, fire or other
7	emergency vehicles for which antique, classic, vintage or
8	collectible registration plates have been issued under
9	section 1340 (relating to antique, classic and
10	collectible plates) and which are driven or transported
11	without operation of visual or audible warning systems.
12	(ii) The sale or use of police, fire or other
13	emergency vehicles for which manufacturer or dealer
14	registration plates have been issued under section 1335
15	(relating to registration plates for manufacturers and
16	dealers) and which are driven or transported without
17	operation of visual or audible warning systems for the
18	purpose of sale, service, demonstration or exhibition.

20	Section 3. This act shall take effect in 60 days.
