## AN ACT

- 1 Amending the act of October 5, 1978 (P.L.1109, No.261), entitled
- 2 "An act requiring the licensing of practitioners of
- osteopathic medicine and surgery; regulating their practice;
- 4 providing for certain funds and penalties for violations and
- repeals, " further providing for physician assistants.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 10(g) of the act of October 5, 1978
- 9 (P.L.1109, No.261), known as the Osteopathic Medical Practice
- 10 Act, amended July 20, 2007 (P.L.316, No.47), is amended and the
- 11 section is amended by adding a subsection to read:
- 12 Section 10. Licenses; exemptions; nonresident practitioners;
- 13 graduate students; biennial registration and
- 14 continuing medical education.
- 15 \* \* \*
- 16 (g) The supervising physician shall file with the board an
- 17 application to utilize a physician assistant containing a
- 18 description of the manner in which the physician assistant will
- 19 assist the supervising physician in his practice, the method and

- 1 frequency of supervision, including, but not limited to, the
- 2 <u>number and frequency of the patient record reviews required by</u>
- 3 subsection (j.1) and the criteria for selecting patient records
- 4 for review when 100% review is not required, and the geographic
- 5 location of the physician assistant. There shall be no more than
- 6 four physician assistants for whom a physician has
- 7 responsibility or supervises pursuant to a written agreement at
- 8 any time. In health care facilities licensed under the act of
- 9 July 19, 1979 (P.L.130, No.48), known as the "Health Care
- 10 Facilities Act, " a physician assistant shall be under the
- 11 supervision and direction of a physician or physician group
- 12 pursuant to a written agreement, provided that a physician
- 13 supervises no more than four physician assistants at any time. A
- 14 physician may apply for a waiver to employ or supervise more
- 15 than four physician assistants at any time under this section
- 16 for good cause, as determined by the board. In cases where a
- 17 group of physicians will supervise a physician assistant, the
- 18 names of all supervisory physicians shall be included on the
- 19 application.

- 21 (j.1) Patient record review.--
- 22 (1) The approved physician shall countersign 100% of the
- 23 patient records completed by the physician assistant within a
- reasonable time, which shall not exceed ten days, during each
- of the following time periods:
- (i) The first 12 months of the physician assistant's
- 27 <u>practice post graduation and after the physician</u>
- 28 <u>assistant has fulfilled the criteria for licensure set</u>
- forth in subsection (f).
- 30 (ii) The first 12 months of the physician

1	assistant's practice in a new specialty in which the
2	physician assistant is practicing.
3	(iii) The first six months of the physician
4	assistant's practice in the same specialty under the
5	supervision of the approved physician, unless the
6	physician assistant has multiple approved physicians and
7	practiced under the supervision of at least one of those
8	approved physicians for six months.
9	(2) In the case of a physician assistant who is not
10	subject to 100% review of the physician assistant's patient
11	records pursuant to paragraph (1), the approved physician
12	shall personally review on a regular basis a selected number
13	of the patient records completed by the physician assistant.
14	The approved physician shall select patient records for
15	review on the basis of written criteria established by the
16	approved physician and the physician assistant. The number of
17	patient records reviewed shall be sufficient to assure
18	adequate review of the physician assistant's scope of
19	practice.
