- 8 Section 2. Section 1503(b) is amended and subsection (a) is
- 9 amended by adding a paragraph to read:
- 10 § 1503. Persons ineligible for licensing; license issuance to

- 12 (a) Persons ineligible for licensing. -- The department shall
- 13 not issue a driver's license to, or renew the driver's license
- 14 of, any person:

- 16 (10) Who is deemed to be habitually truant by an
- 17 <u>attendance officer.</u>
- 18 (b) License issuance to minors. -- The department shall issue
- 19 a driver's license to a person 17 years of age who:
- 20 (1) has successfully completed a driver's training
- course approved by the department; [and]
- 22 (1.1) has received certification from an attendance
- officer of the school in which the person is a student that
- 24 the person is not habitually truant. If at any time the
- 25 person becomes habitually truant, the attendance officer
- 26 <u>shall notify the department in writing</u> that the person is

- 17 driver's license for the class of vehicle for which a permit is
- 18 held. Before a person under the age of 18 years may take the
- 19 examination for a junior driver's license, including a Class M
- 20 license to operate a motorcycle, the minor must:
- 21 (1) Have held a learner's permit for that class of
- vehicle for a period of six months.

- 28 compulsory school age who moves from the address named in the
- 29 application or on the driver's license shall, within 30 days of
- 30 moving, notify the department of the old and new addresses and

- 1 the old and new school districts and submit an updated
- 2 certification signed by the attendance officer of the old and
- 3 new school districts stating that the driver is not habitually
- 4 truant.

- 6 § 1532. Suspension of operating privilege.

- 8 (e) Persons who are habitually truant.--The department shall
- 9 suspend the operating privilege of any person upon receiving

6	suspension or revocation imposed under section 1544, upon:
7	(i) The driver graduating from high school, earning
8	a general educational development diploma or joining the
9	military.
