## A RESOLUTION

1 Recognizing Patrol Officer Eugene J. Ruddy of Dunmore Borough,  
2 Lackawanna County, for his record of service to this  
3 Commonwealth.

4 WHEREAS, Citizens who selflessly devote their lives to  
5 ensuring the safety of the residents of their communities and  
6 ultimately of all the people of this Commonwealth deserve  
7 special recognition; and

8 WHEREAS, Patrol Officer Eugene J. Ruddy of Dunmore borough,  
9 Lackawanna County, deserves such recognition for his heroism  
10 during a structure fire; and

11 WHEREAS, A twelve-year veteran of the Dunmore Police  
12 Department, Patrol Officer Ruddy was on patrol on September 21,  
13 2013, when he smelled smoke; and

14 WHEREAS, Driving to the source, he saw flames coming from an  
15 apartment building and without regard for his own safety, Patrol  
16 Officer Ruddy entered the structure to rouse residents and  
17 assist them from the building; and

18 WHEREAS, Through his laudable actions and deeds, he was able

1 to successfully remove eight individuals from the fire; and  
2 WHEREAS, Patrol Officer Ruddy has faithfully displayed great  
3 loyalty, commitment and professionalism in the performance of  
4 his duties as a member of the Dunmore Police Department and  
5 serves as a role model for all those who aspire to a career in  
6 law enforcement; therefore be it

7 RESOLVED, That the House of Representatives recognize Patrol  
8 Officer Eugene J. Ruddy be recognized for his record of service,
