## A JOINT RESOLUTION

Proposing an amendment to the Constitution of the Commonwealth 1 of Pennsylvania, further providing for tenure of justices, 2 judges and justices of the peace. 3 The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby resolves as follows: 6 Section 1. The following amendment to the Constitution of 7 Pennsylvania is proposed in accordance with Article XI: That section 15(b) of Article V be amended to read: 8 Tenure of justices, judges and justices of the peace. 9 § 15. \* \* \* 10 11 A justice or judge elected under section 13(a), (b) appointed under section 13(d) or retained under this section 12 15(b) may file a declaration of candidacy for retention election 13 with the officer of the Commonwealth who under law shall have 14 supervision over elections on or before the first Monday of 15 January of the year preceding the year in which his term of 16 office expires. If no declaration is filed, a vacancy shall 17

exist upon the expiration of the term of office of such justice 1 or judge, to be filled by election under section 13(a) or by 2 appointment under section 13(d) if applicable. If a justice or 3 4 judge files a declaration, his name shall be submitted to the electors [without] with party designation, on a separate 5 judicial ballot or in a separate column on voting machines, at 6 the municipal election immediately preceding the expiration of 7 the term of office of the justice or judge, to determine only 8 9 the question whether he shall be retained in office. If a majority is against retention, a vacancy shall exist upon the 10 expiration of his term of office, to be filled by appointment 11 under section 13(b) or under section 13(d) if applicable. If a 12 majority favors retention, the justice or judge shall serve for 13 the regular term of office provided herein, unless sooner 14 removed or retired. At the expiration of each term a justice or 15 judge shall be eligible for retention as provided herein, 16 subject only to the retirement provisions of this article. 17 18 Section 2. (a) Upon the first passage by the General Assembly of this proposed constitutional amendment, the 19 Secretary of the Commonwealth shall proceed immediately to 20 21 comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the 22 required advertisements to two newspapers in every county in 23 which such newspapers are published in sufficient time after 24 passage of this proposed constitutional amendment. 25

(b) Upon the second passage by the General Assembly of this
proposed constitutional amendment, the Secretary of the
Commonwealth shall proceed immediately to comply with the
advertising requirements of section 1 of Article XI of the
Constitution of Pennsylvania and shall transmit the required

1 advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of 2 this proposed constitutional amendment. The Secretary of the 3 4 Commonwealth shall submit this proposed constitutional amendment 5 to the qualified electors of this Commonwealth at the first primary, general or municipal election which meets the 6 7 requirements of and is in conformance with section 1 of Article 8 XI of the Constitution of Pennsylvania and which occurs at least 9 three months after the proposed constitutional amendment is passed by the General Assembly. 10
