## AN ACT

- Amending the act of December 19, 1990 (P.L.1372, No.212), 1 entitled "An act providing for early intervention services 2 for infants, toddlers and preschool children who qualify; 3 establishing the Interagency Coordinating Council and 4 providing for its powers and duties; and conferring powers 5 and duties upon the Department of Education and the State 6 Board of Education, the Department of Health and the 7 Department of Public Welfare, " further providing for 8 definitions and for child identification, assessment and 9 tracking system. 10
- The General Assembly of the Commonwealth of Pennsylvania 11
- hereby enacts as follows: 12
- Section 1. Section 103 of the act of December 19, 1990 13
- (P.L.1372, No.212), known as the Early Intervention Services 14
- System Act, is amended by adding a definition to read: 15
- Section 103. Definitions. 16
- The following words and phrases when used in this act shall 17
- have the meanings given to them in this section unless the 18
- 19 context clearly indicates otherwise:

- "Homeless." An individual who lacks a fixed, regular and 21

1	adequate nighttime residence. The term includes:
2	(1) Children and youth in any of the following:
3	(i) Who are sharing the housing of another person
4	due to loss of housing, economic hardship or other
5	reason.
6	(ii) Who are living in a motel, hotel, trailer park
7	or camping grounds due to the lack of alternative
8	adequate accommodations.
9	(iii) Who are living in an emergency or transitional
LO	shelter.
l.1	(iv) Who are abandoned in a hospital.
L2	(v) Who are awaiting foster care placement.
L3	(vi) Who have a primary nighttime residence that is
L <b>4</b>	a public or a private place not designed for or
L5	ordinarily used as a regular sleeping accommodation for
L6	human beings.
L 7	(vii) Who are living in a car, park, public space,
L8	abandoned building, substandard housing, bus or train
L9	station or similar setting.

24	Section 2. Section 305(b) of the act is amended to read:
25	Section 305. Child identification, assessment and tracking

28	(b) At-risk childrenFor the purposes of child
29	identification, assessment and tracking for infants and
30	toddlers, the Department of Public Welfare shall establish, by

- 1 regulation, population groups to be included in these
- 2 activities. The population groups shall include, but not be
- 3 limited to, children whose birth weight is under 1,500 grams;
- 4 children cared for in neonatal intensive care units of
- 5 hospitals; children born to chemically dependent mothers and
- 6 referred by a physician, health care provider or parent;
- 7 children who are seriously abused or neglected, as substantiated
- 8 and referred by the county children and youth agency under the
- 9 act of November 26, 1975 (P.L.438, No.124), known as the Child
- 10 Protective Services Law; [and] children with confirmed dangerous
- 11 levels of lead poisoning as set by the Department of Health; and
- 12 children who are homeless. The Department of Public Welfare may
- 13 establish other population groups by regulation as it deems
- 14 necessary.

- 16 Section 3. This act shall take effect immediately.
