Section 1101 of the act of March 10, 1949 10 (P.L.30, No.14), known as the Public School Code of 1949, amended November 30, 1971 (P.L.546, No.144), is amended to read: 11 12 Section 1101. Definitions. -- As used in this article, 13 The term "professional employe" shall include those who are certificated as teachers, supervisors, supervising 14 principals, principals, assistant principals, vice-principals, 15 16 directors of vocational education, dental hygienists, visiting

- 3 (2) The term "substitute" shall mean any individual who has
- 4 been employed to perform the duties of a regular professional
- 5 employe during such period of time as the regular professional
- 6 employe is absent on sabbatical leave or for other legal cause
- 7 authorized and approved by the board of school directors or to
- 8 perform the duties of a temporary professional employe who is
- 9 absent.
- 10 (3) The term "temporary professional employe" shall mean any
- 11 individual who has been employed to perform, for a limited time,
- 12 the duties of a newly created position or of a regular
- 13 professional employe whose services have been terminated by
- 14 death, resignation, suspension or removal.
- 15 Section 2. Section 1106 of the act, amended June 22, 2001
- 16 (P.L.530, No.35), is amended to read:
- 17 Section 1106. Duty to Employ. -- (a) The board of school
- 18 directors in every school district shall employ the necessary
- 19 qualified professional employes, substitutes and temporary
- 20 professional employes to keep the public schools open in their
- 21 respective districts in compliance with the provisions of this
- 22 act. Except for school districts of the first class and first
- 23 class A which may require residency requirements for other than
- 24 professional employes, substitutes and temporary professional
- 25 employes, no other school district shall require an employe to
- 26 reside within the school district as a condition for appointment
- 27 or continued employment.
- 28 (b) At least seventy-five per centum (75%) of the
- 29 professional employes shall hold appropriate State
- 30 certification. The balance of professional employes shall be

- 1 employed in noncertified positions and, while not required to
- 2 <u>hold appropriate State certification, must:</u>
- 3 (1) Meet the qualifications in sections 1109 and 1209.
- 4 (2) Have demonstrated satisfactorily a combination of
- 5 <u>experience</u>, <u>achievement</u> and <u>qualifications</u> in <u>basic</u> skills,
- 6 general knowledge, professional knowledge and practice and
- 7 <u>subject matter knowledge in the subject area that they will</u>
- 8 teach.
- 9 Section 3. This act shall take effect in 60 days.
