AN ACT

- 1 Providing funding to the Department of Military and Veterans
- 2 Affairs for the purpose of providing current service members 3 and veterans with access to high-definition fiber tracking
- and veterans with access to nigh-definition fiber tracking hrain scans and supporting organize alimical research in this
- 4 brain scans and supporting ongoing clinical research in this

- The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the High-
- 10 Definition Fiber Tracking (HDFT) for Veterans Act.
- 11 Section 2. Definitions.
- The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Brain scan equipment." Health care imaging equipment
- 16 capable of identifying brain damage by graphic depiction of
- 17 individual nerve tracts.
- 18 "Department." The Department of Military and Veterans
- 19 Affairs of the Commonwealth.

- 1 "Eligible center." A health care facility designated by the
- 2 department to provide access to HDFT brain scans.
- 3 "HDFT." A brain scan employing High-Definition Fiber
- 4 Tracking technology.
- 5 Section 3. Military members and veterans.
- 6 (a) Diagnosis. -- Any military veteran or active duty or
- 7 reserve member of the United States Armed Forces or National
- 8 Guard who has symptoms of traumatic brain injury or
- 9 posttraumatic stress or evidence of combat-related concussion
- 10 shall be eligible to receive diagnostic treatment through the
- 11 use of the new HDFT technology using equipment located in this
- 12 Commonwealth.
- 13 (b) Eligible centers. -- The military veteran shall visit an
- 14 eligible center in order to begin the process for the use of the
- 15 diagnostic technology.
- 16 (c) Brain scan equipment.--The equipment shall be provided
- 17 to eligible centers to provide access to HDFT technology
- 18 throughout this Commonwealth.
- 19 Section 4. Regulations.
- The department shall promulgate regulations for the
- 21 implementation of this act. The regulations shall allow for the
- 22 maximum number of military members and veterans to be able to
- 23 use the HDFT technology.
- 24 Section 5. Funding.
- 25 (a) Eligible centers. -- One million dollars shall be
- 26 appropriated for the implementation of this act and shall be
- 27 used by the department for distribution to all eligible centers.
- 28 The amount shall be distributed proportionally based on the
- 29 number of veterans served at each eligible center. The money
- 30 received by each eligible center shall be used to pay for

- 1 hardware and software costs of the diagnostic technology and
- 2 administrative expenses of the eligible center directly related
- 3 to the provision of HDFT scans to military members and veterans.
- 4 (b) Brain scan equipment. -- One million dollars shall be
- 5 appropriated for the implementation of this act and shall be
- 6 distributed by the department to ensure availability of the
- 7 diagnostic technology at locations throughout this Commonwealth.
- 8 Section 6. Appropriation.
- 9 The sum of \$2,000,000, or as much thereof as may be
- 10 necessary, is appropriated to the department for the fiscal year
- 11 July 1, 2015, through June 30, 2016, to carry out the provisions
- 12 of this act.
- 13 Section 7. Effective date.
- 14 This act shall take effect in 60 days.
