## A RESOLUTION

- 1 Directing the Joint State Government Commission to conduct a
- study and publish an electronic report on the potential
- savings by school districts that adopt certain operations
- 4 management practices intended to optimize classroom
- 5 capacities.
- 6 WHEREAS, The Constitution of Pennsylvania requires the
- 7 General Assembly to provide for the maintenance and support of a
- 8 thorough and efficient system of public education to serve the
- 9 needs of this Commonwealth; and
- 10 WHEREAS, Redistricting is a process that school districts
- 11 typically use every five to ten years to balance student
- 12 populations between school buildings within a school district;
- 13 and
- 14 WHEREAS, School districts rarely redistrict due to costs and
- 15 the emotional distress experienced by the community as a result
- 16 of transferring large percentages of students to different
- 17 school buildings; and
- 18 WHEREAS, Logistics professionals in this Commonwealth already
- 19 use existing technology, such as geographic information system

- 1 software and optimization computer programs, that add value for
- 2 their stakeholders; and
- 3 WHEREAS, The rising cost of education continues to elevate
- 4 the importance of exploring any and all potential methods to
- 5 achieve cost savings and improve academic outcomes; and
- 6 WHEREAS, Greater efficiency could fund full-day kindergarten,
- 7 provide property tax relief and lead to smaller class sizes; and
- 8 WHEREAS, Proper balancing of student populations between
- 9 classrooms helps to ensure equal educational opportunities for
- 10 students and greater fairness in evaluating the performance of
- 11 teaching professionals; and
- 12 WHEREAS, A more granular and dynamic redistricting process
- 13 that focuses on balancing student populations between classrooms
- 14 within a school district instead of between school buildings
- 15 could save money, reduce emotional distress, eliminate
- 16 unnecessary student transfers, shorten bus rides, ensure equal
- 17 educational opportunities and ensure fairness in teacher
- 18 evaluations; therefore be it
- 19 RESOLVED, That the House of Representatives direct the Joint
- 20 State Government Commission to conduct a comprehensive, school
- 21 district-by-school district study of the potential savings that
- 22 could be realized by each school district in this Commonwealth
- 23 by moving to a more frequent, flexible and proactive
- 24 redistricting program that prioritizes balancing of class sizes
- 25 over school populations; and be it further
- 26 RESOLVED, That the Joint State Government Commission publish
- 27 an electronic report of the results of the study on the
- 28 commission's publicly accessible Internet website within one
- 29 year of the adoption of this resolution; and be it further
- 30 RESOLVED, That the Joint State Government Commission not

- 1 publish hard copies of the report; and be it further
- 2 RESOLVED, That the report include an estimate of the
- 3 potential savings for each school district in this Commonwealth;
- 4 and be it further
- 5 RESOLVED, That the report be sortable by school district,
- 6 student population or the amount of the potential savings; and
- 7 be it further
- 8 RESOLVED, That the report be downloadable by users of the
- 9 commission's website; and be it further
- 10 RESOLVED, That the Joint State Government Commission notify
- 11 all members of the General Assembly when the electronic report
- 12 is available for public access.
