A RESOLUTION

- 1 Urging the Congress of United States to reconsider the
- 2 resettlement of Syrian refugees in the Commonwealth of
- Pennsylvania until such time as systems are in place to
- 4 thoroughly conduct security and background checks on Syrian
- refugees and to send a report detailing the increased
- 6 measures to the states that are under consideration to
- 7 receive Syrian refugees.
- 8 WHEREAS, In order to address the migrant crisis in Syria, the
- 9 Federal Government has indicated that the United States will
- 10 accept at least 10,000 Syrian refugees during fiscal year 2016;
- 11 and
- 12 WHEREAS, The Commonwealth of Pennsylvania has an abundant and
- 13 successful history of embracing immigrants; and
- 14 WHEREAS, The most important responsibility of government is
- 15 to protect the safety and security of the residents of the
- 16 Commonwealth of Pennsylvania; and
- 17 WHEREAS, On November 13, 2015, coordinated terror attacks
- 18 were carried out in Paris, France, killing at least 129 people
- 19 and injuring more than 350 people; and
- 20 WHEREAS, On November 14, 2015, the Islamic State (ISIS), a

- 1 deadly terrorist organization based in Raqqa, Syria, claimed
- 2 responsibility for the attacks and pledged further attacks
- 3 worldwide; and
- 4 WHEREAS, According to French police, a Syrian passport
- 5 belonging to a Syrian asylum seeker who entered Europe through
- 6 Greece was found near the body of one suicide bomber; and
- 7 WHEREAS, This raises concerns that the security vetting
- 8 procedures used in addressing the Syrian migrant crisis are
- 9 inadequate; and
- 10 WHEREAS, On February 11, 2015, Francis X. Taylor, Under
- 11 Secretary for Intelligence and Analysis for the United States
- 12 Department of Homeland Security, stated, "We are concerned about
- 13 any group of people coming to the United States who may be
- 14 coming to the United States for nefarious purposes"; and
- 15 WHEREAS, Under Secretary Taylor further testified that
- 16 officials "want to make sure that if we are asked to vet
- 17 individuals from any part of the world to come to the United
- 18 States, that we have applied the most rigorous screening that's
- 19 available within the U.S. government"; and
- WHEREAS, On February 11, 2015, Nicholas J. Rasmussen.
- 21 Director of the National Counterterrorism Center, testified in
- 22 front of the United States House of Representatives' Committee
- 23 on Homeland Security that Syrian refugees are:
- 24 clearly a population of concern and, as Under Secretary
- Taylor said, what we want to be able to do is apply the
- full weight of U.S. intelligence community holdings to
- 27 the vetting and screening process so that we can unearth
- any information that we may have in our holdings that
- 29 gives us concern about particular individuals;
- 30 and
- 31 WHEREAS, On February 11, 2015, Michael B. Steinbach,
- 32 Assistant Director, Counterterrorism Division, Federal Bureau of
- 33 Investigation, testified in front of the United States House of

Representatives' Committee on Homeland Security that:
You have to have information to vet, so the concern in
Syria is that we don't have systems in place on the
ground to collect the information to vet. That would be
the concern we would be vetting--databases don't hold the
information on those individuals, and that is the
concern;

- 9 WHEREAS, Increased security measures are necessary following
- 10 the recent terror attacks in order to protect the security,
- 11 safety and basic freedoms of the residents of the Commonwealth
- 12 of Pennsylvania; therefore be it
- 13 RESOLVED, That the House of Representatives of the
- 14 Commonwealth of Pennsylvania urge the Congress of the United
- 15 States to reconsider the resettlement of Syrian refugees in the
- 16 Commonwealth of Pennsylvania until such time as systems are in
- 17 place to thoroughly conduct security and background checks on
- 18 Syrian refugees and to send a report detailing the increased
- 19 measures to the states that are under consideration to receive
- 20 Syrian refugees; and be it further
- 21 RESOLVED, That a copy of this resolution be transmitted to
- 22 the presiding officers of each house of Congress and to each
- 23 member of Congress from Pennsylvania.
