## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto, " in charter schools, further providing
- for definitions and providing for Pennsylvania Charter School
- 7 Oversight Board.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 1703-A of the act of March 10, 1949
- 11 (P.L.30, No.14), known as the Public School Code of 1949, is
- 12 amended by adding a definition to read:
- 13 Section 1703-A. Definitions.--As used in this article,
- 14 \* \* \*
- 15 "Oversight Board" shall mean the Pennsylvania Charter School
- 16 Oversight Board established under section 1733-A.
- 17 \* \* \*
- 18 Section 2. The act is amended by adding a section to read:
- 19 <u>Section 1733-A. Pennsylvania Charter School Oversight</u>
- 20 Board.--(a) The Pennsylvania Charter School Oversight Board is

- 1 established. The Oversight Board shall consist of the following
- 2 members:
- 3 (1) The chairperson of the Education Committee of the
- 4 Senate.
- 5 (2) The minority chairperson of the Education Committee of
- 6 the Senate.
- 7 (3) The chairperson of the Education Committee of the House
- 8 of Representatives.
- 9 (4) The minority chairperson of the Education Committee of
- 10 the House of Representatives.
- 11 (5) The secretary or a designee.
- 12 (6) A member of the State Board of Education.
- 13 (b) The Oversight Board shall elect one of its members to
- 14 serve as the chair.
- 15 (c) The Oversight Board shall hold meetings at the call of
- 16 the chair. A majority of the members of the Oversight Board
- 17 shall constitute a quorum. Each member may designate another
- 18 person to represent that member at meetings of the Oversight
- 19 Board. Meetings shall be conducted under 65 Pa.C.S. Ch. 7
- 20 (relating to open meetings). Documents of the Oversight Board
- 21 shall be subject to the act of February 14, 2008 (P.L.6, No.3),
- 22 known as the "Right-to-Know Law."
- 23 (d) Members of the Oversight Board shall receive no
- 24 compensation for their services.
- 25 (e) The Oversight Board shall have the following powers and
- 26 duties:
- 27 (1) Review applications submitted to a local board of school
- 28 directors for new charter schools located in a city of the first
- 29 class.
- 30 (2) Review denial of applications submitted to a local board

- 1 of school directors for new charter schools located in a city of
- 2 the first class.
- 3 (3) Review revocation or renewal by a local board of school
- 4 directors of charters located in a city of the first class.
- 5 (4) Review applications submitted by the State Charter
- 6 Appeal Board for new charter schools located in a city of the
- 7 first class.
- 8 (5) Review denials made by the State Charter School Appeal
- 9 Board for new charter schools located in a city of the first
- 10 class.
- 11 (6) Authorize charter schools located in a city of the first
- 12 class and support charter school quality and accountability
- 13 through performance monitoring and technical assistance.
- 14 (f) In order to carry out its powers and duties, the
- 15 Oversight Board shall:
- 16 (1) develop principles and standards or adopt the National
- 17 Association of Charter School Authorizers Principles and
- 18 Standards; and
- 19 (2) develop a method to ensure that charter schools are
- 20 sufficiently distributed throughout a school district while also
- 21 ensuring that a charter application is not denied solely on the
- 22 basis of geographic location.
- 23 Section 3. This act shall take effect in 60 days.
