- Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in general provisions

- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 7102(b.3) and (d) of Title 42 of the
- 8 Pennsylvania Consolidated Statutes are amended to read:
- 9 § 7102. Comparative negligence.
- 10 * * *
- 11 (b.3) [Off-road vehicle riding] Sporting and recreational
- 12 <u>activities</u>.--
- 13 (1) [Off-road vehicle riding area operators] Operators
- 14 and providers of sporting and recreational activities shall
- have no duty to protect [riders] participants from common,
- 16 frequent, expected and nonnegligent risks inherent to the
- activity[, including collisions with riders or objects].
- 18 (2) The doctrine of knowing voluntary assumption of risk

- shall apply to all actions to recover damages for negligence
- 2 resulting in death or injury to person or property brought
- 3 against any [off-road vehicle riding area] operator or
- 4 provider of sporting and recreational activities.
- 5 (3) Nothing in this subsection shall be construed in any
- 6 way to abolish or modify a cause of action against a
- 7 potentially responsible party other than an [off-road vehicle
- 8 riding area] operator or provider of sporting and
- 9 <u>recreational activities</u>.

- 11 (d) Definitions.--As used in this section the following
- 12 words and phrases shall have the meanings given to them in this
- 13 subsection:
- "Defendant or defendants." Includes impleaded defendants.
- 15 ["Off-road vehicle." A motorized vehicle that is used off-
- 16 road for sport or recreation. The term includes snowmobiles,
- 17 all-terrain vehicles, motorcycles and four-wheel drive vehicles.
- "Off-road vehicle riding area." Any area or facility
- 19 providing recreational activities for off-road vehicles.
- "Off-road vehicle riding area operator." A person or
- 21 organization owning or having operational responsibility for any
- 22 off-road vehicle riding area. The term includes:
- 23 (1) Agencies and political subdivisions of this
- 24 Commonwealth.
- 25 (2) Authorities created by political subdivisions.
- 26 (3) Private companies.]
- 27 "Plaintiff." Includes counter claimants and cross-claimants.
- 28 "Sporting and recreational activities." The term shall
- 29 include, but not be limited to, baseball, soccer, football,
- 30 paintball, whitewater rafting, canoeing, swimming, kayaking,

- 1 mountain biking, hunting, fishing, off-road riding and other
- 2 <u>similar activities.</u>
- 3 Section 2. This act shall take effect in 60 days.
