

AN ACT

1 Amending Title 23 (Domestic Relations) of the Pennsylvania
2 Consolidated Statutes, in child custody, further providing
3 for consideration of criminal conviction.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 5329(a) of Title 23 of the Pennsylvania
7 Consolidated Statutes is amended to read:

8 § 5329. Consideration of criminal conviction.

9 (a) Offenses.--Where a party seeks any form of custody, the
10 court shall consider whether that party or member of that
11 party's household has been convicted of or has pleaded guilty or
12 no contest to any of the offenses in this section or an offense
13 in another jurisdiction substantially equivalent to any of the
14 offenses in this section. The court shall consider such conduct
15 and determine that the party does not pose a threat of harm to
16 the child before making any order of custody to that party when
17 considering the following offenses:

18 sale or delivery, holding, offering for sale or possession of
19 any controlled substance or other drug or device.

21 Section 2. This act shall take effect in 60 days.
