## AN ACT

1 2 3 4	Amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in general provisions relating to children and minors, providing for contracting and consent by certain minors.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 23 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	§ 5106. Contracting and consent by certain minors.
10	(a) General ruleNotwithstanding any other provision of
11	law, a minor may contract for housing, employment, purchase of
12	an automobile, receipt of a student loan, admission to high
13	school or postsecondary school, obtaining medical care, opening
14	a bank account, admission to a shelter for victims of domestic
15	violence or a homeless shelter and receipt of services as a
16	victim of domestic violence or sexual abuse, including, but not
17	limited to, counseling, court advocacy, financial assistance and
18	other advocacy services, if:

1	(1) The minor is at least 16 years of age.
2	(2) The minor is a homeless minor.
3	(3) The minor is self-supporting and is without the
4	physical or financial support of a parent or legal guardian.
5	(4) The minor's parent or legal quardian has consented
6	to the minor living independent of the parent's or legal
7	quardian's control. Consent may be expressed or implied as
8	follows:
9	(i) Expressed consent shall be any verbal or written
10	statement made by the parent or legal guardian of the
11	minor displaying approval or agreement that the minor may
12	live independently of the parent's or legal guardian's
13	control.
14	(ii) Implied consent shall be any action made by the
15	parent or legal quardian of the minor that indicates that
16	the parent or legal guardian is unwilling or unable to
17	adequately care for the minor. The actions may include,
18	but are not limited to:
19	(A) barring the minor from the home or otherwise
20	indicating that the minor is not welcome to stay;
21	(B) refusing to provide any or all financial
22	support for the minor; or
23	(C) abusing or neglecting the minor or
24	committing an act of domestic violence against the
25	minor.
26	(b) Contract for automobile insuranceA homeless minor or
27	a minor who is 16 years of age or older and who is in the legal
28	custody of a county agency under an order of a court of
29	competent jurisdiction may contract for the purchase of
30	automobile insurance with the consent of the county agency or

1	the juvenile court. The minor shall be responsible for paying
2	the costs of the insurance premiums and shall be liable for
3	damages caused by the minor's negligent operation of a motor
4	vehicle. No county agency, foster parent or entity providing
5	case management of children on behalf of a county agency shall
6	be responsible for paying any insurance premiums nor liable for
7	any damages of any kind as a result of the operation of a motor
8	vehicle by the minor.
9	(c) Contract for checking or savings accountA homeless
10	minor or a minor who is 16 years of age or older and who is in
11	the legal custody of a county agency under an order of a court
12	of competent jurisdiction may contract for the opening of a
13	checking or savings bank account with the consent of the county
14	agency or the juvenile court. The minor shall be responsible for
15	paying all banking-related costs associated with the checking or
16	savings bank account and shall be liable for any and all
17	penalties should the minor violate a banking agreement. No
18	county agency, foster parent or entity providing case management
19	of children on behalf of a county agency shall be responsible
20	for paying any bank fees nor liable for any penalties related to
21	violation of a banking agreement.
22	(d) Consent for no cost emergency shelter, housing and
23	related servicesA homeless minor may consent to no cost
24	emergency shelter, housing and related services, if the homeless
25	minor understands the benefits, responsibilities, risks and
26	limits of the shelter, housing and services and the homeless
27	minor agrees to adhere to the provider's rules and cooperate and
28	participate in the services recommended by the provider if:
29	(1) the provider has not, despite reasonable efforts,
30	been able to contact the homeless minor's parent, legal

2	(2) the provider has made contact with the homeless
3	minor's parent, legal guardian or legal custodian and the

5	has refused to give consent and, based on the information
6	available to the provider, the provider reasonably believes
7	that the homeless minor would incur harm or would be subject
8	to threatened harm if the homeless minor returned immediately_
9	to the home of the parent, legal quardian or legal custodian;
10	or
11	(3) the homeless minor has refused to provide contact
12	information for the homeless minor's parent, legal quardian
13	or legal custodian, and the provider reasonably believes that
14	the homeless minor would incur harm or would be subject to
15	threatened harm if the homeless minor returned immediately to
16	the home of the parent, legal quardian or legal custodian.
17	(e) Duration of consent for no cost emergency shelter,
18	housing and related servicesAny consent given under
19	subsection (d) by a homeless minor shall, for the duration of
20	the period of shelter or housing and with respect to all
21	services, including medical services, be valid and binding as if
22	the homeless minor had reached the age of majority. The
23	following shall apply:
24	(1) The consent given under subsection (d) shall not be
25	subject to later disaffirmance by reason of the homeless
26	minor's minority.
27	(2) A provider who renders emergency shelter, housing
28	and related services to a homeless minor under and can
29	demonstrate compliance with subsection (d) shall be immune
30	from any civil or criminal liability based on the provider's

1	determination to provide the emergency shelter, housing and
2	related services provided that if a provider's assessment and
3	determination or conduct in providing emergency shelter,
4	housing and related services, is the result of the provider's
5	gross negligence or willful or wanton acts or omissions, the
6	provider may be held liable for the provider's gross
7	negligence or willful or wanton acts or omissions.
8	(3) A provider who renders emergency shelter, housing
9	and related services to a homeless minor shall document in
10	writing the efforts made to contact the homeless minor's
11	parent, legal quardian or legal custodian.
12	(4) The provider shall report any suspected child abuse
13	or neglect to the county agency or the local police
14	department in accordance with this title.

10	U.S.C. § 6301 et seq.), living in circumstances under
11	paragraph (1), (2) or (3).
12	"Minor." An individual under 18 years of age.
13	"Provider." An organization established to provide emergency
14	shelter to minors and to provide related services, health care
15	<u>or supplies.</u>
16	Section 2. This act shall take effect in 60 days.
