- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, in rules of the road in general, further providing
- for following too closely; and, in other required equipment,
- further providing for general requirements for school buses.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 3310 and 4552(a) of Title 75 of the
- 8 Pennsylvania Consolidated Statutes are amended to read:
- 9 § 3310. Following too closely.
- 10 (a) General rule. -- [The] Except as otherwise provided in
- 11 this section, the driver of a motor vehicle shall not follow
- 12 another vehicle more closely than is reasonable and prudent,
- 13 having due regard for the speed of the vehicles and the traffic
- 14 upon and the condition of the highway.
- 15 (b) Combinations of vehicles and trucks.--
- 16 <u>(1)</u> The driver of any motor vehicle drawing another
- vehicle or of any truck when traveling upon a roadway outside
- of an urban district and following a motor vehicle drawing

- another vehicle or following a truck shall, whenever
- 2 conditions permit, leave sufficient space so that an
- 3 overtaking vehicle may enter and occupy the space without
- danger[, except that this subsection does not].
- 5 (2) This subsection shall not be construed to prevent a
- 6 motor vehicle drawing another vehicle or prevent a truck from
- 7 overtaking and passing any vehicle or combination of
- 8 vehicles.
- 9 (c) Caravans and motorcades.--
- 10 <u>(1)</u> Upon any roadway outside of an urban district, motor
- 11 vehicles being driven in a caravan or motorcade, whether or
- not towing other vehicles, shall be so operated as to allow
- 13 sufficient space between each vehicle or combination of
- vehicles so as to enable any other vehicle to enter and
- 15 occupy space without danger.
- 16 (2) This subsection does not apply to funeral
- 17 processions, which shall not be interrupted by any vehicle
- 18 other than an emergency vehicle.
- 19 (d) School buses. -- The driver of a motor vehicle shall not
- 20 <u>follow a school bus more closely than 10 feet.</u>
- 21 § 4552. General requirements for school buses.
- 22 (a) Color and identification. --
- 23 <u>(1)</u> Every school bus shall be of a uniform color scheme
- 24 and labeled "School Bus" on both front and rear as provided
- 25 by regulation.
- 26 (2) Exterior labels and markings other than those
- specifically required or permitted <u>under paragraph (3) or</u> by
- law or regulation shall be prohibited.
- 29 <u>(3) The rear of every school bus manufactured after</u>
- 30 December 31, 2021, shall have affixed to it an exterior

- 1 reflective label, sticker or sign stating: "At all times stay
- 2 back a minimum of 10 feet. It is the law."
- 3 (4) This subsection shall not be construed to prohibit
- 4 the affixation of exterior labels or stickers of a temporary
- 5 nature which have been approved by the school district as
- 6 having educational value and which do not obscure the "School
- 7 Bus" labels.

- 9 Section 2. This act shall take effect in 60 days.
