7	(a) Authorization and purposeEach school entity shall
8	develop and implement a written comprehensive school counseling
9	plan that ensures that student services are coordinated in a
10	manner that provides comprehensive and developmental support to
11	all students of the school entity.
12	(b) Requirements generallyA plan must:
13	(1) Be implemented by a Pennsylvania-certified school
14	counselor or counseling team working within each school in
15	the school entity.
16	(2) Utilize nationally recognized and State-recognized
17	counselor frameworks.
18	(3) Be reviewed annually and updated as needed by the
19	school counselor or counseling team, in collaboration with
20	each affected building principal as well as other
21	stakeholders and staff of each school entity.
22	(4) Be systemically aligned from kindergarten through

9	and other data to develop, implement and evaluate the plan.
10	(3) A delivery component, which focuses on direct
11	services and indirect services through the implementation of
12	the plan and which shall include:
13	(i) A plan for each grade taught by the school
14	entity.
15	(ii) A plan for students with individualized
16	education plans and other special needs.
17	(iii) A plan for each building in the school entity,
18	<u>if applicable.</u>
19	(4) An accountability component, which ensures regular

9	(a) General requirementSufficient time at each school
10	entity shall be allotted for the school entity's counselor to
11	carry out the duties stated in the school entity's plan.
12	(b) Direct and indirect services
13	(1) A school counselor shall spend at least 80% of the
14	school counselor's working time during student contact days
15	providing direct services and indirect services to students.
16	(2) Direct services and indirect services may be
17	provided in collaboration with other school personnel and
18	include:
19	(i) Providing academic advisement services,
20	including:
21	(A) Developing an individual planning system to
22	guide a student to access and monitor the student's
23	own educational, career and social and emotional
24	progress.
25	(B) Guiding a student along the pathways to
26	graduation.
27	<u>(C) Guiding a student in goal-setting</u>
28	experiences and course selection aligned with the
29	student's post-secondary goals.

9	rigorous coursework and take advantage of post-

11	(ii) Providing a career planning process, including:
12	(A) Guidance in understanding the relationship
13	between classroom performance and success in school
14	and beyond.
15	(B) The provision of resources to identify
16	career interests and aptitudes to assist a student in
17	age-appropriate college and career planning.
18	(C) Guidance in understanding the advantages of
19	completing career certifications and internships.
20	(D) Interpretation of augmented, criterion-
21	referenced or norm-referenced assessments for
22	students and parents or guardians of students.
23	(E) The provision of information to a parent or
24	<u>legal guardian of a student, such as through</u>
25	workshops on preparing for college, financial aid and
26	<u>career opportunities.</u>
27	(F) Encouragement to a parent or legal guardian
28	of a student to support partnerships in the student's
29	learning and career planning processes.

1	to support students, including programs to:
2	(A) Promote cultural and social awareness,
3	positive communication and relationship skills,
4	collaboration with others and responsible decision

8	a safe and supportive environment.
9	(C) Develop conflict-resolution skills.
10	(D) Prevent bullying, including:
11	(I) Training programs for school employees
12	regarding how to recognize bullying behaviors.
13	(II) Protocols for responding to bullying
14	that is occurring in the school entity.
15	(III) Strategies that support a student who
16	is being bullied.
17	(IV) Strategies that help a bystander speak
18	<u>out against bullying.</u>
19	<u>(E) Address age-appropriate suicide awareness</u>
20	and prevention through:
21	(I) Strategies that help identify a student
22	who is at risk for suicide.
23	(II) Strategies and protocols that help a
24	student who is at risk for suicide.
25	(III) Protocols for responding to a suicide
26	<u>death.</u>
27	(iv) Intervening with students who are at risk of
28	dropping out of school to determine if there is a way to
29	keep the students in school.
30	(v) Providing orientation programs for new students

1	and transferring students at each level of education.
2	(vi) Serving as a contributing member of decision-
3	making teams and programs, which include:
4	(A) Teams that are convened under 29 U.S.C. §
5	794 (relating to nondiscrimination under Federal
6	grants and programs).
7	(B) Multitiered System of Supports (MTSS) or
8	Response to Intervention (RTI) teams.
9	(C) English language learner programs.
10	(D) Parental involvement or family engagement
11	programs.
12	(E) Positive behavioral intervention support
13	programs.
14	(F) Advanced placement and gifted and talented
15	programs.
16	(c) Administrative activities
17	(1) Administrative activities performed by a school
18	counselor shall not exceed more than 20% of the school
19	counselor's time spent working during student contact days.
20	(2) Administrative activities provided by a school
21	counselor in collaboration with other school personnel
22	include:
23	(i) Coordinating State assessments, cognitive
24	achievement assessments, advanced placement programs and
25	language acquisition testing programs.
26	(ii) Developing master schedules.
27	(iii) Coordinating the following:
28	(A) Teams that are convened under 29 U.S.C. §
29	<u>794.</u>
30	(B) Response to Intervention (RTI) teams.

13	responsible for posting its plan on the school entity's publicly
14	accessible Internet website or, in the alternative, on the
15	publicly accessible Internet website of the school entity's
16	school district, under the category of State-required
17	information.
18	(b) OversightBeginning with the 2024-2025 school year,
19	the department shall monitor each school entity to ensure
20	implementation and compliance with this article.
21	(c) Departmental dutiesThe department shall:
22	(1) Employ at least one individual who is certified as a
23	<u>school counselor.</u>
24	(2) Provide a multilevel system of support to school
25	entities to assist in complying with this article.
26	(3) Provide guidance and technical assistance to school
27	entities to support equitable access to school counseling
28	services.
29	Section 2. This act shall take effect immediately.
