# COMMUNICATION FROM GOVERNOR

REORGANIZATION PLAN No. 1 PRESENTED

The Secretary to the Governor, being introduced, presented the following communication in writing from His Excellency, the Governor, which was read:

Commonwealth of Pennsylvania Governor's Office, Harrisburg

April 8, 1975

TO THE GENERAL ASSEMBLY OF THE COMMON-WEALTH OF PENNSYLVANIA:

By the authority vested in me by the Reorganization Act of 1955, Act No. 8 of the General Assembly, approved April 7, 1955, providing for the reorganization of agencies and functions of the State Government subject to the approval or disapproval by the General Assembly,

I transmit herewith Reorganization Plan No. 1 of 1975.
In September of 1971, for reasons which are no longer applicable, the Tax Litigation Unit of the Department of Justice was administratively transferred to the Department of Revenue. This unit handles litigation involving tax matters before the Commonwealth and Supreme Courts arising out of appeals from the Board of Finance and Revenue; the unit also handles some cases of original jurisdiction.

It is my belief now that the direct supervision of this unit should be by the Attorney General. Accordingly, I have prepared the attached Reorganization Plan No. 1 of 1975 to transfer the functions of the Tax Litigation Unit

to the Department of Justice.

The Tax Litigation Unit is composed of six attorneys in grades III, IV, and V (there are currently two vacancies), and three clerk stenographers and two administrative assistants. The projected expenditures of the unit under the 1974-75 budget are approximately \$183,600. The immediate supervision of the unit is currently by the Deputy Secretary for Taxation of the Department of Revenue.

I am hopeful that the General Assembly will give their careful consideration to the attached reorganization plan.

I, therefore, transmit to you and urge your approval of Reorganization Plan No. 1 of 1975.

# REORGANIZATION PLAN No. 1 OF 1975

Section 1. The functions, powers, and duties of the Department of Revenue with regard to the litigation of taxation matters as are now exercised by the Tax Litigation Unit of the Department of Revenue are transfer-

red to the Department of Justice.

Section 2. There are hereby transferred to the Department of Justice to be used, employed and expended in connection with the functions, powers, and duties transferred by section 1 of this Reorganization Plan, the personnel, records, files, property, supplies, equipment, and the unexpended balances of appropriations, allocations, and other funds available or to be made available for use

in connection with such functions, powers, and duties. RESOLVED, That Reorganization Plan No. 1 of 1975 transmitted to the General Assembly under date of April 8, 1975, which is incorporated herein by reference, be

approved.

# COMMUNICATION FROM GOVERNOR

#### REORGANIZATION PLAN No. 2 PRESENTED

The Secretary to the Governor, being introduced, presented the following communication in writing from His Excellency, the Governor, which was read:

#### TO THE GENERAL ASSEMBLY OF THE COMMON-WEALTH OF PENNSYLVANIA:

By the authority vested in me by the Reorganization Act of 1955, Act No. 8 of the General Assembly, approved April 7, 1955, providing for the reorganization of agencies and functions of the State Government subject to the ap-

proval or disapproval by the General Assembly, I transmit herewith Reorganization Plan No. 2 of 1975

By operation of the Act of December 3, 1970, P. L. 834, No. 275, Sections 30(F) and 31, 71 P. S. Sections 510-103 (F) and 510-104, the personnel within the Department of Labor and Industry assigned to the inspection of deep mines other than coal mines were trans-ferred to the Department of Environmental Resources. ferred to the Department of Environmental Resources. Prior to this transfer, these mine inspectors had been charged with the enforcement of all of the rules and regulations of the Department of Labor and Industry which related to deep mines other than coal mines. Upon their transfer to the Department of Environmental Resources, however, they were empowered, by operation of Section 20 of the above act (71 P. S. Section 510-1 (24)), only to enforce the rules and regulations authorized by two statutes dealing with explosives.

Simultaneous with this transfer, the Department of Environmental Resources, by operation of Sections 30 (F) and 31 (71 P. S. Sections 510-103 (F) and 104) received from the Department of Mines and Mineral Industries the personnel charged with the enforcement of the safety laws governing coal mines. The effect of these transfers has been as follows:

(a) The transfer of mine inspectors from the Deof Environmental Resources has removed from the Department of Labor and Industry to the Department of Environmental Resources has removed from the Department of Labor and Industry the personnel needed to enforce the safety laws and regulations applicable to deep mines other than coal mines.

(b) These same inspectors, now under the jurisdiction of the Department of Environmental Resources, have been unable to enforce the safety laws and regulations applicable to deep mines other than coal mines because the Department of Environmental Resources had not received the power to enforce

those laws and regulations.

The Reorganization Plan now being submitted is depational safety laws created, apparently inadvertently, by operation of the Act of December 3, 1970, P. L. 834, No. 275. Under the Act of May 18, 1937, P. L. 654, the Department of Labor and Industry obtained jurisdiction Department of Labor and Industry obtained jurisdiction over occupational safety for all places of employment within the Commonwealth; this included jurisdiction over deep mines other than coal mines (Act of May 18, 1937, P. L. 654, Section 2 (F), 43 P. S. Section 25-2 (F)). The Reorganization Plan, No. 2 of 1975, will transfer this included in the coal mines to the jurisdiction over deep mines other than coal mines to the Department of Environmental Resources.

My reasons for urging the adoption of this Reorgani-

zation Plan are based upon the following findings:
(1) The Department of Labor and Industry lacks the personnel and expertise needed to enforce the safety laws and regulations applicable to deep mines other than coal mines.

(2) The Department of Environmental Resources has the personnel and expertise needed to enforce the occupational safety laws and regulations applicable to deep

mines other than coal mines.

(3) The transfer of jurisdiction over occupational safety in deep mines other than coal mines from the Department of Labor and Industry to the Department of Environmental Resources would accomplish the following objectives:

(a) Allow the persons previously charged with the enforcement of occupational safety laws and regulations applicable to deep mines other than coal mines to resume the enforcement of those laws and regulations:

(b) Eliminate the current lapse in the enforcement

of those laws and regulations;

(c) Place the responsibility for the enforcement of the occupational safety laws and regulations applicable to deep mines other than coal mines under plicable to deep mines other than coal mines under the jurisdiction of a department (DER) charged with occupational safety in coal mines, thus consolidating within a single department two functions which deal with similar safety problems, namely:

(1) transporting workers and mined materials;
(2) avoiding hazards caused by water seepage, oxygen deficiency, roof falls, and electrical shocks and explosions:

shocks and explosions;

(3) conducting rescue operations. In light of these findings, I am submitting to you the attached Reorganization Plan No. 2 of 1975.

# LEGISLATION TO BE INTRODUCED

The SPEAKER pro tempore. The Chair recognizes the gentleman from Montgomery, Mr. Mebus.

Thank you, Mr. Speaker. Mr. MEBUS.

I have a couple bills which I want to introduce in the immediate future that might be of some interest to some of the members of the House, and they might wish to cosponsor them. On the other hand, they might not like to, either. They are controversial.

The first is a bill that has been around for many years, for a number of sessions, which calls for the nonpartisan election of school board members.

I have been asked to introduce this by a group of citizens back in my local school district and by others. And though I know that there is inherent opposition to this proposal, I know that there is also a lot of latent support for such a proposal.

So for any who might be interested, I am going to lay it up here on the rail in front of the bill clerk for those who might wish to sign it, in the hope that it can be introduced today.

The other proposal grows, again, out of a local problem that I have had at home in dealing with public em-

more of them that go longer and longer and longer toward resolution. And I have a proposal here to change Act 195 so that when you come up to an impasse you would finally appoint a board of three arbiters whose decision would be final, but not in the same sense that this is true in Act 111 which deals with police and firemen.

The proposal for a change in Act 195 would be more like that which has been employed in recent times by the professional football and baseball teams where, when you reach an impasse, each would make a final offer or a final demand, as the case may be, and the arbiters determine which is the most reasonable of the two proposals, and this is what is finally settled upon. You get a final demand from the union on the one hand and a final proposal from the municipal employer on the other hand, and all the arbiters do is then to determine which is the more rational, and that one they select and determine to be in effect.

It would seem that this is a way to resolve some of these impasses that we have come to at the present time, and to prevent some of these periods of elimination of service to the people of the Commonwealth, and I think maybe it makes more sense than what we are doing at the present time.

So, therefore, I also would lay this one on the table for the signature of anyone who might choose to sign it.

Each of them is labeled on the outside as to what it does so that they are not hard to identify.

# LEGISLATION TO BE INTRODUCED

Mr. ZELLER. Mr. Speaker, I have a bill that I am introducing today which I believe most of the members will be interested in.

Last year we amended Act 235 which deals with the handicapped people in regard to coming into business establishments and providing rest rooms for them.

This is very worthy legislation, but we have a problem with it. We have over 200 cases in Labor and Industry now, where they are standing still. They cannot do anything with them because there is no way to issue a variance.

The hearing board of Labor and Industry has no way, the building board has no way, under the law to hear these cases because they are "mom and pop" organizations that are going to expand with, say, an extra room or something and they must adhere to the law, to Act 235. Therefore, it is costing them between \$3,000 and \$5,000 to go into these various regulations and it is putting them out of business.

The board is asking for this legislation. We are holding ployes' strikes. There seem to be more and more and up the building industry, and for those who would like

to get on, all it does is allow the board to give a variance in those cases.

Anyone who wants to get on it, they may. They may have problems in their own areas.

# LEGISLATION TO BE INTRODUCED

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. Hammock.

Mr. HAMMOCK. Thank you, Mr. Speaker.

Mr. Speaker, just a few brief comments about the bill I introduce today.

Several months ago Philadelphia Magazine had a!

lengthy article reporting some apparent inadequacies and deficiencies in the operation of the Department of the Treasury, as well as the Board of Finance and Revenue. It has been alleged by Philadelphia Magazine that the Commonwealth of Pennsylvania does not make the best use of its investment dollars, and this opinion, I might add, is shared by a number of investment people throughout the Commonwealth, including some of the state's leading bankers and members of financial institutions.

I introduce a bill today designed to amend the present policies of the Department of Treasury regarding the investment of taxpavers' dollars and regarding the regulations of some of our financial institutions, especially our banking industry.

No intent is meant by the introduction of this bill to cast aspersions on any individual, but I am convinced that we are not applying sound fiscal policies to our best interest here in the state.

I might also mention that the Auditor General, Robert Casey, and his department had a lengthy investigation of the Department of Treasury and the Board of Finance and Revenue, and it was their opinion that many deficiencies and inadequacies result from a lack of sound fiscal policy and sound direction in the Department of Treasury.

I will introduce a subsequent bill in the next week or so that is designed to do something with the anticipated cost savings that will result if this first bill is passed. The second bill will be designed to have financial institutions, especially the savings and loan companies and the banks, take the money saved by reason of this bill and plow it back into the dying housing industry in this state

Many of us believe that if our financial institutions, especially the savings and loan institutions, across the Commonwealth have at their access more moneys available, they will encourage new home ownership, rehabilitation of already existing structures, and that might have a real impact in helping to turn the economy around.

I will be trying very hard to push this bill during this session and I welcome the support of all members.

I will have the bill laid on the desk for any additional signatures and for perusal by the membership.

The best that I can do, Mr. Speaker, is to alert the House as soon as I have made a decision and I promise to do that.

Mr. ZELLER. Mr. Speaker, the ones that are on the calendar now for certain are going to be run, plus the additional ones that you have here?

Mr. IRVIS. No. The only ones, Mr. Speaker, which are certain to be run are the ones which we have given you in a memo. Those are certain.

We may have one or two others, although I am going to try my best to restrict the calendar to what I have said on that memo for just the reason that the gentleman, Mr. Zeller, has pointed out.

Mr. ZELLER. I appreciate that, and I also want to compliment him for the fine job.

Mr. IRVIS. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks both gentlemen for enlightening the House as to its procedures.
