## CALENDAR

### NONPREFERRED APPROPRIATION BILL ON FINAL PASSAGE

Agreeable to order,

The House proceeded to the consideration on final passage of **House bill No. 1274, printer's No. 1975**, entitled:

An Act making appropriations to the Thomas Jefferson University of Philadelphia, Pennsylvania.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The SPEAKER. The Chair recognizes the gentleman from Chester, Mr. Morris. For what purpose does the gentleman rise?

Mr. MORRIS. I have an amendment, Mr. Speaker.

The SPEAKER. Has the amendment been distributed?

Mr. MORRIS. I believe this one has.

The SPEAKER. Is the amendment referred to by the gentleman the amendment labeled A-2254?

Mr. MORRIS. A-2254, Mr. Speaker.

The SPEAKER. For the information of the members, HB 1274, PN 1975, a nonpreferred appropriation bill on final passage, has been called up on final passage. The gentleman, Mr. Morris, offers the following amendment, which is labeled A-2254:

Amend Sec. 1, page 1, line 5, by striking out "\$3,978,000" and inserting \$3,870,000

Amend Sec. 6, page 2, line 16, by striking out "July 1, 1977." and inserting immediately.

On the question.

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from Chester, Mr. Morris.

Mr. MORRIS. Mr. Speaker, this bill deals with the Jefferson Medical College.

The amendment reduces the appropriation for the Jefferson University Medical School, and the basis of the reduction is to reduce it 2.5 percent less than the appropriation last year. It changes it from the appropriation in the bill of \$3,978,000 to \$3,870,000.

The SPEAKER. Has the gentleman finished his explanation of his amendment?

Mr. MORRIS. That is correct.

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. Pievsky.

Mr. PIEVSKY. Mr. Speaker, I oppose the amendment. The reason is that the state-related medical schools are based on \$4,400 per capita and it has been that way for the last 10 years. I see no reason why we should change it now. The school needs the money, and I oppose the amendment.

The SPEAKER. Does the gentleman, Mr. Morris, have additional amendments to this bill?

Mr. MORRIS. Not to this bill, Mr. Speaker.

The SPEAKER. Does the gentleman, Mr. DeVerter, have an amendment to this bill?

The Chair recognizes the gentleman, Mr. DeVerter.

Mr. DeVERTER. Mr. Speaker, I do not have an amendment to the bill. I would like to speak on the bill subsequently, please.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. The Chair recognizes the gentleman from Mifflin, Mr. DeVerter.

Mr. DeVERTER. Thank you, Mr. Speaker.

Mr. Speaker, prior to the running of these bills, I would, for the purposes of the record, like to express my reasons for my decision to vote "no" on these nonpreferred appropriations, not because I am against the appropriations but rather because of the circumstances that surround the bills that are now before us and the reason for the position that they are in.

It seems inconceivable to me that the majority leader would run these bills prior to the adoption of the necessary revenue-producing legislation needed to fund them. To further perpetrate the charade that took place in August, to me, is inconceivable and unconscionable. These bills, if they are passed here today, will really be sent to the Senate where they will rest until such time as this body brings itself to the point of getting 102 votes on that board for the adoption of necessary taxes to fund this legislation.

I firmly believe and am convinced that until this General Assembly will take upon itself the responsibility it has to the citizens of this Commonwealth to first produce the revenues that are necessary to fund legislation, we will continue to have the same kinds of problems that we witnessed over the past several months.

I would like to suggest, Mr. Speaker, that those who were so insistent upon the passage of HB 1349 be given the opportunity to express their desires for this legislation that we are now considering by placing the tax package, whatever that might be—and I do not think there are many in this body who have seen it—before this General Assembly so that they might consider it prior to the time of the running of the nonpreferred appropriations.

Again I would like to make it very clear that I am not against these institutions of higher learning. I firmly believe and have taken the lead in many instances for the funding of educational

purposes in this Commonwealth, and I think it should be our top priority. However, as I say, to do this now I think is just perpetuating the charade—and that is all it was back in August—and I, for one, want no part of it.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Geisler.

Mr. GEISLER. Mr. Speaker, during this interim I would like to call a meeting of the State Government Committee, which is a continuation of the meeting last week to consider an amendment to a particular bill, in room 246.

The SPEAKER. The House is going to be declared at ease until 20 minutes to noon.

Mr. GEISLER. Thank you.

### URBAN AFFAIRS COMMITTEE MEETING

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Caputo, who wishes to announce a meeting.

Mr. CAPUTO. Thank you, Mr. Speaker.

Mr. Speaker, there will be a meeting of the Urban Affairs Committee tomorrow morning, Wednesday, September 28, in room 401, at 10:30 a.m. I would urge all members of the Urban Affairs Committee to be there promptly. We have some very serious bills to consider.

The SPEAKER. The Chair has been advised that it may take longer than the 10 minutes to reconstruct what has gone wrong with this machine.

The Chair recognizes the majority leader for purposes of declaring a caucus.

### DEMOCRATIC CAUCUS

The SPEAKER. The Chair recognizes the majority leader.

Mr. MANDERINO. Mr. Speaker, I ask that this House be in recess.

The SPEAKER. The Chair would suggest that the way they are working on the machine, it may take at least a half hour before they are ready.

Mr. MANDERINO. Mr. Speaker, I ask that this House be in

recess for one-half hour and, during that period of time, I ask that the Democratic members report to the caucus room.

I would like every member who is on the floor of the House to be in the caucus room for a very short caucus immediately upon the declaration of the recess.

The SPEAKER. The Chair recognizes the gentleman from Blair, Mr. Hayes.

Mr. S. E. HAYES. Thank you, Mr. Speaker.

I wonder if I could ask the majority leader a question, please.

The SPEAKER. The majority leader indicates he will stand for interrogation.

Mr. S. E. HAYES. Mr. Speaker, what are your plans for the day? Let us begin with the lunch schedule; is there going to be a period set aside for lunch?

Mr. MANDERINO. I have not yet planned lunch.

Mr. S. E. HAYES. Thank you, Mr. Speaker.

The Republican Representatives have caucused on this package of bills. I believe we are prepared to vote on the same. It would be my recommendation to the Republican Representatives that they go to lunch while we are in recess.

Thank you, Mr. Speaker.

### LUNCH

The SPEAKER. The Chair recognizes the majority leader.

Mr. MANDERINO. If it be the pleasure of the Chair, we could extend the recess for an hour and we will all get lunch during that hour. But I would urge the Democratic members to report immediately upon the recess to the caucus room for a caucus.

### RECESS

The SPEAKER. The gentleman's suggestion makes sense. The Chair declares the House in recess until 12:45 p.m. and urges the members who wish to secure lunch to do so at that time.

The majority caucus has been called immediately for the Democratic Party.

This House stands in recess until 12:45 p.m.

### AFTER RECESS

The time of recess having expired, the House was called to order.

The SPEAKER. For the benefit of those members within hearing of the Speaker's voice, the electronic machine has not yet been repaired. It is not recording accurately and, consequently, because of the number of votes which we have to take today, we are not going to be able to continue at 10 minutes of 1.

### RECESS CONTINUED

The SPEAKER. The Chair declares a continuation of the recess until 3 p.m., at which time the Chair will make a further announcement, hopefully. For the members' sake, hopefully, that announcement will be that the machine has been repaired.

The Chair urges all members to remain in the Capitol and immediately available by 3 o'clock, because if the machine is in

working order, it is the majority leader's intention to call up the nonpreferred appropriations in order on the calendar.

All members who have amendments thereto should take this opportunity to have those amendments correctly prepared, filed with the amendment clerk, and distributed so that we are not delayed by any member showing up with a last-minute amendment.

This House will continue in recess, therefore, until 3 p.m.

### AFTER RECESS

The time of recess having expired, the House was called to order.

The SPEAKER. The members within the Speaker's voice are advised of the fact that the machine is not repaired and is not going to be repaired for the remainder of this day. The technician is on his way but is not here and will not arrive here until at least 5:30 p.m. Therefore, the Speaker does not see it necessary for the members to report to the floor.

The only thing which will be done now is action on motions and transferences of certain bills on the tabled calendar to the active calendar and recommitment of a bill from the tabled calendar to the Appropriations Committee.

The Speaker will read the numbers of those bills out so that anyone within the hearing of his voice will know which bills have been removed from the tabled calendar to the active calendar. In general, they are all nonpreferred bills. They are nonpreferred bills which will be moved from the tabled calendar to the active calendar and will appear on the active calendar tomorrow.

The adjournment motion will be until 11 a.m. tomorrow and, hopefully, the machinery of the House will be functioning.
