#### PARLIAMENTARY INQUIRY

The SPEAKER. The Chair recognizes the gentleman from Westmoreland, Mr. Kukovich. For what purpose does the gentleman rise?

Mr. KUKOVICH. I rise to a parliamentary inquiry.

The SPEAKER. The gentleman will state it.

Mr. KUKOVICH. Mr. Speaker, I am wondering why we have not had a rollcall vote and why we did not have a rollcall vote last Monday, also.

The SPEAKER. Would the gentleman repeat his question?

Mr. KUKOVICH. Mr. Speaker, I am concerned that we did not have a rollcall vote last Monday and again today we started to do business and we have not had a master roll call.

The SPEAKER. It was the Chair's privilege to utilize the vote on the suspension of the rules as the master roll call for the day.

Mr. KUKOVICH. Mr. Speaker, will that be the procedure hence-forth? Will we not have a master roll but rather take the

first vote of the day as a master roll? The SPEAKER. Not necessarily.

#### POINT OF ORDER

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. Richardson. For what purpose does the gentleman rise?

Mr. RICHARDSON. I rise to a point of order.

The SPEAKER. The gentleman will state it.

Mr. RICHARDSON. I would just like to follow on that. I think that in the past we have at least been afforded the courtesy of knowing what is going to be the procedure as far as the master roll is concerned. We were upstairs in our offices and, before that vote was taken, we were not even afforded the opportunity of knowing whether it was a master roll or not, but we did come downstairs.

I would like to know if the floor leaders have any suggestions as to how the members are going to be informed as to whether or not there will be a master roll taken when we come up on Monday and Tuesday and Wednesday when we are in session or whether or not there is not going to be one. I think that we have the right to know.

That is my point of order, Mr. Speaker. May I have an answer, please?

The SPEAKER. For the information of the gentleman, as the year progresses, the gentleman will find that master roll calls will be utilized more often than not to expedite the business of the session. It has been found in the past that it is a very expedient way to permit the members of this House to be recorded as being present in the House. It was the Chair's feeling today and one day last week, because of the lightness of the schedule, that the two votes that were taken today and last week were sufficient to replace what we knew in prior years as a master roll call per se. But for the information of the gentleman, master roll calls will be taken.

Mr. RICHARDSON. Thank you very much, Mr. Speaker, because also it has a lot to do with the bearing on one's legislative expenses in terms of whether or not it can be determined whether or not those persons were in session on the day in question. One of the ways in the past that has been identified is the fact that a person who does appear on the master roll then could not claim or disclaim whether he was here or not here, because the record will so reflect it.

I thank the Speaker very much for the information, because it would seem to me that many of the members who probably are also raising this question would like to have that clarified for their own edification. Thank you very much, Mr. Speaker.

#### QUESTION OF PERSONAL PRIVILEGE

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Cowell. For what purpose does the gentleman rise?

Mr. COWELL. I rise to a question of personal privilege.

The SPEAKER. The gentleman will state it.

Mr. COWELL. Mr. Speaker, on that same point of roll calls, I would simply note two things. As I recall, last Monday there

was no roll call taken in this House for any purpose, including a promptly to the caucus room on the declaration of the recess. master roll call. I would encourage whoever is going to make Thank you, Mr. Speaker. these kinds of decisions to have a roll call taken if we are asked to be present in this House, because, frankly, when we fail to take a roll call or fail to take a master roll call, that works to the benefit and the convenience of those people who choose not to be here, and I am tired of a system that works that way.

Secondly, Mr. Speaker, if a roll call for any purpose will be deemed to be the master roll call, as occurred just moments ago with this vote on the suspension of the rules, I would ask that it be so indicated; that the Speaker would indicate that that roll call will be deemed to be the master roll call and that that indication be made in advance of the roll being taken. Thank you, Mr. Speaker.

#### HOUSE SCHEDULE

The SPEAKER. The Chair recognizes the majority leader.

Mr. RYAN. Mr. Speaker, for the benefit of the members, so you will understand what we are hoping to accomplish this week, we are suggesting that both caucuses meet very shortly and that they address themselves to two particular bills, one being HB 17, which is the ethics bill, and discuss any amendments that may be offered so that we can vote on them today.

Secondly, when we return from caucus to the floor, I am going to ask that the rules be suspended with respect to HB 56. which was just removed from the table, so that it can be put on the calendar and second consideration taken care of with respect to that bill so that it can be voted on finally tomorrow. That is the deficiency appropriation. Absent that suspension. there is a strong likelihood that we would be required to be in session on Wednesday, and if we can suspend the rules just to get over the second consideration today, we will be in a position to vote it tomorrow rather than holding out until Wednesday on it.

The SPEAKER. The Chair recognizes the gentleman from Adams, Mr. Cole.

Mr. COLE. Thank you, Mr. Speaker. For the information of the members, I am now going to introduce the cancer control bill that overwhelmingly passed the House in the last session.

We have over 50 sponsors already. Anybody who would like to put their name on the sponsorship of the cancer control plan for Pennsylvania, along with the funding bill, I will be glad to have you as cosponsors. Thank you.

#### ADDRESS TO HOUSE

Mr. ROCKS, under unanimous consent, addressed the House: Mr. ROCKS. Thank you, Mr. Speaker. I consider it a particular honor to make my first appearance at this microphone on the floor of the House of Representatives on a day traditionally commemorative of one of the greatest Americans in the history of this Nation, Abraham Lincoln, the 16th President of the United States, and, I would probably note, the first Republican President of this country, who provided during the most turbulent times of this Nation, a unique kind of leadership.

It was Abe Lincoln's undaunted concern for freedom for all The SPEAKER. The Chair recognizes the gentleman from people and Lincoln's sense of humility and profound desire to reconcile differences among all people that have marked his memory as one of the greatest American citizens in our 200-year history.

I would remind the body that Abraham Lincoln never graduated from grade school. It is noted, however, on a plaque in the halls of Oxford University in England, that great protectorate of the English language, that the greatest living example to date of our language is, in fact, the Gettysburg Address.

It is also noteworthy that, on his way to his first inaugural address, President Abraham Lincoln stopped and addressed the Pennsylvania General Assembly. It is my fondest hope that Lincoln's spirit of humility and his undaunted concern for the continued concept of freedom for all people in this Nation may be, in fact, the guiding light for the 1979 and 1980 legislature. Thank you, Mr. Speaker.

#### BIRTHDAY WISHES

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Goebel.

Mr. GOEBEL. Just a very few moments to also recognize the birthday of another great American and great Pennsylvanian who is unequaled in his dedication and service to the people. It is none other than our own colleague, Mr. Anthony Cimini, Representative from the 83d district. He declines the "Happy Birthday" song, so if we would just applaud him, I think it would be enough.

Amend Sec. 2, page 2, lines 9 through 11, by striking out "Provided, however, That any" in line 9, all of lines 10 and 11, and inserting (b) Notwithstanding the effective date postponement of subsections (a), (b), (d) and (e) of section 4 hereof, any action taken pursuant to such subsections between January 1, 1979 and such postponement dates shall not be invalidated.

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the minority whip.

Mr. MANDERINO. Mr. Speaker, very simply, on the second page of HB 17, the effective-date section, I am changing the proviso in that section. I am not touching the effective date, but I am changing the proviso in that section to make it absolutely clear that that which is not invalidated that was done after January 1, 1979, pertains only to those sections which are postponed. It was a little ambiguous the way it was stated because it talked about anything done pursuant to this act, and

what we really meant was that which was done pursuant to the postponed sections of the act "was not being invalidated."

The SPEAKER. The Chair recognizes the majority whip.

Mr. S. E. HAYES. Thank you, Mr. Speaker.

We have read the gentleman's amendments and have agreed to them.

On the question recurring,

Will the House agree to the amendments?

Amendments were agreed to.

On the question,

Will the House agree to the bill as amended on third consideration?

Mr. KUKOVICH offered the following amendments:

Amend Sec. 1 (Sec. 14), page 1, line 14, by striking out "(A)"

Amend Sec. 1 (Sec. 14), page 2, lines 3 through 7, by striking out all of said lines

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from Westmoreland, Mr. Kukovich.

Mr. KUKOVICH. Mr. Speaker, the purpose of my amendment is to give us a clean bill. The purpose of HB 17 purportedly was to simply delay this 6 months. The language in section (b) raises the question of constitutionality and also raises another penal provision which is unnecessary, and I think in order for us to go along with what was originally intended with HB 17, I would urge your support for that amendment.

The SPEAKER. The Chair recognizes the gentleman from Montgomery, Mr. Polite. For what purpose does the gentleman rise?

Mr. POLITE. What is the number of the amendment that we are alluding to?

The SPEAKER. I have been informed that the number of the amendment is A41.

Mr. POLITE. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the majority whip.

Mr. S. E. HAYES. Thank you, Mr. Speaker.

We also agree to these amendments.

On the question recurring,

Will the House agree to the amendments?

Amendments were agreed to.

On the question recurring,

Will the House agree to the bill as amended on third consideration?

Bill as amended was agreed to.

Ordered, that the bill as amended be prepared for final passage.

# ADDRESS TO HOUSE

Mr. FRYER, under unanimous consent, addressed the House. Mr. FRYER, Mr. Speaker, I have several amendments to HB 17, one of which would exempt those local public officials who are earning less than \$5,000 from their municipality to be exempt from Act 170.

Representative Gamble also has amendments, as do other members of the House. We had been persuaded not to present these amendments at this time in order to insure the swift passage of HB 17. That puts us in the position, Mr. Speaker, that I would like to inquire from the majority leader. I would like to ask him to stand for a period of brief interrogation.

The SPEAKER. Will the gentleman settle on the majority whip?

Mr. FRYER. Certainly. He is a fine gentleman.

The SPEAKER. The gentleman may proceed.

Mr. FRYER. Mr. Speaker, as you know, HB 17 does not change the ethics bill; it merely postpones the agony. Now my question is, in regards to those of us who do have amendments to offer, that we feel should be accepted to insure the proper performance by our local elected officials, and, in view of that, could the gentleman give assurances to the House that there would be a bill in form before the House that this body could present amendments thereto?

Mr. S. E. HAYES. If I understand the gentleman's question, the answer is yes, and in conversation with the chairman of the Local Government Committee, there is realization that that particular committee in this House of Representatives will have to begin its deliberations with respect to those questions which to date have been raised concerning Act 170 of 1978. It is the chairman's intention at this particular time to begin a study of all those matters which have been brought to us as individual Representatives and also to those persons who specifically serve on the Local Government Committee, so that a determination can be made as to what changes should properly be made to Act 170. It is his intention to begin a review of this matter in the very near future, Mr. Speaker, and to bring before this House of Representatives the committee's recommendations with respect to Act 170.

Mr. FRYER. Mr. Speaker, would the gentleman care to advance any date as to when this vehicle would be before the House?

Mr. S. E. HAYES. If the General Assembly enacts HB 17 with the 1 August effective date, it is the chairman's intention to begin these reviews and studies in the very near future, as I mentioned, because if we are going to satisfy that 1 August date, there is going to have to be something before this House of Representatives and then to the Senate of Pennsylvania so that both chambers can take appropriate action before the 1 August date expires, which means that, in all probability, by the month of May the Local Government Committee will be ready to report its findings back to this House of Representatives.

Mr. FRYER. Mr. Speaker, I gather then that there would be ample time for the various members of the House to present their amendments at that time so that they could be considered on the floor of the House with ample time for the Senate then also to act prior to that deadline. Am I correct in that assumption?

Mr. S. E. HAYES. I believe your assumption is correct and I

believe the chairman would even like to cooperate with those individual Representatives before it is necessary to come to the floor of this House. In all probability, some of the concerns which are being expressed by individual Representatives who do not serve on the Local Government Committee could be brought to the attention of the Local Government Committee in proper form as meetings are scheduled on this particular statute so that the committee can consider those matters even before the appropriate legislation comes to the floor of this House. Of course, if the committee does not accept their points of view during committee deliberations, they are more than welcome, under the rules of the House, to bring amendments to this floor, but it is the committee chairman's intention to bring before this House of Representatives its recommendations in good order so that the 1 August deadline can be satisfied without a further delay.

Mr. FRYER. I thank the gentleman, Mr. Speaker, and at this time I will withhold my proposed amendments and offer them at the proper time. Thank you, Mr. Speaker.
