STATEMENT BY MR. WASS

Mr. SIEMINSKI. Mr. Speaker, I rise to ask for unanimous consent to make a brief statement.

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. SIEMINSKI. Thank you, Mr. Speaker.

Saturday, May 2, I had the honor and privilege to participate in the Fourth Annual Polish-American Day sponsored by the Polish-Americans of Lehigh Valley and the Sun Inn Society of Bethlehem. Since this is the anniversary marking the first Polish free constitution and the contribution of General Casimir Pulaski, Polish nobleman and patriot, to our fight for freedom and Solidarity's current strife in Poland, I would like to have my remarks of Saturday spread upon the record. Thank you, Mr. Speaker.

Mr. SIEMINSKI submitted the following remarks for the Legislative Journal:

REPRESENTATIVE EDMUND J. SIEMINSKI SPEECH, MAY 2, 1981 4TH ANNUAL PULASKI DAY CELEBRATION BETHLEHEM, PA

I greet you very cordially in Polish—Witam was Polskimi slowami badrzo serdecznie.

I am filled with pride and humility this morning as I join with you to commemorate the significance of this day and place here in historic Bethlehem. As the grandson of a Polish immigrant, I am proud to have been asked to make brief remarks today. Like you, I am proud of my heritage. I am humbled, however, by my inability to express my inadequate remarks in fluent Polish. Unlike many of you present today, I did not learn Polish at home or in school. For that I apologize.

As a retired Army officer and cavalryman in the modern, mechanized American Army, it gives me particular pride to join with you in commemorating the contribution of General Casimir Pulaski, Polish nobleman and father of the American cavalry, to the cause and success of the American Revolution.

Pulaski arrived in Marblehead, Massachusetts, on July 23, 1777. In August he joined George Washington's staff which was stationed in Bucks County, as a volunteer. As we know, April 16 and May 17, 1778, he visited the Moravians in Bethlehem. A detachment of his union was on duty at Minnisink near Bethlehem. The Moravians and Poles were neighbors in Europe. The Moravians later made Pulaski's banner which was the subject of Longfellow's poem "Hymn of the Moravian Nuns."

Casimir Pulaski came to America in defense of liberty. His lifelong dedication to the principle of freedom, both in his native Poland and in this land, was, I think, characteristic of all Poles' love of freedom, liberty, and justice. That same spirit is demonstrated by the trade union movement Solidarity in Poland today. Just as General Pulaski, in his own words, "could not submit to stoop before the sovereigns of Europe" and came to America to fight for liberty, the formation of the trade union movement Solidarity in August 1980 testifies to the unquenchable spirit of freedom in the Polish people.

Count Pulaski, the father of the American cavalry, fought alongside Washington and Lafayette for the formation of a new republic free from economic restraints imposed by a foreign rule—restraints which ran counter to the needs of its subjects. Patriots rebelled against the Stamp Act and taxes on tea and sugar. An analogous drive for economic self-determinism fuels Solidarity's current demands for the worker's voice in economic decisions. In Lech Walesa (Wah-len-sa) words, "We can work for only a plate of soup if we know for whom we work, if we knew we work for ourselves: We are Poles and responsible ones" are echoes of the same democratic principles for which General Pulaski gave his life.

While the seeds of the American Revolution fay partly in Britain's economic repression, equally compelling was an insistence on other inalienable human rights; religious freedom, freedom of assembly, and freedom of speech. The realization of these principles was the goal of Count Pulaski's unfailing devotion to the American cause and are among the aims of Solidarity's efforts,

In Poland, the Catholic Church, since the baptism of its first ruler in 966, has been an enduring stronghold through almost two centuries of foreign domination: It remains a symbol both of Polish nationalism and anti-communism.

Solidarity is a nationalistic movement which has united Poles from all sectors of society (farmers, workers, professionals, students, miners) in the cause of liberty and democracy within their political system. Count Pulaski charged into approaching British forces and was able to halt their advances during the Battle of Brandywine, thereby encouraging the American troops to reassemble and repel the British forces. On this and other occasions, such as his successful recruitment of independent troops. Count Pulaski united American patriots from equally diverse backgrounds in the cause of American nationhood. His banner, with the words "Union makes valor stronger" and "No other governs" and his personal heroism in combat reflect a deep and ardent love of liberty. He wrote in a letter to Col. R. H. Lee, "Honor and a true desire of distinguishing myself in defense of liberty was the only motive which fired my breast for the cause of the United States.'

Like the members of Solidarity, Count Pulaski risked everything—family, property, his fatherland, and even his life—in the struggle to regain freedoms taken away by others.

In October, addressing a rally, Lech Walesa said: "Do not give in, for once you give in, you will not rise back for a long time. Indeed, we cannot surrender, for those who will follow us will say, 'They were so close and they failed.' History would not absolve us then."

History did not have to absolve Count Pulaski. His heroism and devotion to national liberty continue as inspirations for Americans over 200 years later.

Two days before his death Pulaski, heavily wounded at the Battle of Savannah, said: "God is good. He let me think clearly and pray. I have so much for which to pray: That my country will once again be freed as this country surely will. All my life I have fought for freedom."

Today his prayers seem to be coming true. Poland fights for the independence started with Pulaski. He has inspired the many great heroes who fought "for our freedom and yours." He was looked upon during the epic of heroism of three generations of insurrectionists in Poland: He is the inspiration of the Polish workers now. Freedom, the right to live and work in a free, just country is the main aim to the workers of Solidarity. It is the aim of the free trade union.

Pulaski and his ideals will be remembered as long as there are people who love freedom, and who want to live in peace.

Today as we commemorate and rededicate Pulaski Day, let us all reflect on and pray for the success of the Polish people to gain their rightful freedom.

I finish with the Polish words goodbye: Koncze Polskimi slowami: do widenzia!

The SPEAKER pro tempore. Could the gentleman, Mr. Wilson, understand the question?

Mr. WILSON. I heard the question, but I do not know if anybody else did.

The SPEAKER pro tempore. I know I could not hear it.

BILL ON THIRD CONSIDERATION POSTPONED

The House proceeded to **HB 82**, **PN 83**, on third consideration postponed, entitled:

An Act amending the "Pennsylvania Cigarette Tax Act," approved July 22, 1970 (P. L. 513, No. 178), removing an exemption from taxation.

On the question,

Will the House agree to the bill on third consideration as amended?

Mr. HOEFFEL offered the following amendments No. A1206:

Amend Title, page 1, line 4, by removing the period after "taxation" and inserting

and prohibiting persons convicted of felonies and certain other crimes from being licensed as cigarette stamping agents.

Amend Bill, page 2, by inserting between lines 14 and 15

Section 2. Section 402 of the act, is amended by adding a subsection to read:

Section 402. Licensing of Cigarette Stamping Agents.—***

(e) For purposes of this section, a person convicted of committing any felony, any infamous crime or any crime involving moral turpitude shall not be a "person of good moral character" and shall not be licensed as a cigarette stamping agent.

Amend Sec. 2, page 2, line 15, by striking out "2." and inserting

3.

On the question,

Will the House agree to the amendments?

The SPEAKER pro tempore. The Chair recognizes the gentleman from Montgomery, Mr. Hoeffel.

Mr. HOEFFEL. Thank you, Mr. Speaker.

Mr. Speaker, this amendment is being offered by Representative Freind and myself and addresses itself to the licensing of cigarette stamping agents.

As the members know, the cigarette stamping agents in the Commonwealth perform a very sensitive function on behalf of the Department of Revenue. They are responsible for affixing to the cigarette packages sold in this state the state stamp that indicates the amount of tax paid on the cigarettes.

A court decision in 1973 found that the cigarette stamping agents were not required to meet the standard of moral character that was currently in the law at that time. The court decision was on a specific case and found that the cigarette stamper under question, who had been convicted of violations

of drug laws and alcohol laws in the 1950's, was nevertheless not to be found in violation of the moral turpitude section of the law and was allowed to be a stamping agent.

It is my view that we need to make sure that people who have this very sensitive responsibility not be convicted felons, not be guilty of infamous crimes, and, therefore, this amendment would say that people who had been convicted of these offenses could not be eligible for licensure as stamping agents. I ask for approval of my amendment. Thank you.

The SPEAKER pro tempore. Does the gentleman, Mr. Richardson, wish to be recognized on the amendment?

Mr. RICHARDSON. Yes. I would like to interrogate the sponsor of the amendment, because it is very hard hearing what the intent of this amendment is.

The SPEAKER pro tempore. The gentleman, Mr. Hoeffel, indicates that he is willing to be interrogated.

Mr. RICHARDSON. Mr. Speaker, could you explain to us what the terminology "any infamous crime or any crime involving moral turpitude" means to you in relationship to this amendment?

Mr. HOEFFEL. Yes, Mr. Speaker. I do not have to tell you what it means to me. I can tell you what the courts have said those two phrases mean.

The condition of moral turpitude has been defined by the Pennsylvania Supreme Court as personal misconduct in the private and social duties between citizens that would be considered acts of baseness, vileness, or depravity and as contrary to accepted and customary rule of right and duty between citizens. That would be the court's definition of "moral turpitude."

The definition of "infamous crime," Mr. Speaker, has also been defined and followed by the Pennsylvania Supreme Court. Just to restate quickly, Mr. Speaker, both of these phrases, "moral turpitude" and "infamous crime," have been defined by the Supreme Court of Pennsylvania and are routinely followed and interpreted because of those court decisions. They are not terms that I dreamt up, in other words. These are terms taken from the case law of Pennsylvania.

I gave you the definition of "moral turpitude." Now, as to the definition of "infamous crime," the language I have is rather stilted because it is an old case, but it was a Supreme Court case that defined the phrase "infamous crime" which appears in our state constitution, and it essentially says that people who have been convicted of an infamous crime are people who are incompetent to be witnesses, who have been convicted of treason, felony, and crimes such as forgery, perjury, subordination of perjury, false verdict, and then the language continues, "...other offenses of the like description which involve the charge of falsehood and affect the public administration of justice."

Mr. Speaker, the point of all this, the point of my amendment, is to focus in, first off, on felonies—that is included in the amendment—then those two phrases, "moral turpitude" and "infamous crime," to try to focus on crimes that have involved an abuse of public trust, some kind of flagrant abuse of common decency between people as opposed to something

like a traffic violation. We are not including misdemeanors or summary offenses; they are not included in my amendment. We are including all felonies and then other offenses that would be interpreted by the courts as these abuses of public trust.

Again, Mr. Speaker, the purpose is to make sure the people who are licensed as stamping agents and therefore responsible for thousands of dollars of state revenue would be people of high moral character, people whom we can trust with our tax money.

Mr. RICHARDSON. Would this also include in any way the question of embezzlement? Is it part of the felony law?

Mr. HOEFFEL. Mr. Speaker, I assume that embezzlement is a felony. If it is not a felony, I would certainly assume it would be considered a crime of moral turpitude.

Mr. RICHARDSON, Okay.

Mr. HOEFFEL. I am pretty sure it is a felony.

Mr. RICHARDSON. Okay. One final point: The amount of dollars handled by cigarette stamping agents is a lot of money in this Commonwealth concerning revenue and other matters that deal specifically with those persons who would be out there in the community going from place to place dealing with cigarettes, right? And because of the fraud that we have presently with the crime wave and with the Crime Commission reports that have come back with these persons who are able to get away with a lot of these crimes, you are going at the prevention stage at this point prior to them becoming these agents and then cheating the system. You are saying this amendment here will help strengthen the laws around that. Is that my understanding?

Mr. HOEFFEL. Yes, sir, that is my intention and Representative Freind's intention. Let me say, Mr. Speaker, that the cigarette stamping agents that I am referring to and Mr. Freind is referring to in this amendment are not state employes. These are private individuals who sell and wholesale cigarettes for a living, and they are licensed by the state to be cigarette stamping agents - all the more reason, in my judgment, that we need to have high standards for them to meet before they can be licensed. They are private citizens who are in this business, and the Revenue Department asks private citizens to stamp the cigarette packs that we sell in Pennsylvania. The stamping is not done by the state. It is done under license by the state by the private sector, and we are simply trying to make sure that the people who are licensed to do this work have good records.

Mr. RICHARDSON. Thank you very much, Mr. Speaker. I wish to be in order to speak on the amendment.

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. RICHARDSON. I would just ask the members to support the amendment. I support the amendment, and I thank the gentleman for the clarity on the amendment.

STATEMENT BY MR. DAVIES

The SPEAKER pro tempore. The Chair recognizes the gentleman from Berks, Mr. Davies.

Mr. DAVIES. I request unanimous consent to address the House.

The SPEAKER pro tempore. The Chair hears no objection. The gentleman may proceed.

Mr. DAVIES. I have distributed a piece that I wanted to be read into the record, "Our Day in Commonwealth Court, A Judicial Mockery."

I would like to make corrections on it. In line 1, that "Last Friday" should read "Two Fridays ago." Line 6 should be "last week." Line 9 should be "many of these" at the end of the line.

I would like to make an additional statement to this, Mr. Speaker, that the Supreme Court asked for a temporary I-day stay, which kept the trains running another day, then ruled against the Public Utility Commission and the same interveners, those three representatives. This is again an example of the judicial system ignoring the legislative intent of the law by upholding an improper administrative interpretation of the law of the Commonwealth by unilateral action of the Department of Transportation without proper notification of the rule-making decision by that same department. No notification of the same was in the Pennsylvania Journal. This strikes at the very essence of our system, the balance of power between the legislative, executive, and the courts.

I would be remiss if I did not call your attention to this important matter and ask the leadership on both sides of the aisle to consider this as an additional erosion of our constitu-

tional powers. I would ask that leadership consider possible action in the Federal courts to seek a remedy to this constitutional abuse of judicial and executive power. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Speaker would like to thank the members of the House for the election yesterday when I was elected as Speaker pro tem in the absence of Speaker Ryan. I want to thank the gentleman from Dauphin County who conducted over the Chair at that time and for his method of railroading it through without a vote and assuring me a victory, but I am very proud and I want to thank you people for bestowing this honor on me.

I had them check, and it is the first time they have elected a Speaker pro tem since 1921, and, unfortunately, at that time the reason they did it was because they kicked out of the Chair a gentleman from York County. Let us hope that does not happen. But I want to thank the members of the House, and bear with me, and we will try to get along until the Speaker gets back. Thank you very much.

STATEMENT BY MR. McMONAGLE

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. McMonagle.

Mr. McMONAGLE. Mr. Speaker, I would like to have the unanimous consent of the House to make a brief statement.

The SPEAKER pro tempore. The Chair hears no objection. The gentleman may proceed.

Mr. McMONAGLE. Thank you, Mr. Speaker.

Yesterday we had a patriot who died. Some people call it suicide; others call it murder. The news media this morning announced the death of Bobby Sands in the Maze Prison in Belfast as the result of a hunger strike. Bobby Sands was recently elected to the House of Commons and was thus a political prisoner by any rational definition of the term. And it is in the interest of all who believe in democracy and in the proper function in a parliamentary practice that such a death be noticed, and the British Government has revealed an extraordinary insensitivity to both the humanitarian aims and to the creation of enduring peace in Ireland. All men and women of goodwill now pray that the demise of this young man not be a spur for more bloodshed in that unhappy country, and we hope somehow the intractable conservative government of Mrs. Margaret Thatcher can be moved to consider its cruel intransigence and enter into negotiation with all interested parties.

Mr. Speaker, Bobby Sands is not the only one who died. There were 12 others in the last 20 years who died from hunger strikes. We have three other men in Ireland who right now have 56 days and 45 days each of fasting. John Hughes, who has 56 days of fasting, is near death himself. There was a quote from his brother saying that when he went to prison Sunday he did not recognize the 27-year-old man. What he recognized was a 90-year-old person who is dying, who is blind, and through the people of Ireland, who are saddened

by this affair, and the American people, I think we ought to do something to let England know.

Six weeks ago we in this House passed a resolution commending England for their human rights. This does not show me any human rights from England. This shows me a great insensitivity from a leader who is supposed to be from a free country and will not do anything for the people who are under their laws. That same thing could not happen here in the United States. It would be a disgrace, and when everybody in the country would know about it, they would be up in arms.

Yesterday our brothers and sisters in the State of New Jersey passed a resolution condemning England for that. I have a resolution which will be coming down. I thought it would be down by now, but Monday when I introduce it, I hope every member of this House will sign it. Thank you very much.

The SPEAKER pro tempore. The Chair recognizes the majority leader.
