Mr. WENGER. Mr. Speaker, the present bill says that in order for a farm to qualify for the provisions of this bill, it has to have gross sales of at least \$2,000 per year. There was some concern that this amount was too low and that this would extend these benefits to backyard farming operations that were not really farms in the first place. For that reason I have

proposed the amendment that would increase the threshold from \$2,000 to \$5,000. That means that before a farm could qualify for the provisions of this bill, it would have to have gross sales of at least \$5,000. I respectfully request an affirmative vote on this amendment.

Mr. REBER. Mr. Speaker, Representative Foster will, most likely on final passage, speak in greater detail as to the necessity for this bill. This is a very minor amendment and preserves the bill as written with the exception of providing for an exception to the 10-acre excess requirement. It is simply going to allow farmers who have a lease arrangement to continue to have the exemption in full force and effect under the act.

I believe the abuses that necessitated the introduction of this legislation certainly will not be perpetuated by this amendment and will give appropriate relief to farmers who have been acting with the intent of this initial exemption when it was put into the Municipalities Planning Code. This is an agreed-to amendment, and I would ask for your support. Thank you.
