Mr. Speaker, ladies and gentlemen, I would like to introduce some very dear friends of mine. They are the colorful entourage assembled in the rear of the House, and they are the First Highland Watch of Bucks County. They have been designated the Governor's own band, and they are here today to entertain the members of the House briefly.

They are here as the guests of the Bucks County delegation, Representative Hoeffel, and myself. Thank you.

STATEMENT BY MR. OLIVER

TERCENTENARY COMMITTEE ON THIS DAY IN HISTORY

The SPEAKER. The Chair at this time recognizes the gentleman from Philadelphia, Mr. Oliver, for the purpose of giving us this day in history.

Mr. OLIVER. Thank you, Mr. Speaker.

Mr. Speaker, on this day in history in 1780, Pennsylvania's General Assembly began a process which would eventually

lead to an end of slavery in America. On that date the Abolition Act was passed, which repealed a number of discriminatory laws against blacks. Mounting objections to slavery, which were evident as early as 1688, resulted in Pennsylvania becoming the first of the colonies to legislatively call for freedom for black men and women.

It was primarily the Quakers, led by Francis Daniel Pastorius of Germantown, who spoke out against slavery and drafted strong moral challenges against such bondage. Because of the work of Pastorius and others like him, the number of slaves in the Commonwealth dropped from over 3,700 in 1790 to zero in 1850.

The early battle against involuntary servitude in Pennsylvania included some of our Nation's most articulate Founding Fathers. Philosopher, scientist, statesman Benjamin Franklin served as the president of the Pennsylvania Abolition Society in 1787.

While the fight against slavery ran on for many years and racial discrimination has still not been entirely erased, the beginning of the end of such discrimination can be traced back to the Pennsylvania assembly's passage of the Abolition Act on this day in 1780. Thank you, Mr. Speaker.

AMENDED HOUSE BILL RETURNED FOR CONCURRENCE CONSIDERED

The clerk of the Senate, being introduced, returned the following **HB 874**, **PN 2776**, with information that the Senate has passed the same with amendment in which the concurrence of the House of Representatives is requested:

An Act amending the "Liquor Code," approved April 12, 1951 (P. L. 90, No. 21), further providing for the licensing of establishments near interstate highways and for unlawful acts relative to liquor, malt and brewed beverages and licensees.

The SPEAKER. The Chair recognizes the gentleman from York, Mr. Lehr.

Mr. LEHR. Mr. Speaker, I request that we nonconcur on HB 874.

PARLIAMENTARY INQUIRY

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. Richardson.

Mr. RICHARDSON. Mr. Speaker, I would like to ask a point of parliamentary inquiry.

The SPEAKER. The gentleman will state his point of parliamentary inquiry.

Mr. RICHARDSON. It is my understanding that there is no opportunity at all to amend a concurrence bill. Is that correct, Mr. Speaker?

The SPEAKER. That is correct, Mr. Richardson.

Mr. RICHARDSON. I would like to ask whether or not we may know why the gentleman is asking for nonconcurrence and what the Senate amendments are.

The SPEAKER. The gentleman from York, Mr. Lehr, indicates he will consent to interrogation. The gentleman may respond to Mr. Richardson's question.

Mr. RICHARDSON. I would like to know, and I guess for the edification of all the members of the House, what the Senate amendments were and why you are asking for nonconcurrence.

Mr. LEHR. The Senate put into HB 874 a provision that a liquor establishment can be 300 feet off an interstate highway. Representative Foster is very much concerned about this problem. I would yield to Representative Foster to let him tell you the problem he has with the bill.

The SPEAKER. The Chair recognizes the gentleman from York, Mr. Foster.

Mr. A. C. FOSTER. Thank you, Mr. Speaker.

I am not opposed to the amendment per se, but I am opposed to the way it is drafted in the bill in that there is an apparent omission. In the language on page 2, starting on line 4 of page 2, current law states that no licensed establishment

shall be permitted within 300 feet of a ramp of an interstate highway. The change that was being made here was simply that the entrance of the building be within no less than 300 feet. However, what they did, on line 5 they say "...the entrance of an interstate limited access highway." They neglected to also say the "exit." So for the gentleman, Mr. Richardson, they should have included both "exit" and "entrance." Therefore, I would likewise like a nonconcurrence so that that can be corrected.

Will the House concur in Senate amendments?

House Resolution No. 9 was passed concurrently by the House of Representatives and the Senate in the Spring of 1981. It directed this committee to "conduct an investigation of the regulations and procedures of the Pennsylvania Public Utility Commission in order to ensure the public that adequate water service will be provided by the utilities under its jurisdiction."

A special Subcommittee on Water Supply Systems was created to facilitate that investigation, chaired by Representative Joseph R. Pitts. Comments were solicited from water customers, water regulators and water purveyors from across the Commonwealth. A public hearing was held in August of 1981.

This report contains the findings and recommendations resulting from that study. Given the breadth and complexity of issues associated with the overall water supply problem, its focus is limited to those concerns addressed in House Resolution No. 9 or raised in the comments provided.

The recommendations contained in this report are felt to be fair, reasonable and appropriate. We firmly believe their implementation will improve water service to the public.
