STATEMENT BY MRS. HAGARTY

TERCENTENARY COMMITTEE ON THIS DAY IN HISTORY

The SPEAKER. The Chair recognizes the lady from Montgomery, Mrs. Hagarty.

Mrs. HAGARTY, Thank you, Mr. Speaker.

On this day in history, April 21, 1760, the cornerstones were laid for what was to become a distinguished Philadelphia institution, the private school known as Germantown Academy. Today the academy enjoys a special place in history as the Nation's oldest preparatory school in continuous operation.

The academy was founded by subscription, and a lot was purchased on what is now School House Lane. The academy was opened in 1761, and it was decided by its trustees that it should be free to boys of all religious denominations.

The original gray stone schoolhouse, which still stands, was 80 feet long and 40 feet wide, two stories high, with six schoolrooms and wings which formed dwelling houses for the use of the masters. The school's main entrance is reached by a stone sill, worn down by the tread of thousands of students and visitors. One of those visitors was George Washington, who came to the academy on several occasions.

Greek, Latin, and higher mathematics were taught at the academy, as well as the rudiments of good manners. However, it was expressly stated that youths of Quaker parentage were not required to take off their hats in saluting their teachers.

During the Revolutionary War the academy was used by the British as a hospital for casualties in the Battle of Germantown. Six Hessian soldiers who died of their wounds were buried somewhere on the grounds, and generations of younger students have from time to time made modest archeological excavations in the hope of turning up breastplates or buttons or bones.

For a more tangible reminder of the revolution, students had only to look skyward at the academy's belfry. British students evidently used it for target practice, for musketball holes are clearly visible.

It should be noted, Mr. Speaker, that at least one member of the House, the Honorable Charles F. Nahill, is a graduate of Germantown Academy. If any members wish to learn more of the school's 222-year history, I am sure that Representative Nahill will be happy to oblige them.

The SPEAKER. Does the gentleman from Lackawanna, Mr. Serafini, desire recognition?

Mr. SERAFINI. Mr. Speaker, my switch failed to function on HB 2340. I would like to be recorded in the affirmative, please. Thank you.

The SPEAKER. The remarks of the gentleman will be spread upon the record.

BILLS ON THIRD **CONSIDERATION CONTINUED**

The House proceeded to third consideration of HB 2257, PN 3130, entitled:

An Act amending the "Public School Code of 1949," approved March 10, 1949 (P. L. 30, No. 14), further providing for expenses for attendance at meetings.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman from Allegheny, Mr. Fleck.

Mr. FLECK. Thank you, Mr. Speaker.

HB 2257 will provide an open-ended reimbursement for school directors and some school officials to attend intrastate, inside Pennsylvania, conferences, as well as the national conference for the school board directors.

I have had a lot of correspondence-and I am sure some of you have—encouraging me to support this bill, but I think it is worthwhile that we point out that at a time when property taxes are a major concern to all of our constituents, at a time when school districts are unable to fund all of the programs that they express are needed by their schools, and at a time when this General Assembly is having difficulty meeting what we have stated in law as our expected level of contribution for school expenses, we should not be further increasing the expenses reimbursed to these school directors, and I will state why.

The national meeting for the conference of school directors is typically held in some of your more prestigious resort-type locations - 2 years ago, San Francisco; last year, New Orleans - and it seems to me the wrong time to be authorizing carte blanche to these school directors to attend conferences in New Orleans that are loosely supervised; we do not know what they are really getting out of it. Why do they not hold a regional conference in Cleveland, or Pittsburgh with our new convention center? I think we would feel a lot better about those types of expenses than sending our school directors with airline tickets and Hvatt Hotel rooms and dinners at Gallitiore's in New Orleans.

I think we ought to look at this bill, and I urge you to vote "no." Thank you.

The SPEAKER. The Chair recognizes the gentleman from Dauphin, Mr. Piccola.

Mr. PICCOLA. Thank you, Mr. Speaker.

I can appreciate the gentleman's concerns. However, I believe by not passing this legislation based upon the reasons he stated, we are really doing a disservice to our school board members. First of all, these conferences are only attended when they are authorized by the entire board. I have great faith that the school boards of this Commonwealth, with the limited funds available to them, will not use this opportunity

without the utmost amount of thought. There are a lot of changes going on in education, the approach to education and funding for education, and I think some of these conferences that are available will be of great benefit to school board members.

Secondly, you are talking about unpaid positions. These individuals serve without pay, and J think the knowledge that they gain from these conferences can be beneficial, and if we can encourage them to attend several of them, I think we are doing them a great justice.

I would point out to the gentleman that we have inserted language in there that the members must be accountable to the public in their districts by making public the expenses which they are being reimbursed for at the very next meeting of the school board. So these are not unaccountable expenses.

Finally, I would point out to the membership that in HB 1300, I believe, which we recently passed, the recodification of the School Code, similar language was included in that bill, and it is now in the Senate. So the House has already dealt in a positive nature on this issue.

The SPEAKER. The Chair recognizes for the second time the gentleman from Allegheny, Mr. Fleck.

Mr. FLECK. Thank you, Mr. Speaker.

Will the gentleman, Mr. Piccola, submit to brief interrogation?

The SPEAKER. The gentleman indicates he will. The gentleman may proceed.

Mr. FLECK. Mr. Speaker, could you tell me, under the public information portion that you just mentioned, the amendment, is that a requirement that that be publicly disclosed and made a part of the official and permanent records of the school board, or would that have to be requested by someone?

Mr. PICCOLA. The language is quite clear. It says, "All such expenses shall be made public at the next meeting of the board." Further, I would assume that if you are writing checks to reimburse board members, the writing of those checks is a public document available to the public at any time.

Mr. FLECK. Thank you.

May I be recognized?

The SPEAKER. The gentleman is in order.

Mr. FLECK. In brief rebuttal, it has been pointed out that these are unpaid directors and, therefore, maybe we ought to compensate them some way by allowing them to take trips to wherever these conferences arc held, and I think that goes directly to my point. These people agreed to serve without compensation. This is not to be compensation and should not be, unless there is a valid purpose and we can prove that it is done at the least possible cost to the taxpayer that this valid purpose be served. We should not be voting this in. We should not provide carte blanche for 1,000 dollars' worth of airplane tickets to go round trip to San Francisco or \$150 a night in a hotel room or \$100 a day in expenses. I think it is overdone. Maybe the limit is too low now, but we are not suggesting a new, more appropriate limit. We are suggesting carte blanche, and I think it is the wrong time in the Commonwealth's state of financial affairs to be doing this. Thank you.

The SPEAKER. The Chair recognizes the gentleman from Bucks, Mr. Cordisco.

Mr. CORDISCO. Mr. Speaker, I understand that the majority leader has intended for us to leave early, but I think it is very important that the members of this House fully understand what we are attempting to vote for here today.

I served as president of our local school board. I also upon serving on that board asked the Auditor General's office to review a situation that had occurred in my district where on one single convention, the school directors decided to take the entire school board to San Francisco at a cost of \$9,000 to my school district. Now, Mr. Piccola raised the point that it is upon approval of all the board members or the majority of those board members. If all nine members are going, Mr. Speaker, it is obvious that neither one is going to address the issue of how much they spent on that particular trip. The Auditor General found that they owed the school district in excess of \$3,000. It was not until 3 years later that they agreed to pay that money back to the district.

I also attended a trip, or a convention as they might say, to New Orleans, a definite junket. To my amazement, I found that not one school board director, upon meeting in the hospitality room, could address anything that was being discussed at that time. To clarify myself, I did pay the money back to the district and felt it was not a worthwhile trip and filed a report to that district. However, I do believe that it is very important to our school districts to send those people who can gather information that can be brought back to the district and be of value to that district. Those are superintendents and administrators, those educators who are knowledgeable enough to understand the material that is being discussed. That \$9,000, Mr. Speaker, is three-quarters of 1 mill within my district.

I do believe that the conferences that we do have in the State of Pennsylvania are valuable, and the information that can be gathered at those conferences could be utilized back in the local districts, therefore having no need to send people from our districts to New Orleans, to San Francisco, and so on. Those people who are elected to those positions understand it is a nonpaying job when they take the position and decide to run. If the only reason that they are running is to take the conventions, they are doing a disservice to the school districts.

The State of Mississippi prohibits any school director from traveling outside of its State boundaries. I think that Pennsylvania should follow that example.

There is not much that can be done to this bill at such a late date, and everyone will be at least trying to do something for their school directors. Let us try doing something for the taxpayers instead for a change and vote "no." Thank you.

The SPEAKER. The Chair recognizes the gentleman from Westmoreland, Mr. Hutchinson.

Mr. A. K. HUTCHINSON. Thank you, Mr. Speaker.

Confession is good for the soul, and maybe some other soul. I served 6 years on the school board, and I went to the conventions. I go to conventions here, and I think I am a better legislator because I went. When this is home rule, let them take the heat and the scuff and the scurry if they vote a whole nine-man board. I think we ought to give more back to the local people and let them decide how many want to go to the board. Conventions are good no matter where they are. even in Puerto Rico. Thank you very much.

BILL REVERTED TO **PRIOR PRINTER'S NUMBER**

The SPEAKER. The Chair recognizes the gentleman from Greene, Mr. DeWeese.

Mr. DeWEESE. Mr. Speaker, I would like to revert to the prior printer's number for this bill.

The SPEAKER. Will the gentleman state the number?

Mr. DeWEESE. Mr. Speaker, the current printer's number is 3130. I would like to revert to the prior printer's number. I do not have that available - 2931; excuse me.

The SPEAKER. The question before the House is the motion of the gentleman, Mr. DeWeese.

DECISION OF CHAIR REVERSED

The SPEAKER. Without objection, the Chair reconsiders its decision that this bill has been agreed to on third consideration.

On the question recurring,

Mr. PICCOLA. Mr. Speaker, I have no objection to the gentleman's motion. I would support that.

Such forms shall be made freely available to the public at county board of elections, municipal buildings and at such other locations designated by the secretary. Copies of all completed applications for official absentee ballots shall be retained by the county board of elections.

Section 2. Section 1303 of the act is amended by adding a subsection to read:

Section 1303. Official Absentee Voters Ballots.-***

The official absentee voter ballot shall state that a voter (e) who receives an absentee ballot because of illness or absence from the district and who, on election day, is capable of voting at the appropriate polling place must void the absentee ballot and vote in the normal manner at the appropriate voting place.

Mr. MANDERINO. Mr. Speaker, I, along with 38 cosponsors, sponsored a similar House resolution to SR 229. It was introduced last week in the House of Representatives. I rise today to urge passage of this Senate resolution in the interest of timely communication with Congress. It is imperative that Congress and the administration in Washington should know as soon as possible that we are opposed to the plans of the Office of Management and Budget to eliminate the Railroad Retirement Board. If this plan goes forward as it is now proposed, it will drastically affect the lives of 81,000 retired and 50,000 active railroad workers in our State. The Office of Management and Budget's action would make railroad pensions taxable and would renege on an agreement that has been in force since 1937 when the railroad retirement system was created.

The resolution before us today has the support of both labor and management in the railroad industry. We must agree with them that it is illogical to kill off a small independent agency that does not cost the Federal Government's General Fund a single penny.

The Railroad Retirement Board is a comprehensive agency that serves the needs of active and retired members through regional offices. In addition to administering the pension system and the workmen's compensation system, the board functions as a comprehensive unemployment agency for all of the railroad workers. Mr. Speaker, this means that the Pennsylvania railroad workers who are not now part of our UC system may become part of our system, and this has all sorts

of ramifications, given the condition of the unemployment compensation system in Pennsylvania. I urge for all these reasons, Mr. Speaker, an affirmative vote on the resolution.

In November of 1977 the Corps of Engineers had reviewed that situation, and it was determined that that wall was deteriorating. I have reviewed copies of correspondence, intradepartmental correspondence within the Department of Environmental Resources, in which they assessed the situation and made some recommendations. Unfortunately, there were legal problems involved; moneys that had been put aside in previous budgets were since used to fund the PEMA (Pennsylvania Emergency Management Agency) program, and the result, the only course of action that could be taken at this time would be to amend this piece of legislation. The amount of money involved is approximately \$370,000 for the replacement of this wall and the reconstruction. I would appreciate the support of all the members on this amendment. Thank you.

The SPEAKER. Does the gentleman from Allegheny, Mr. Grabowski, desire recognition on the amendment?

Mr. GRABOWSKI, Yes, Mr. Speaker.

The SPEAKER. The gentleman is in order.

Mr. GRABOWSKI. I rise in support of the Pistella amendment. The borough of Millvale is currently in my legislative district. This has been a longstanding concern of the people of the borough of Millvale, and that is the problem, that it probably will not be standing much longer. I am sure all of you remember the tragedy that happened back on July 20, 1977, in Johnstown, and I would think that if several months prior to that this House of Representatives could have made an appropriation to prevent that tragedy, I could not imagine anyone who would vote against it. This tragedy will happen if that wall is not replaced or repaired, and I ask for an affirmative vote.
