BILL PASSED OVER TEMPORARILY

The SPEAKER. The Chair rescinds its decision on SB 5 as being agreed to. SB 5, PN 766, will go over temporarily.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 189**, **PN 586**, entitled:

An Act amending the "Real Estate Tax Sale Law," approved July 7, 1947 (P. L. 1368, No. 542), extending time for claims for unpaid taxes; and extending waiting periods.

On the question,

Will the House agree to the bill on third consideration? Mr. DORR offered the following amendment No. A0513:

Amend Sec. 1 (Sec. 502), page 5, lines 12 through 17, by striking out all of said lines and inserting

- (1) Serious physical illness or injury or a combination of such illness or injury with a state of prolonged unemployment if:
 (i) the taxpayer is a permanent resident of the Commonwealth,
 (ii) the illness or injury, or combination thereof, occurred during the tax year for which the taxes were assessed or during the year immediately preceding, and (iii) the illness or injury, or combination thereof, has been a substantial cause of the taxpayer's failure to pay the tax to the date of application for relief under this section.
- (2) Unemployment if: (i) the taxpayer is a permanent resident of the Commonwealth, (ii) the unemployment occurred during the tax year for which the taxes were assessed or during the year immediately preceding, and (iii) the unemployment has been a substantial cause of the taxpayer's failure to pay the tax to the date of application for relief under this section.

On the question,

Will the House agree to the amendment?

The SPFAKER. On that question, the Chair recognizes the gentleman from York, Mr. Dorr. The gentleman is in order and may proceed.

Mr. DORR. Thank you, Mr. Speaker.

The amendment attempts to clarify two phrases which are used in the act in order to make certain that the tax claim bureaus and other interested people will know what is meant by the terms "serious physical illness or injury" on the one hand and "unemployment" on the other.

I believe the language problems have been worked out now, and I would recommend an affirmative vote on the amendment.

The SPEAKER. The Chair thanks the gentleman.

On the amendment, the Chair recognizes the gentleman from Beaver, Mr. Laughlin.

Mr. LAUGHLIN. Mr. Speaker, I agree with Representative Dorr. The original amendment that he had offered was very restrictive in that it would have deprived just about everyone in the State who was on unemployment compensation of receiving benefits. This new language clarifies that issue, and I certainly urge the members to concur.

The SPEAKER. The Chair thanks the gentleman.
