Mr. Speaker, there is a very important matter of HB 960, which was the deficiency appropriation bill passed by the House of Representatives, sent to the Senate. The Senate chose to take out the appropriation to the Auditor General, and the bill is back in our hands.

1 am asking, Mr. Speaker, that this House be declared in recess until 3 o'clock and that at 3 o'clock we return to the

floor of the House for the purpose of handling the deficiency appropriation bill, HB 960, which is presently listed on the supplemental calendar. It is imperative that all members of the Democratic Caucus report to the caucus so that we can discuss the matter of HB 960, and we also will take up the other third consideration bills on the calendar which have not been caucused on. All members report to the caucus upon the declaration of the recess.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, would the majority leader advise us whether it is his intention to take up when we return from recess bills other than HB 960? It was not clear from his statement. I understood him to say caucus on them, but I did not understand whether he intended to take them up or not.

Mr. MANDERINO. Mr. Speaker, it is my understanding that the bills on third consideration have been passed over for the day. If we can get an agreement on running some of the bills today, I would like to do that, but that would be done by agreement.

#### PARLIAMENTARY INQUIRIES

The SPEAKER. The Chair recognizes the minority leader. Mr. RYAN. Mr. Speaker, I have several points of parliamentary inquiry I would like to pose to the Chair.

The SPEAKER. The gentleman will state those points.

Mr. RYAN. Is it my understanding that the motion is such that if it carries, only one amendment would be permitted to be offered to this particular bill at this time?

The SPEAKER. That is correct. That is the understanding of the Chair.

Mr. RYAN. A second point of inquiry, Mr. Speaker.

The SPEAKER. The gentleman will proceed.

Mr. RYAN. In your absence several weeks ago, we moved to suspend the rules to permit an amendment to Senate amendments, and we had some difficulty that day. My question to you, Mr. Speaker, is, assume for a moment that the amendment that Mr. Manderino would offer is accepted and the bill, as amended by Mr. Manderino's amendment, does not get 102 votes. What happens? Let me go a step further, if I may. Is that tantamount to a nonconcurrence? And if it is a nonconcurrence, does the bill that goes back to the Senate and eventually into a conference committee, presumably, have the Manderino amendment with it or without it?

The SPEAKER. It would be the Chair's belief, Mr. Ryan, that if the Manderino amendment were added, it becomes an integral part of the bill, and if on a later vote the bill fails concurrence, then the bill, together with the Manderino amendment added, will be sent back to the Senate.

Will the gentleman, Mr. Ryan, wait for a moment? I am not following the argument of the Parliamentarian, and I do not want to change anything which is already established in the House.

In answer to the minority leader, it is the Chair's opinion that if the Manderino— Assuming that the House suspends the rules, then the question would be immediately before the House, as soon as the gentleman, Mr. Manderino, offers his amendment, shall the House adopt the amendment? Assuming also arguendo that the House does adopt the amendment, then the question is, will the House concur in the Senate amendments as amended?

The problem area arises that if the House fails to concur in the amendments as amended, in what position is HB 960? It is the position of the Chair that at that point in time he will request the majority leader to withdraw his amendment from the bill after the proper reconsideration motion is adopted, and therefore, in front of us would be HB 960, PN 1343, in the form that it was sent to the House by the Senate, and the question then would be whether the House concurs or nonconcurs.

On the question recurring,

Will the House agree to the motion?

The SPEAKER. The Chair recognizes the majority leader on the motion.

Mr. MANDERINO. Mr. Speaker, 1 ask for an affirmative vote on the suspension of the rules. The Senate removed the deficiency moneys for the Auditor General's Office, and 1 think they ought to be returned, and that can only be done by a suspension of the rules, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, I oppose the motion of the gentleman, Mr. Manderino, to suspend the rules for a number of reasons. First, the amendment that he proposes to offer, which is part of his motion, restores the bill to the point it was when it left the House, and it is that portion, and it is this amendment, that was deleted by the Senate.

It seems to me, Mr. Speaker, that the interests of the welfare constituency, the veterans, and the job training money that is wrapped up in this bill - the interests of all of these are better served if we address the main question before the House, which is simple concurrence.

Mr. Speaker, I asked the parliamentary question that I did because several weeks ago we became embroiled in a parliamentary battle. I think the wisdom of the rule that you cannot amend Senate amendments became apparent that day several weeks ago when you were absent. I think there is a good reason for that rule. I think that reason is still with us, despite your ruling, because it occurs to me, Mr. Speaker, that if you have a majority that will put the Manderino amendment in and you do not have the 102 votes to concur with those amendments, you probably will not have a majority to remove the amendment, and the only people who will suffer will be the welfare recipients, the veterans, the summer job program, and medicaid. I think it would be far wiser for us to vote against this motion, take up the question under consideration-that is, of concurrence-and be done with HB 960. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

A majority of the members elected to the House having voted in the affirmative, the question was determined in the affirmative and the motion was agreed to.

The SPEAKER. The House rules are suspended for the specific purpose of debating amendment A1157, to be offered by the majority leader.

On the question recurring,

Will the House concur in Senate amendments?

Mr. MANDERINO offered the following amendment No. A1157:

Amend Sec. 2, page 2, by inserting between lines 16 and 17 To the Department of the Auditor General For the Department of the Auditor General for auditing annually, periodically or specially, the affairs of any department, board or commission which are supported out of the General Fund, district justices, other fining offices, Volunteer Firemen's Relief Association Funds and the offices of elected State officials.....

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the majority leader.

Mr. MANDERINO. Mr. Speaker, very briefly, amendment A1157 provides a deficiency of \$550,000 to the Auditor General, which was passed substantially by this House when it passed HB 960, and I ask for an affirmative vote.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader.

Mr. RYAN, Would the gentleman, Mr. Manderino, stand for interrogation?

The SPEAKER. The gentleman, Mr. Manderino, indicates he will so stand. The gentleman, Mr. Ryan, is in order and may proceed.

Mr. RYAN, Mr. Speaker, it is my understanding in the bill, HB 960, that all the deficiency appropriations provided for are provided because these various departments and/or programs are running a deficit.

Mr. MANDERINO. Mr. Speaker, that is correct, including this one for the Auditor General.

Mr. RYAN. Has the Auditor General advised the House that he is in a deficit position? It is my understanding that that is not the case.

Mr. MANDERINO. Mr. Speaker, I think your facts are in error. The status of appropriations for the current month will show a negative balance in the Auditor General's account.

The SPEAKER. Has the gentleman, Mr. Ryan, concluded his interrogation?

Mr. RYAN. Yes, Mr. Speaker.

The SPEAKER. The Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, it is my understanding that the current month's appropriations are not yet available. It is my further understanding that the Auditor General has taken no steps whatsoever, if indeed he is in a deficit position, to protect against that deficiency, that there have been no layoffs, threats of layoffs, or cutbacks in spending. Now, when I say it is my understanding, it is based on a negative the negative being that the Auditor General has yet to contact us or anyone else and copy us of these facts. It may be that the gentleman, Mr. Manderino, has facts to support his position that there is a deficit running.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the majority leader.

Mr. MANDERINO. Mr. Speaker, the Auditor General has caused layoffs in order to try to stem the deficiency. He has vacancies and unfulfilled responsibilities that this General Assembly has given him. He has communicated that not only to our caucus; I know it was communicated to the Senate Republican Caucus. The communication came as early as February of this year. I am looking at a communication here which details the expenditures necessary to the end of the fiscal year, what has been done to stem those deficiencies, and he has taken proper action all through.

Mr. Speaker, I ask for an affirmative vote on the amendment.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, I am against this particular amendment for a number of reasons.

First, the appropriation of some \$550,000 covers a period of slightly less than 2 weeks. I sincerely believe that if Auditor General Benedict were running as tight as Mr. Manderino indicates he is, we would have heard of this problem that he has. How the Auditor General, in the closing 2 weeks of this fiscal year, is going to spend an additional \$550,000, that question goes unanswered.

My other concern, Mr. Speaker, is-and this was pointed out earlier in private conversations-we can take care of any slight deficiency he has when we resolve the entire budget problem. There is no need, 2 weeks before the end of the fiscal year, to address that problem. By addressing it today, those of you who have expressed an interest in the payment of welfare benefits to those who will not get them tomorrow are jeopardizing those payments. The Senate removed this \$550,000 from HB 960. If this bill goes back with this amendment in, and if it results in further delay and conference committees and further delay, then I think that those who vote for the amendment should bear the responsibility for those delays.

I think the prudent way to act is to deny Mr. Manderino this particular amendment, concur in the bill as we have it before us today, and address Auditor General Benedict's problem when we address the rest of the problems of the Commonwealth, rather than give him another \$550,000 to spend in the next 2 weeks. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question, the Chair recognizes the minority whip.

Mr. HAYES. Mr. Speaker, I wonder if the gentleman, Mr. Manderino, would answer one question, please?

The SPEAKER. The gentleman, Mr. Manderino, indicates he will so stand for interrogation. The gentleman, Mr. Hayes, is in order and may proceed.

Mr. HAYES, Thank you, Mr. Speaker.

Did I hear the gentleman correctly say that the Auditor General has additional job tasks at the present time which have been assigned by this General Assembly?

Mr. MANDERINO. Yes. You heard me say that there are responsibilities of the Auditor General that are not being carried out because of the lack of funds,

\$550,000

Mr. HAYES. Which ones would they be, sir? That is 1-A.

Mr. MANDERINO. Mr. Speaker, the Auditor General communicated with the chairman of the Appropriations Committee in February, and in the letter he communicated that he was unable to continue in several areas. If you would like to read the letter in its entirety, you may. I am quite certain that you and your caucus received a similar letter.

Mr. HAYES. Mr. Speaker, if I may continue.

How is the Auditor General going to do all of those things which purportedly are required of him in the next couple of days before the end of this fiscal year?

Mr. MANDERINO. Just as all the other departments that are getting deficiencies in this bill will be able to use their deficiencies in the last 2 weeks, as you put it. It is not the last 2 weeks - it is the pay periods; it is accrued bills; it is bills that have not been paid; it is moneys that should be coming from the departments that have been billed for audits that have not been paid because the Thornburgh administration is experiencing severe deficiencies in their budget so they are not paying their bills.

Mr. HAYES. The facts are, Mr. Speaker, the Auditor General refused to live within the confines of his budget, and there is a distinct difference between an Auditor General refusing to do that and a Bureau of Correction, which is suffering crowded conditions at the present time, having to do what it must do by law. There is certainly a lot of difference, Mr. Speaker, and I believe the gentleman made my point. There is no way that he is going to be able to do all those audits in the next couple of days. Whatever is accruing, the gentleman who serves this Commonwealth as Auditor General could bring us those bills for inclusion in the next fiscal year's budget. There is certainly nothing urging us at this time to pass \$550,000 of additional bills. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the majority leader.

Mr. MANDERINO. Mr. Speaker, will the gentleman, Mr. Hayes, consent to interrogation?

The SPEAKER. The gentleman, Mr. Manderino, requests that the gentleman, Mr. Hayes, stand for interrogation. The gentleman, Mr. Hayes, indicates that he will so stand. The gentleman, Mr. Manderino, is in order and may proceed.

Mr. MANDERINO. Mr. Speaker, do you remember that the Treasurer of this Commonwealth was given additional funds over his budget? Do you recall that?

Mr. HAYES. That request was certainly better documented than the one here today.

Mr. MANDERINO. That is your opinion. But he was given additional funds over his budget, was he not? And at that time you refused to give the Auditor General money. Is that not correct?

Mr. HAYES. Based upon documentation, the one gentleman was able to affirm why he needed the money; the other one just kind of wants to make things fair.

Mr. MANDERINO. It is a question of whether or not you recognize the documentation that was given to you or whether you just say we do not recall ever getting anything.

#### Mr. HAYES. Where are the bills, Mr. Speaker? Mr. MANDERINO. I have concluded my interrogation. The SPEAKER. The Chair thanks both gentlemen.
