BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of SB 473, PN 876, entitled:

An Act amending the act of June 3, 1937 (P. L. 1225, No. 316), entitled "The Game Law," removing the requirements to obtain special permits for the possession and sales of ferrets or fitches; further defining unlawful hunting with ferrets or fitches; and providing penalties.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage. The question is, shall the bill pass finally?

(Members proceeded to vote.)

The SPEAKER. For what purpose does the gentleman from Northampton, Mr. Freeman, rise?

Mr. FREEMAN. I ask that the vote be stricken until more members are present on the floor.

The SPEAKER. The vote will not be stricken. We will hold the board open.

Mr. FREEMAN. Thank you, Mr. Speaker.

The SPEAKER. The Chair will be cautious about closing the board.

All members report to the floor. We are on final passage of SB 473. We are dealing with the sales of ferrets and fitches. All of you who are concerned with the sale of ferrets and fitches will report promptly on the floor of the House.

For what purpose does the gentleman from Bucks, Mr. Wright, rise?

Mr. J. L. WRIGHT. Mr. Speaker, many of us, or some of us, including myself, do not know what a ferret or a fitch is or what the purpose of them is.

The SPEAKER. You are joking. You do not understand the difference between a ferret and a fitch?

Mr. J. L. WRIGHT. No, sir, I do not.

The SPEAKER. Oh my. I thought all of us knew that.

Mr. J. L. WRIGHT. Is it possible for somebody in the House to educate the rest of us?

VOTE STRICKEN

The SPEAKER. For that purpose the Chair will indeed strike the board, because the Chair was under the impression that every single living soul understood ferrets and fitches.

The clerk will strike the board for the purpose of us ignorami who do not understand ferrets and fitches.

We recognize the learned gentleman from Centre, Mr. Letterman, who understands ferrets and fitches.

Mr. LETTERMAN. Thank you, Mr. Speaker.

It is a European skunk. They are both out of the European skunk family.

The idea of the whole bill is, right now if you purchase one of these, which they are selling quite a few of in Pennsylvania, you have to buy a \$10 permit to have them. The Game Commission cannot keep up to it and does not want the permit on at all. All we would be doing is taking the permit off.

I went and bought one of these animals just to make sure of what I was doing. I will guarantee you one thing: they are a lot of fun. Do not let them bite you; they bite quite hard, and you cannot train them. But the idea is to take the license off because the Game Commission no longer desires to keep that on.

The SPEAKER. The Chair thanks the gentleman.

Does the gentleman from Philadelphia want to talk about ferrets or fitches or both?

Mr. RAPPAPORT. Yes, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman, Mr. Rappaport.

Mr. RAPPAPORT. Mr. Speaker, I ordinarily follow the lead of my good friend, the chairman of the Fish and Game Committee, on these types of bills. However, I wonder, Mr. Speaker, is the gentleman asking this General Assembly to go on record as favoring the free importation of European skunks into this Commonwealth? If that is his position, so be it, but I am just curious.

The SPEAKER. Will the gentleman, Mr. Letterman, explain to the House whether or not he is for or against skunks?

Mr. RAPPAPORT. Particularly European skunks, Mr. Speaker.

Mr. LETTERMAN. Mr. Speaker, the raising of these animals and domesticating them has become a very big business in the State of Pennsylvania. We have one person who has a mink farm. They raise these to sell in the off-season when they are not killing the mink, and they are selling quite a few. There are about 7,500 of them purchased a year in the State. They are domesticated. They can make good pets for you. I do not know what else to say.

No, they are not imported, Mr. Speaker. They are raised right here. The reason for the license in the old days was we used to use them to hunt rabbits, and the Game Commission felt at that time that you had to license them, but that is also a no-no. You are not allowed to hunt with them in any way and you are not allowed to turn these animals loose in any way in the State of Pennsylvania.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Rappaport.

Mr. RAPPAPORT. Mr. Speaker, I thank the gentleman for his usual cogent explanation on these bills about which I know very little, and based on that, I intend to vote for the bill.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

STATEMENT BY MISS SIRIANNI

The SPEAKER. The Chair recognizes at this time the lady from Susquehanna, Miss Sirianni. For what purpose does the lady rise?

Miss SIRIANNI. Mr. Speaker, I would like to make a statement and a request.

The SPEAKER. The lady is recognized under unanimous consent. The Chair hears no objection. The lady may proceed.

Miss SIRIANNI. Mr. Speaker, I would please ask for the attention of all the members.

Mr. Speaker, Madalyn O'Hair, an atheist, has petitioned the Federal Communications Commission in Washington for a hearing, because she wants to remove all types of religious programs from the air and from television and she wants to stop Christmas programs in the schools and the singing of Christmas carols. In order to combat this, they need 1 million letters in Washington. I have typed a letter with the number of her petition on it. I have typed a letter, and I have placed it on the front desk. BILLS ON THIRD CONSIDERATION CONTINUED

The House proceeded to third consideration of SB 206, PN 980, entitled:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, permitting the use and possession of blackjacks by police officers, sheriffs and deputy sheriffs.

On the question recurring,

Will the House agree to the bill on third consideration as amended?

Mr. WOGAN offered the following amendments No. A2244:

Amend Title, page 1, line 2, by inserting after "Statutes," further providing for prohibited offensive weapons; and

Amend Sec. 1, page 1, line 7, by striking out "by adding a subsection"

Amend Sec. 1 (Sec. 908), page 1, line 9, by striking out all of said line and inserting

(a) Offense defined.—A person commits a misdemeanor of the first degree if, except as authorized by law, he makes repairs, sells, or otherwise deals in, uses, or possesses any offensive weapon.

(b) [Exception.—] Exceptions.—

(1) It is a defense under this section for the defendant to prove by a preponderance of evidence that he possessed or dealt with the weapon solely as a curio or in a dramatic performance, or that he possessed it briefly in consequence of having found it or taken it from an aggressor, or under circumstances similarly negativing any intent or likelihood that the weapon would be used unlawfully.

(2) This section does not apply to forensic firearms experts or forensic firearms laboratories operating in the ordinary course of business and engaged in lawful operation.

(c) Definition.—As used in this section "offensive weapon" means any bomb, grenade, machine gun, sawed-off shotgun, firearm specially made or specially adapted for concealment or silent discharge, any blackjack, sandbag, metal knuckles, dagger, knife, razor or cutting instrument, the blade of which is exposed in an automatic way by switch, push-button, spring mechanism, or otherwise, or other implement for the infliction of serious bodily injury which serves no common lawful purpose.

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. Wogan.

Mr. WOGAN. Thank you, Mr. Speaker.

Mr. Speaker, this amendment would do a very simple thing. Presently, because of a decision which has come out of Delaware County, the Vink decision, there is some question as to the legality of independent forensic firearms experts and their operations. Of course, no one disputes the fact that various police departments around the Commonwealth can run forensic tests, but because it may be illegal for independent firearms experts to possess certain weapons, they cannot ply their trade. This would enable them to keep these what they call reference weapons and operate and testify in court on an equal basis with police witnesses.

The SPEAKER. The Chair thanks the gentleman.

No physician, nurse or technician or hospital employing such physician, nurse or technician may administratively refuse to perform such tests and provide the results to the police officer except as may be reasonably expected from unusual circumstances that pertain at the time the request is made.

Section 4. Section 3755(b) of Title 75 is amended to read:

(b) Immunity from civil or criminal liability.-No physician, nurse or technician or hospital employing such physician, nurse or technician and no other employer of such physician, nurse or technician shall be civilly or criminally liable for [properly] withdrawing blood or obtaining a urine sample and reporting test results to the police pursuant to this section or for performing any other duty imposed by this section. No physician, nurse or technician or hospital employing such physician, nurse or technician may administratively refuse to perform such tests and provide the results to the police officer except as may be rea-

sonably expected from unusual circumstances that pertain at the time of admission.

Section 5. (a) Section 1 of this act shall take effect immediately.

(b) Section 2 of this act shall take effect immediately and shall be retroactive to January 14, 1983.

(c) Section 3 of this act shall take effect in 120 days and shall expire four years from its effective date.

Mr. GREENWOOD. Thank you, Mr. Speaker.

This amendment amends the drunk driving portion of the Vehicle Code. Under that existing law, a technician at a hospital, a nurse, a physician, is required to perform a bloodalcohol content test on any victim of an accident where there is probable cause that that victim may have been operating a car, an automobile, or a vehicle under the influence of alcohol.

Current law also provides immunity from civil liability for those physicians and nurses, but it does not provide criminal liability. This amendment simply provides criminal liability and would not allow an individual who has been so tested to file criminal charges, such as assault and battery, against the nurse or physician. I would ask for the House's support.

Mr. HALUSKA. Mr. Speaker, the reason for this resolution is that it had been called to my attention by one of the community colleges in my respective district that they were offering a semester of free courses for the unemployed people in our severely distressed legislative district with a high unemployment of about 24 percent. They found when the people on unemployment came to register for these courses and pursue them, they became interested and wanted to register for a full-time course.

Unfortunately, under our present law or regulations by the Department of Labor and Industry, this is not permissible in Pennsylvania in spite of the fact there are numerous States throughout the country that permit our unemployed to pursue courses of study for retraining on a full-time basis. So the intent here is to have our Labor Committee meet with Labor and Industry to resolve this issue to permit our unemployed to take full-time courses for retraining purposes, especially in those cases where they do not foresee full-time employment in the future in their present employment.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Chester, Mr. Pitts.

Mr. PITTS. Thank you, Mr. Speaker.

On the resolution, after reading it, I see no major problem with the resolution. I think perhaps this is an area that the Labor Relations Committee ought to investigate, because with the new JTPA (Job Training Partnership Act), we are going to have to get into this matter of retraining and what the approved programs are in order to draw UC (unemployment compensation) and still be in the retraining program.

The only issue that I might raise for the members is, I am not certain, after looking into Mr. Haluska's situation, that the department has made a determination contrary to this section of the law, as the resolution states. With that reservation as to the wording of the resolution, I intend to support HR 40. Thank you, Mr. Speaker.

Mr. CLARK. Thank you, Mr. Speaker.

I introduced this resolution because of a result of some investigation during the Appropriation hearings this spring. I learned that the Department of General Services has been abolishing the position of police officer throughout the Capitol Police Department and replacing that position with one known as a security officer and that what we were doing was going from a force that was capable of making arrests and halting criminal activities and protecting the buildings to merely caretakers in each building. I am sure you are familiar with the function of the security officers in each building they provide for signing in and signing out, and that is about their only function. But the police officers were able to make arrests and stop offenses from being committed, as well as protecting the property of the taxpayers. As an example, in 1982 the Capitol Police answered 301 criminal complaints, 483 incidents involving the police, they assisted the Harrisburg Police on 44 occasions, and handled juvenile complaints on 31 occasions.

What I am asking in the resolution is that we establish a complement of what is needed to protect the facilities as well as the employees of the Commonwealth, and that would be done by the State Government Committee. I would urge an affirmative vote on the resolution.

Mr. WAMBACH. Mr. Speaker, I urge all my colleagues, just as Representative Clark had indicated, to support HR 105.

In the last 5 or 6 years the Department of General Services, through its Capitol Police force, had a decrease of almost 50 police officers from, I believe, 137 in 1978 to about 87 today. I think for the safety of all the employees in the Capito Complex— Just over the weekend I attempted to get into m office, and I was told that there were only three police officer who were on the street that day as far as walking is concerned One was located in the Finance Building, due to the Treasury one was located in the PennDOT building, due to the mone in that situation; and one was at the front desk of the Mai Capitol Building. I think that is inefficient for a weekenoperation when our tourists are coming in. I think it is highly inadequate on the night shifts when we are here late and our secretaries and our staff must find ways to their car, as far as the darkness of night is concerned and for their own safety. I would ask all the members to support HR 105 to really get to the bottom of the fact that our police officers are being replaced by security personnel who are unarmed, et cetera. So I would ask all the members to support HR 105.
