### STATEMENT BY MR. WAMBACH

The SPEAKER. The Chair recognizes the gentleman from Dauphin, Mr. Wambach.

Mr. WAMBACH. Mr. Speaker, I would like to make a short statement on a bill I am about to introduce.

The SPEAKER. The gentleman is in order and may proceed.

Mr. WAMBACH. Thank you, Mr. Speaker.

Mr. Speaker, I would just like to have your attention for a minute to describe a bill I am about to introduce. The bill itself would increase the emergency tax on liquor by 2 percent and provide that money earmarked specifically for alcohol and drug treatment centers across this Commonwealth.

With the decrease in Federal dollars that will be coming into this State to the tune of about \$3 million in the treatment field and with the awareness that is being brought about through the "Chemical People" project through the public television networks, obviously the need for treatment dollars will increase. This bill would raise those needed moneys without affecting the General Fund revenues currently being derived from the Liquor Control Board sales, and it does it by simply increasing the emergency tax on liquor by 2 percent.

I am going to leave the bill on the bill clerk's desk for further sponsors. I have a great many now, and I would appreciate your consideration to become a cosponsor. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

### MAYOR-ELECT OF PHILADELPHIA PRESENTED

The SPEAKER. The Chair is delighted to present to the hall of the House, as the guest of the Philadelphia delegation, the mayor-elect of the largest city in the Commonwealth of Pennsylvania, the Honorable Wilson Goode.

Mr. GOODE. Mr. Speaker, members of the House, I want to thank the Speaker for the opportunity to say a few words to all of you this morning. I have had a chance this morning, as I did back in June, to come here and to meet with many of you in small groups to discuss with you some concerns which I have; to listen to concerns that you have; to try and forge, if we can, open lines of communication; to recognize that we all are part of a State, that somehow as goes the State of Pennsylvania, so will go the individual areas that we all represent.

I am here to really say three things to you. Number one, I thank all of you for your cooperation with me while I have been here today and will be here throughout the day. Thank you for making yourselves available. I thank the Speaker for having me come here and spend these few minutes with you. I intend to come back, come back and to let you know in very clear terms my support for the entire State of Pennsylvania and my interest in making sure that the city which I represent is a vital part of this State and in fact that we communicate with all of you around those concerns.

The second thing I want to say is that we have to more and more communicate around our common interests, our common concerns, and our common problems. I am here today to do that, to open up my heart and my mind and say that I believe that all of us can share our own interests. We also can in a real way make sure we serve our mutual interests by opening up the lines of communication.

My third and final point is that I believe that the problems that we are faced with in this State - joblessness, problems of crime, problems of those persons who cannot afford to pay their way - can be solved if we find a way to begin to put those interests forth in a very common kind of way.

I am not here to make a big speech to all of you, but I intend to do two things in our city: I intend to run that city in an efficient, cost-effective way. I intend to improve the image facing our city. I intend to have all of you from around the

State look toward Philadelphia as a model, not only for Pennsylvania but for this country and indeed for this world, because I believe the best way that I can help you help me and help our citizens in our city is to do an outstanding job in managing the tax resources within a city, and I intend indeed to do that.

Secondly, Philadelphia is indeed a critical part of the State. We are indeed the largest urban area in Pennsylvania, and somehow, unless Philadelphia is strong, the State may in fact be somewhat weaker. But every part of the State is important, and therefore the rural, the suburban, and the urban areas must see themselves working together if in fact we are going to stay strong as a State.

Someone asked me this morning about what I see that we can do to solve our economic problems. I said, first of all we have to change the image of Pennsylvania, because when businesses look for a State to locate, Pennsylvania is 46th on a list of 48 or 49 or 50, and we have to change that. The east and the west and the northeast and the central and all parts of our State must indeed work together to bring that about, because unless people come to Pennsylvania, none of us, whether we be rural or suburban or urban, can in fact profit therefrom.

I am delighted to be here. I am glad I won. I intend to come back. I intend to be a part of this State. I intend to be a voice of reason, a voice of cooperation, a voice of communication, and a voice that will work to try and build a strong city, strong regions in our State, and a strong Pennsylvania. Thank you all very much. Thank you, Mr. Speaker. I am glad to be here.

The SPEAKER, Thank you very much, Mr. Mayor.

All of us in our school days learned of the importance of one city in the Colonies, and that city was Philadelphia. All of us learned where the Liberty Bell was deposited. Sometimes in modern times we forget the greatness of the city of Philadelphia, and I want to assure the mayor that on both sides of the aisle, the men and women who are seated in this House understand that Philadelphia is a part of the Commonwealth, and that as the Commonwealth prospers, so will Philadelphia, and as Philadelphia prospers, so will the Commonwealth. I have told them that we have our differences, and indeed we do, but we are intelligent human beings on both sides of the aisle and we are capable of recognizing those differences and minimizing them. I want to congratulate him on taking on a job which is one of the most strenuous in the United States of America and to pledge to him publicly that I will support him in every effort that he makes to improve the city of Philadelphia and the Commonwealth of Pennsylvania.

An Act amending the "Local Economic Revitalization Tax Assistance Act," approved December 1, 1977 (P. L. 237, No. 76), further defining the term "improvement."

On the question,

Will the House agree to the bill on third consideration?

Mr. HALUSKA offered the following amendments No. A3890:

Amend Title, page 1, line 6, by striking out ""improvement." and inserting

"improvement"; and imposing a limitation on the tax reduction.

Amend Sec. 1, page 1, line 9, by striking out "section 3" and inserting

sections 3 and 5(a)

Amend Sec. 1, page 1, line 11, by striking out "is" and inserting

Amend Sec. 1, page 2, by inserting between lines 9 and 10 Section 5. Exemption schedule.

- (a) (1) A local taxing authority granting a tax exemption pursuant to the provisions of this act may provide for tax exemption on the assessment attributable to the actual cost of improvements or up to any maximum cost uniformly established by the municipal governing body. Such maximum cost shall uniformly apply to all eligible deteriorated property within the local taxing authority jurisdiction.
- (2) A local taxing authority granting a tax exemption pursuant to the provisions of this act for new construction of industrial, commercial or business property may provide for tax exemption of up to 50% of the assessment attributable to the actual costs of the new construction of industrial, commercial or business property or up to any maximum cost not in excess of 50% uniformity established by the municipal governing body. Such maximum cost shall uniformly apply to all eligible property within the local taxing authority jurisdiction.

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from Cambria, Mr. Haluska.

Mr. HALUSKA. Mr. Speaker, this amendment is intended to preserve the intent of the original revitalization act for restoring properties in the various portions of the Commonwealth by giving tax incentives for improvements. Without this amendment we would literally destroy the act as it is intended, because basically at this point we do not give tax credits to the entire property that is being revitalized. We only give the tax incentive to that portion of the property that is reconstructed, and that incentive is divided over a period of 10 years. What this amendment does is to just state that any new construction, that 50 percent of it would be retained in the original tax base and 50 percent of the new construction would be placed on the 10-year plan, similar to the revitalization act for used buildings that are reconstructed.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Washington, Mr. Daley.

Mr. DALEY. Mr. Speaker, I support the Haluska amendment and ask the members to support it also.

# CALENDAR CONTINUED BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 286**, **PN 2122**, entitled:

An Act amending the "Public School Code of 1949," approved March 10, 1949 (P. L. 30, No. 14), further providing for the attire for students and for a discipline code.

On the question,

Will the House agree to the bill on third consideration?

Mrs. HARPER offered the following amendment No. A4104:

Amend Sec. 1 (Sec. 1317.1), page 2, line 6, by inserting after "STUDENTS."

If the board of school directors does adopt a discipline code, such code shall require teachers to notify a parent or guardian by letter or, if possible, by telephone, if they are having a discipline problem with the parent's or guardian's child prior to any formal action by the board of school directors.

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the lady from Philadelphia, Mrs. Harper.

Mrs. HARPER. Thank you, Mr. Speaker.

This amendment amends section 1317, page 2, line 6, by inserting after "students," "If the board of school directors does adopt a discipline code, such code shall require teachers to notify a parent or guardian by letter or, if possible, by telephone if they are having a discipline problem with the parent's or guardian's child prior to any formal action by the board of school directors." Some teachers are suspending students without notifying the parent or guardian. If they will notify the parents, this will be better for the students and the teachers. Some of these problems can be worked out without suspending the student, and that is the purpose for this amendment.

The SPEAKER. The Chair thanks the lady.

On the adoption of the Harper amendment, the Chair recognizes the gentleman from Berks, Mr. Davies.

Mr. DAVIES. Mr. Speaker, I rise to oppose the Harper amendment, even though it may be stated as a "may" provision, simply on the grounds that the courts have established over the many years that the matter of dress has been established as a matter of nothing more than an extension of the freedom-of-speech concept that we have inculcated into the Constitution of the United States and the other aspects of it, as I understand. If I do not understand the lady's amendment, I will be glad to place a question about the amendment, because I do not have the amendment in front of me.

The SPEAKER. The lady, Mrs. Harper, indicates she will stand for interrogation. The gentleman, Mr. Davies, is in order and may proceed.

Will the pages make sure that Mr. Davies has a copy of the amendment.

Mrs. HARPER. Mr. Speaker, this amendment does not have anything to do with the dress code. This is just an

amendment stating that the teachers should notify the parent or guardian if they are having a problem with a child. This only is a part of the discipline code, not the dress code.

Mr. DAVIES. I see. All right. May I ask the lady one or two questions?

The SPEAKER. The lady has indicated she will stand for interrogation. The gentleman is in order and may proceed.

Mr. DAVIES. As far as the "may" provisions for the disciplinary code under this amendment, Mr. Speaker, this letter or phone call, must it have some kind of formalized receipt so that there is no chance that this goes awry and that those involved are properly informed or there is that kind of guarantee of due process involved in this?

Mrs. HARPER. Mr. Speaker, this is just an attempt to bring the teacher and the parent closer together in trying to work out the problem with the student. It will certainly be a help to the student as well as the teacher to work out this discipline code, and it is just a matter of notifying the parent. I am sure for a lot of parents— In fact, I spoke with a number of parents, and they were so surprised to have their students suspended without even hearing anything from the teachers, so the teachers should at least notify the parents and let them know that they are having a discipline problem. This will help the teacher as well as the student. It is not mandatory, but it certainly should be done.

Mr. DAVIES. All right. Now, Mr. Speaker, the second question is, is there going to be required of this a proper notification of the administrators involved in that particular area of administration so that it is not just the parent, that there is a proper notification and that this is a matter of record within the school district as well?

Mrs. HARPER. Yes. This notification can go out from the school directors or the teacher. It is just a matter of sending a letter or a telephone call.

Mr. DAVIES. All right. And even though that is not stated in the amendment per se of A4104, is that just a matter of your assuming that that will be done, or just what kind of guarantee is established in that process?

Mrs. HARPER. That is established in the bill, that the school administrators will oversee that procedure.

Mr. DAVIES. In other words, Mr. Speaker, that would be a continuation of part of that "may" provision. Is that right?

Mrs. HARPER. That is correct.

Mr. DAVIES. Thank you, Mr. Speaker.

### REPORT OF COMMITTEE OF CONFERENCE CONSIDERED

Mr. DAWIDA called up for consideration the following Report of the Committee of Conference on HB 379, PN 2035, entitled:

An Act providing for the licensing and regulating of public adjusters and public adjuster solicitors.

On the question,

Will the House adopt the report of the committee of conference?

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Dawida.

Mr. DAWIDA. Mr. Speaker, I urge a "yes" vote on the conference report. This bill passed the House 198 to nothing; it passed the Senate 49 to 1; and then it was signed by all six conferees. The changes that were made were basically tinkering with a bill that deals with a very small area of insurance. I think that we have reached a fair consensus among all parties, and I urge a "yes" vote.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from York, Mr. Dorr.

Mr. DORR. Mr. Speaker, will the gentleman from Alle gheny, Mr. Dawida, submit to interrogation?

The SPEAKER. The gentleman, Mr. Dawida, indicates he will stand for interrogation. The gentleman, Mr. Dorr, is in order and may proceed.

Mr. DORR. Mr. Speaker, would the gentleman indicate whether or not this bill contains a sunset provision?

Mr. DAWIDA. No; none of us thought that this was the appropriate kind of legislation for that.

Mr. DORR. May I make brief remarks, Mr. Speaker?

The SPEAKER. The gentleman is in order and may proceed.

Mr. DORR. Mr. Speaker, I apologize to the gentleman from Allegheny and the other supporters of this bill for not being more on top of this earlier, but I think that this is exactly the kind of legislation in which we ought to have a sunset provision. We are going through, as everyone well knows, a very extensive process regarding sunset at this time with regard to most licensing laws. This particular bill, while it does not in effect create a licensing law, because as I understand it there is present law on the books, in fact it is the establishment of an extensive licensing process, and I would recommend that we send it back to conference for the insertion of a sunset provision.

The gentleman and others know that I am not an advocate of extending our licensing laws in this Commonwealth generally, but I really do not have any strong objection to this particular bill if we can just do that. But I do think it is important to insert the sunset provision in this bill, and I would therefore recommend that we vote in the negative, just for that strict purpose of making that one editorial change. Again, I apologize for being late in the process.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Allegheny, Mr. Dawida.

Mr. DAWIDA. As Mr. Dorr knows, I am less an advocate of licensing than even he is, having had a bill for the last 4 years before that committee which I think would strengthen our hold over how we do licensing. However, this particular thing really is not an appropriate sunset vehicle. It is a very, very small area with 181 licensed adjusters. The group b been licensed. We are not changing anything in the way that done. What we are doing, though, is tightening up some loopholes where consumers were being ripped off.

We worked 2 years on this bill, and I think it is in shape right now to be passed. I would urge a "yes" vote.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Bucks, Mr. Reinard.

Mr. REINARD. Thank you, Mr. Speaker.

Should the bill be here as we hope it will be from the Senate at that time, I do not envision any extended debate, and we ought to be able to conclude our business for the day rather quickly.

Mr. Speaker, unless there are other announcements, I would ask that the Democrats report to caucus immediately upon the call of the recess and the recess, Mr. Speaker, be until 4 o'clock. I imagine the Republicans— Mr. Noye can announce his caucus.
