The SPEAKER. The Chair recognizes the gentleman from Centre, Mr. Letterman.

Mr. LETTERMAN. Thank you, Mr. Speaker.

Mr. Speaker, this just puts the total feet in body length to 72 feet on a mobile home and extends to 14 feet 6 inches in width or 14 feet 6 inches in height.

The SPEAKER. The Chair thanks the gentleman.

On the amendment, the Chair recognizes the gentleman from Westmoreland, Mr. Petrarca.

Mr. PETRARCA. Mr. Speaker, it is an agreed-to amendment. When the bill was drawn up at Legislative Reference, we felt that the language was in the bill, but there was a discrepancy between two attorneys, so Representative Letterman cleaned up the language. We accept the amendment.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Indiana, Mr. Wass.

Mr. WASS. Mr. Speaker, may I interrogate Mr. Petrarca?

Mr. PETRARCA. Yes, Mr. Speaker.

The SPEAKER. Mr. Petrarca indicates he will stand for interrogation. The gentleman, Mr. Wass, is in order and may proceed.

Mr. WASS. Mr. Speaker, if I may, body length, does that include the hitch?

Mr. PETRARCA. That was a problem we had, Mr. Speaker. When we said 70 feet before, PennDOT felt that 70 feet was within the axle and the tractor combined. What we did was put the 70 feet now to 72 feet with Representative Hasay's amendment, and the tractor-trailer is excluded. It is 72 feet excluding the tractor-trailer.

Mr. WASS. If I may, Mr. Speaker, I am trying to find out if the 72 feet includes the hitch. There is about 6 feet of hitch.

Mr. PETRARCA. It does not include the hitch. It is just like it is right now. On the 70 feet tractor-trailer you have now, is the hitch included? It is identical to that except we added the 2 feet.

Mr. WASS. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Berks, Mr. Davies.

Mr. DAVIES. Mr. Speaker, would the sponsor stand for a few questions of interrogation?

Mr. PETRARCA. Yes, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Davies, has been recognized.

Mr. DAVIES. Mr. Speaker, what is the status of this amendment as to what is the current height, for example? This, as I understand, will go to 16 feet 6 inches. Is that correct? Or what was the height that he stated?

Mr. LETTERMAN. Mr. Speaker, may I answer that?

The SPEAKER. If the gentleman, Mr. Petrarca, will yield.

Mr. PETRARCA. It is Mr. Letterman's amendment.

The SPEAKER. The gentleman, Mr. Petrarca, yields to the gentleman, Mr. Letterman.

Mr. LETTERMAN. Mr. Speaker, this is an increase of 6 inches.

Mr. DAVIES. To what height, sir?

Mr. LETTERMAN. It is 14 feet 6 inches, not 16 feet 6 inches. It is 14 feet 6 inches.

Mr. DAVIES. Mr. Speaker, what are most of the current bridge clearances on the interstate?

Mr. LETTERMAN. For height, you mean?

Mr. DAVIES. Yes, Mr. Speaker.

Mr. LETTERMAN. Most of them are 14 feet 8 inches. Very few are under that. There are some on back roads that are like that but none on transporting roads.

Mr. DAVIES. The only comment I would have, sir, is it seems then as if my district is the only one that has the exception, because on some of the interstates I have, there are those that are below that height level. That is why I have a grave concern about this increase. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Centre, Mr. Letterman, for the second time on the amendment.

Mr. LETTERMAN. This is only added on width; it is not added on height.

Well, if the gentleman is satisfied, I would like to have the bill run, please.

The SPEAKER. On the amendment, the Chair recognizes the gentleman from Luzerne, Mr. Hasay.

Mr. HASAY. Thank you, Mr. Speaker.

I would appreciate that the House support this amendment. Any of you legislators who are here today who have any mobile home manufacturers in your legislative districts have requested this amendment. This amendment passed the House in December in the late night hours, and because of attorney discrepancies, we now have to offer the amendment again.

Again, I request your support. It is for the mobile home trailer manufacturing organizations in Pennsylvania. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes, for the second time on the amendment, the gentleman from Berks, Mr. Davies.

Mr. DAVIES. I withdraw my concern. I have just been assured that there was no increase in the height, so I withdraw that concern.

The SPEAKER. The Chair thanks the gentleman.

BILLS ON THIRD CONSIDERATION CONTINUED

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing that certain vehicles carrying hazardous materials stop at all railroad crossings.

Mr. Speaker, I would just like to explain for the record that while this bill on its surface appears to be something which is going to result in fewer accidents involving hazardous materials and I certainly support that, as I understand it, it is going to require hazardous material haulers to stop at railroad crossings even though that railroad crossing is otherwise protected with flashing lights or with gates. This, in my district and on a highway which is one which is much traversed by hazardous haulers, is likely to result in more acci-

dents and rear-end collisions. For that reason, Mr. Speaker, I intend to vote against this bill. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
