To the Honorable, the House of Representatives of the Commonwealth of Pennsylvania

I have the honor to inform you that I have this day approved and signed House Bill 682, Printer's No. 2334, entitled "AN ACT amending the act of April 9, 1929 (P. L. 177, No. 175), entitled 'An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined,' further providing for gubernatorial appointments; further providing for boards of trustees of State institutions; increasing the membership on the State Board of Education and the State Veterans' Commission; establishing the Pennsylvania Academic Commission on Technological Development and providing for its powers and duties; further providing for membership on the Council of Higher Education; excluding State colleges and universities from certain requirements relating to purchases of printing supplies; imposing additional limitations relating to publications; providing for notice to certain municipalities; further providing for the powers and duties of the Department of Public Welfare; further providing for the powers and duties of the State Board of Occupational Therapy Education and Licensure; transferring certain fees to the Historical and Museum Commission; and making a repeal."

I have approved this legislation because it includes necessary and important amendments to the Administrative Code of 1929 but I have serious concerns pertaining to section eleven which must be addressed by remedial legislation. This section requires that every applicant for a Department of Environmental Resources permit relating to air quality, water allocation, water obstruction, water quality, solid waste and hazardous waste provide written notice of the permit application to the affected municipalities. The Department would be prohibited from issuing any of these permits until the municipality has been in receipt of the notice for 30 days for all permits other than solid and hazardous waste permits, which require a 60 day waiting period.

While the intent of providing affected municipalities with a time period for comment before a permit may be issued has merit, the legislation is defective because it does not provide the Department with flexibility to deal with emergencies. For example, during a drought the Department must often issue water allocation permits allowing the use of emergency alternate sources of drinking water. Similarly, water obstruction permits are often issued during floods to prevent further flooding and to clear debris immediately following a flood. Obviously, the public health and safety could be endangered if the Department of Environmental Resources was barred from issuing emergency permits in these and similar circumstances.

Despite these concerns, I am approving this legislation at this time because officials of the Department of Environmental Resources have been assured by legislative leaders that remedial legislation will be forthcoming to correct this defect prior to the effective date of this legislation. I urge the members of the General Assembly, therefore, to act promptly and expeditiously to adopt the required amendments to this legislation.

What we see happening in this State is very often many disabled veterans pass away, and as a result of their passing, the estate that they lived on is put back onto the property tax rolls, and their spouses, often living under a fixed income, very brief income, must bear the costs of those property taxes. This bill will help a small number of spouses of disabled veterans. Thank you, Mr. Speaker.

In 1950, he was judged by two hundred fifty sportswriters of The Associated Press as the greatest world swimmer in the first half of the twentieth century. Throughout his service to sports, and later during his career as an actor of note, John Weissmuller conducted himself in accordance with principles which inspired and guided his fellowman. As an American, he reflected qualities of patriotism and citizen conduct which were of great worth and credit to his native Commonwealth of Pennsylvania and his beloved United States of America; now therefore be it
