Mr. DUFFY. Thank you, Mr. Speaker.

Under this bill, the people who provide the services are well taken care of. What I would like to do is try to protect the people who come in and buy these life care units for \$60,000, 70,000. I would like to see them protected. Under this amendment it gives them reasonable means to proceed to protect their own interest.

The SPEAKER. The Chair thanks the gentleman.

The question is on the Duffy amendment, and the Chair recognizes the gentleman from Montgomery, Mr. Hoeffel.

Mr. HOEFFEL. Thank you, Mr. Speaker.

I rise in opposition to this amendment, Mr. Speaker. SB 455, which is before us, would regulate the life care industry. This bill is a Senate bill. It is similar to legislation that I have worked on and Representative Lashinger has worked on here in the House for 4 years. We believe that the bill is in very good shape as it is now. It needs a couple of technical amendments, but this amendment and some others to be offered by Mr. Duffy I must oppose.

This amendment, 0611, would change the purpose clause of the legislation and would refer to the residents of these life care communities as resident-investors. Well, in fact, they are not investors in the traditional sense of the word. These are not cooperative corporations or mutual corporations; dividends are not paid. The residents are actually purchasing a service; they are consumers purchasing a life care contract through their initial investment. The language here, "resident-investor," included in the Duffy amendment is not appropriate for these facilities, and it is appropriate for the control of these facilities to be in the hands of boards of directors. The Duffy amendment, this and others to follow, would challenge that assumption that the facilities should be under the control of a board of directors.

I would ask for a negative vote on this amendment. The SPEAKER. The Chair thanks the gentleman. On the Duffy amendment, the Chair recognizes the gentleman from Montgomery, Mr. Godshall.

Mr. GODSHALL. On the Duffy amendment to SB 455, I concur with Representative Hoeffel. This bill was worked out after a series of public meetings held in southeastern Pennsylvania. I was part of a number of those meetings.

SB 455, as I said yesterday in the Republican caucus, I believe is something that the nursing homes and long-term care facilities can live with. It also protects the residents.

I would appreciate a "no" vote on the Duffy amendment. Thank you.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Duffy, for the second time on the amendment

Mr. DUFFY. I would just like to say that I have talked to the residents of one of the homes in my area, and they seem to think that they need the protection. They are consumers, and when they come up with \$50,000, \$60,000, or \$70,000, I think they should have some say on how the place is run.

I would like a "yes" vote on this amendment. Thank you.

The SPEAKER. The Chair recognizes the gentleman from Montgomery, Mr. Saurman, on the amendment.

Mr. SAURMAN. Mr. Speaker, thank you.

I would also like to add to the opposition to this amendment.

I have five long-term life care facilities in my district. During the last session, we met regularly to discuss a House bill and a Senate bill which were then being proposed. Those residents are aware of this legislation, in the form that it is presented, as a compromise. If we do anything to it, it is likely that they will not again be able to enjoy the protection to which they are looking forward.

I would ask that we vote against all amendments and maintain this bill in the form in which it came from committee. Thank you.

So what we would like to say is that if this does come about, some interested party could request the reasons in writing and possibly go to court to get this determination, and not just leave it to be a one-sided affair.

The Chair recognizes the gentleman from Montgomery, Mr. Hoeffel.

Mr. HOEFFEL. Thank you, Mr. Speaker.

I rise in opposition to this amendment. This is a substantive amendment that I believe poses a real threat to the safety of other residents of life care facilities. The bill as written would permit the termination of residency contracts for just cause, defining that as a good-faith determination in writing made by the medical director and the administrator of the facility that the resident is a danger to himself or to others. Mr. Duffy would add to that that such a termination could not occur, the resident could not be removed, until a court review is held.

That is time consuming; it is cumbersome; it could pose a threat to the safety of other residents. If the medical director and administrator feel—and in writing they are willing to say—that they have just cause to believe someone is a threat, I believe that person should be removed. He still has legal recourse, but we should allow these facilities to act without waiting for a court review to remove potential threats from the residential environment.

I would ask for a negative vote.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Montgomery, Mr. Godshall.

Mr. GODSHALL. Again concurring with Representative Hoeffel, I also ask for a negative vote on this amendment.

For what purpose does the gentleman from Indiana, Mr. Wass, rise?

Mr. WASS. Mr. Speaker, I would like to interrogate Representative Itkin.

The SPEAKER. On final passage?

Mr. WASS. On final passage.

The SPEAKER. On final passage, the Chair recognizes the gentleman, Mr. Wass, who indicates he wishes to interrogate Mr. Itkin, who indicates that he will stand for interrogation. Mr. Wass is in order and he may proceed.

Mr. WASS. Mr. Speaker, it has been called to my attention by a builder in my district that the additional fees are already being charged in R-3 from \$5 to \$10. Are they now collecting that additional fund?

Mr. ITKIN. Yes.

Mr. WASS. Then they are doing that before the fact?

Mr. ITKIN. I believe the law provides that the department may set reasonable fees in this regard. Set in the law was a \$5 fee. Because of the number of submissions by the builders, it has not been sufficient to carry out the administrative costs of the program, and the Department of Community Affairs has raised it from \$5 to \$10.

Mr. WASS. Mr. Speaker, can you tell me when they raised it?

Mr. ITKIN. I believe it was last year.

Mr. WASS. Last year. And now we are putting it into law?

Mr. ITKIN. No.

Mr. WASS. Is it in the bill?

Mr. ITKIN. Yes; that is right. You are quite correct. We are putting it in the law.

Mr. WASS. Mr. Speaker, further: In the area where we do not have an architect's plan or a designer's plan, is it true that the builder is responsible for the building?

Mr. ITKIN. That is correct.

Mr. WASS. Mr. Speaker, I was hoping that you would say no, he was not, but you are telling me that he is. The builder is responsible for the building even though he is being told by the owner how he is to build it? Mr. ITKIN. If there is no licensed design professional retained during the construction period, then current law charges the builder or the owner, if he is the builder, with the responsibility to certify that the building was constructed in accordance with the act.

Mr. WASS. Under those conditions then, a builder would have to refuse the owner's wishes on how the home is to be built to protect himself. Is that right?

Mr. ITKIN. Under certain circumstances, if the owner insisted that the building was to be constructed with inferior standards, the builder could be put in that position. However, I would like to put it in the proper perspective. The builder certifies to the owner that he warrants to the owner that these conditions have been met. The owner has the right to waive the certification, and so if the owner, for example, decides he does not want this building constructed to the conservation levels required in the act, he may do so by waiving the warranty that he is required to receive under the law.

Mr. WASS. The owner is to receive a warranty from the builder?

Mr. lTKIN. That is correct.

Mr. WASS. And under these conditions the builder could protect himself if he asks for a waiver?

Mr. ITKIN. If the owner does not want the building constructed to the BECA standards, he may tell the builder that he will waive the warranty.

Mr. WASS. I have no further questions, Mr. Speaker. Thank you.

On the question recurring, Shall the bill pass finally?

The SPEAKER. The Chair recognizes the minority whip.

Mr. HAYES. Mr. Speaker, may I interrogate Mr. McMonagle?

The SPEAKER. Mr. McMonagle indicates he will stand for interrogation. The minority whip is in order and may proceed.

Mr. HAYES. Thank you, Mr. Speaker.

Would the gentleman explain the necessity of HB 2110? As the gentleman may recall, this morning the minority leader had asked the purpose for having this appropriation framed in this manner.

Mr. McMONAGLE. Yes. We explained to the minority chairman that the engineers want to do some sites on geology and everything, and they asked for this appropriation from the bureau, and the bureau did not feel it was necessary. We asked the bureau if we could put a line item in for them to do these test sites. We felt like it was not a great amount of money, and they have over \$1 million surplus. So we felt it was proper to give them what they are asking for.

Mr. HAYES. My purpose is not to be argumentative, but would the gentleman please provide for the House information as to why the licensure board did not agree with the engineers who wanted to conduct this engineering activity, just by way of information?

Mr. McMONAGLE. The bureau felt it was not cost effective to add the sites, even though they had the surplus of over \$1 million that they could do this with, and it would be cost effective by the engineers. The actual cost would only be a couple thousand dollars to do the additional sites.

Mr. HAYES. Does the gentleman believe that it would be cost effective, regardless of what the professional licensure board thought and believed? And if so, would you provide us with the justification for your point of view?

Mr. McMONAGLE. This would allow the students who are taking the tests for licensure to take them at local sites rather than at great expense through sites at the other end of the State or somewhere.

Mr. HAYES. Where is the test site at the present time?

Mr. McMONAGLE. There are six of them currently throughout the State. I do not have the list with me, Mr. Speaker, but they are mostly in the center part of the State, the different areas, and this would allow them to spread a little bit more throughout the State. There are six sites presently.

Mr. HAYES. There are six test sites presently, and by making this type of appropriation there would be additional sites?

Mr. McMONAGLE. Yes, Mr. Speaker.

Mr. HAYES. Where would the additional sites be? In other words, what areas would be better served than they are currently at the present time?

Mr. McMONAGLE. The test sites will be at the engineering schools where the students are right now rather than having

them travel to another school to take the test. This would be at their own schools.
