Can the gentleman give us an estimate of how long this caucus will last?

Mr. SWEET. Mr. Speaker, I apologize for the delay. This was an amendment that was added in the Education Committee, and I am consulting to make sure that the answer we give you is the correct one.

Mr. HALUSKA. Are you going to respond to that, Mr. Speaker?

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Sweet.

Mr. SWEET. I am sorry, Mr. Speaker. I thought it had been explained to you. I yield to Mr. Burns.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Bucks, Mr. Burns.

Mr. BURNS. What this amendment that was put in in the Education Committee does is simply try to straighten out the numbers of people for whom a school district is reimbursed. There are many school districts in the State where they cross over into post offices, not necessarily municipalities. For example, in Bucks County we have the Pennsbury School District, which crosses over into the Morrisville Post Office. In addition, there is the Morrisville School District and the Morrisville Borough, which is a municipality. This has nothing to do with the municipalities, and that is basically what the amendment says. It does not affect municipalities. It only affects those people who are legal residents of the Pennsbury School District, for example, but who physically reside in the post office designation of Morrisville, and we have tried to exempt the borough of Morrisville from any part of that, or any other borough, for example, that might come into this. I believe there is a case here in Dauphin County, Camp Hill, and so forth.

Mr. HALUSKA. Mr. Speaker, may I ask another question, please?

The SPEAKER pro tempore. If Mr. Burns has finished, yes. The Chair recognizes the gentleman, Mr. Haluska.

Mr. HALUSKA. Mr. Speaker, will the municipality be required to abide by the same disclosures that the school district presently does? Under the current law, as I understand it, only the secretary and the tax collector are permitted to see these lists. Not even a school board member is permitted to see this. Will this apply to municipalities where the council members will not see it, only the secretary and the tax collector?

Mr. BURNS. Mr. Speaker, if I might, I believe that what that amendment tries to do is prevent what you have just described happening to municipalities.

Mr. HALUSKA. Okay. Thank you.

BILLS ON THIRD CONSIDERATION CONTINUED

The House proceeded to third consideration of **HB 171, PN** 625, entitled:

An Act amending the act of March 11, 1971 (P. L. 104, No. 3), known as the "Senior Citizens Rebate and Assistance Act," increasing eligibility under the property tax or rent rebate and inflation dividend; and further providing for the allowable percentage of real property tax or rent rebate.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman from Allegheny, Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, HB 171 would increase the income eligibility limits and the amount of inflation dividends paid to senior citizens under the property tax and rent rebate program. The bill increases the maximum annual income level for senior citizens taking advantage of the program from \$11,999 per household to \$15,000 and increases the inflation dividends to \$10 for each of the three lowest income categories and \$5 for the remaining income categories. In addition, the bill establishes a \$20 inflation dividend for any new income eligibility group in the \$12,000 to \$15,000 category.

It is estimated, Mr. Speaker, that the bill will provide rebates for an additional 100,000 households across the State. Of the eligible households under the new increased income limits, it is expected that 47 percent, or 47,000 households, will apply for the rebates. The increase for this program will begin in 1986 for applications on taxes paid in 1985.

Mr. Speaker, I believe every member in this room would agree that the seniors in Pennsylvania deserve as much financial help as we can possibly give them. We have the resources to do this through the successful State lottery program which we generate in the Commonwealth of Pennsylvania and which was created for the sole purpose of helping our seniors in Pennsylvania.

Mr. Speaker, this is a nonpartisan measure, and the Governor himself advocated an increase in eligibility to the program in his 1985 budget address.

I also, Mr. Speaker, would like to read into the record a statement from the Secretary of the Treasury that states: "The Lottery is sound and will be able to support all existing programs, plus the expansion of the PACE program recently passed by the General Assembly and the Governor's proposed expansion of the Property Tax/Rent Rebate and Inflation Needs programs, so that income eligibility for these programs will extend to \$15,000."

I ask for an affirmative vote on this, Mr. Speaker. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Cumberland, Mr. Broujos.

Mr. BROUJOS. Would the speaker rise for interrogation? The SPEAKER pro tempore. The gentleman indicates he will stand for a period of interrogation. The gentleman, Mr. Broujos, is in order and may proceed.

Mr. BROUJOS. Mr. Speaker, I understand that the Secretary of Revenue at one point indicated that there were some problems with the Lottery Fund financially, and I think that Pennsylvanians are entitled to know whether there is any problem and whether now at this time we are in fact presenting a program that will create financial difficulties in the future.

Mr. DeLUCA. Mr. Speaker, the Secretary at that time was misquoted before the budget hearings. The statement I just read was a reply from a February 20 letter that was sent to Representative Trello which states the fact that we do have sufficient revenue to take care of this in the lottery program.

Mr. BROUJOS. The next question is, that is based on representations you have received from the administration?

Mr. DeLUCA. Pardon me?

Mr. BROUJOS. You make that statement based on information you have received from this administration?

Mr. DeLUCA. Yes; I do, Mr. Speaker.

Mr. BROUJOS. Thank you. I have no further questions, Mr. Speaker.

 - (i) The utility does its own testing or procures its own analysis of its fuel.
 - (ii) The net energy cost of the utility for the most recently completed fiscal year exceeds that of the prior fiscal year by more than 5%.

(iii) The commission has not completed a fuel purchase audit of the utility in the past two years.

- (2) This audit, which shall be completed within one year of the presentation of the petition, shall include, but not be limited to, a comparison of unit price paid for fuel for generating purposes, considering such factors as ash, sulfur content and British thermal units.
- (3) The audit shall seek to determine whether the public utility's fuel purchasing procedures are conducted in such a manner as to result in the greatest benefit to the environment and the ratepayers.
- (4) The commission's audit report shall contain recommendations as to methods by which the utility's fuel purchasing procedures can be adjusted so as to result in the greatest benefit to the ratepayers and the environment.
- (5) The commission shall take the audit report into consideration at the utility's next request for a rate adjustment.
- (6) Copies of the audit report shall be mailed to each of the petitioners who request the audit.

Mr. GEORGE. Mr. Speaker, this amendment simply insures that the fuel purchases conducted by the utilities in Pennsylvania will be done in such a manner that if there is any doubt whatsoever of the legitimacy, there is within this amendment an action that can be approved that will see to it that these purchases are legitimate by audit. The audit will be performed by the public utility.

Mr. GEORGE. Not to the same instance, Mr. Speaker, does this amendment allude. The bill or the law as suggested, that you believe now is in format, alluded to fuel adjustment with the utility not involved, a claim in fuel adjustment per se. This amendment is needed to go back 2 years prior to any rate increase and to find out whether or not these utilities are in actuality procuring these fuels at the most competitive, best price.

Mr. COY. Mr. Speaker, is the heart of the amendment not rather the availability of a petition by 500 or more ratepayers? Is this not the part of the process which is changing and not the actual substance on the part of the Public Utility Commission?

Mr. GEORGE. Mr. Speaker, I do not know whether I heard your question properly. The reason for the number of petitioners was just to guarantee that there would not be any frivolous action and that there would be several other instances by the petitioners that would have to be considered.

Mr. COY. Mr. Speaker, my question is, is the requirement of the petition being filed by ratepayers a new requirement?

Mr. GEORGE. Yes; it is, Mr. Speaker.

Mr. COY. So that is the heart of the amendment then, the fact that this action can be called for by a number of ratepayers requesting it rather than simply on the part of the Public Utility Commission doing it?

Mr. GEORGE. You are absolutely accurate, Mr. Speaker.

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Bucks, Mr. Greenwood.

Mr. GREENWOOD. Thank you, Mr. Speaker.

The bill that we are considering now is a bill that modifies the law that provides a system of handicapped license plates and handicapped placards. The reason that there has been some legislative activity on this act is because those who are handicapped and the advocates for the handicapped have discovered that it is far too easy to get a license plate or a placard that enables you to use the parking spots which are reserved for the handicapped. As a result of that, the truly handicapped people who need those spaces are not able to find them when they need them.

The first amendment that I am going to be offering specifies a means by which a determination can be made as to whether or not someone truly needs the use of a handicapped license plate or placard, and we are requiring that the disability, as it refers to the loss of the use of a leg or legs, is evidenced by the use of a wheelchair, a walker, crutches, a quadripod cane, an artificial leg or legs, braces, or other such device. Also, under the area involving respiratory ailments, we specifically say that we include chronic emphysema or bronchitis and we exclude minor respiratory ailments.

This amendment is agreed to by the prime sponsor of the bill, as I understand it, and I would appreciate the support of the House.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. Linton.

Mr. LINTON. Mr. Speaker, as indicated by the previous speaker, this is an agreed-to amendment.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Allegheny, Mr. Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

I would like to ask a question of the maker of the amendment, please.

The SPEAKER pro tempore. The gentleman indicates he will stand for a period of interrogation. The gentleman is in order and may proceed.

Mr. MARKOSEK. Mr. Speaker, in dealing with the respiratory diseases that we are alluding to in this amendment, are these diseases a cause for ambulatory problems?

Mr. GREENWOOD. Yes.

The reason for including this category is that there are those who suffer from severe emphysema, for instance, and for them just to walk across the parking lot of a shopping center or a mall is more than they can do. The Department of Transportation, by the way, has been consulted on this amendment. They support it, and the various advocacy groups for the handicapped have supported this amendment.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Amend Sec. 1 (Sec. 1338), page 2, line 18, by inserting after "PERSON."

Placards may also be issued for use in vehicles operated exclusively for the use and benefit of handicapped persons.

On the question,

Will the House agree to the amendments?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Bucks, Mr. Greenwood.

Mr. GREENWOOD, Thank you, Mr. Speaker.

This amendment is also agreed to by the prime sponsor of the bill, and it refers to the handicapped placard. There are two devices used in this legislation. One of them is the license plate, which is permanently attached to the car, and the other is the placard, and the placard is used for a number of reasons.

Number one, when you have a temporary disability, the placard can be posted within the car and then removed when the disability is no longer there. It can also be used by the parents of a handicapped person when the handicapped individual is transported in different cars from time to time.

This amendment allows the placard to be used for someone who is blind or who is the parent or a person in loco parentis of a person specified in the previous section, under the handicapped section, and whose application has been verified by a physician. This amendment also allows placards to be issued for use in vehicles operated exclusively for the use and the benefit of handicapped persons.

I would ask for support of this amendment.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. Linton.

Mr. LINTON. Thank you, Mr. Speaker.

This, too, is an agreed-to amendment, and I ask for support of the amendment. Thank you.

Mr. GREENWOOD offered the following amendments No. A0499:

On the question,

Will the House agree to the amendments?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Bucks, Mr. Greenwood.

Mr. GREENWOOD. Thank you, Mr. Speaker.

About this amendment we will have some debate.

I introduced legislation earlier in this session to comprehensively modify the handicapped parking law, and I started out where Mr. Linton is now in his bill, simply requiring that a physician approve of the application and verify that there is a handicap. That has been the subject itself of some controversy for the following reasons: There are those who are advocates for the handicapped and who are handicapped themselves who have argued that, number one, if we require the handi-

capped individuals to go to their physician for verification, we are first off requiring an expense on their part. They are going to have to pay their physician to go and verify the form that they need in order to get the license plate. The other argument that has been repeatedly brought to my attention is that a physician is inclined to support the application of his client, not necessarily because the client is in need of the specialized treatment but because he or she is a client, and that it is too easy to have your doctor approve the application.

This amendment would transfer the verification procedure from the physician to a police officer. Now, the police officers are accessible in every community, and it would require that the handicapped person simply stop at the police station and have their application verified, indicating that they do indeed meet the requirements of the act and are, therefore, eligible for a license plate.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. Linton.

Mr. LINTON. Thank you, Mr. Speaker.

This, as indicated also, is not an agreed-to amendment. My efforts on the part of the legislation, I think, my intent in introducing this bill is similar to that of the Representative. However, I question whether in fact we should have police officers whom we see as those who are designated to deal with crime to now be designated to be burdened with verifying whether one is in fact handicapped. It seems to me that in many of the instances in this Commonwealth we believe in and trust in the professional capabilities of physicians, trust in fact that they are indeed honest, and expect that they would in fact verify whether one is or is not competent or one should not be classified as a handicapped individual for the purpose of these license plates. I do not think that we should be involved in, as I said earlier, burdening the police department with verifying whether one is or is not handicapped.

In addition, if I understand the bill correctly as it was amended, under what circumstances or what ability is a police officer able to clearly indicate whether one has a problem that would require respiratory difficulties and be able to verify that to indicate that this individual is in fact eligible to receive a placard or handicapped plate?

So I am asking the members to vote in opposition to this amendment.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Chester, Mr. Morris.

Mr. MORRIS. Mr. Speaker, I would just like to suggest to the members of the House that probably in their districts, and quite a few of them, there are people who live closer to a doctor than they do to a police officer. That happens to be the case with myself. I think this amendment is not well thought out.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Northampton, Mr. Rybak.

Mr. RYBAK. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose the Linton amendment, and I wholeheartedly support the Greenwood amendment. I do so based on experience, as I am a member of the club, and I brought my club along to prove it.

We know that just about any individual who goes to a friendly doctor will be able to get a permit. He will overlook whether or not there is a certificate of need. That is human nature. We also know that this is a much-needed piece of legislation for handicapped people who really need a parking place, who need a plate. But we also know from our experience that there has been quite a bit of abuse, that they are handed out too readily. I believe that a police officer would be a disinterested party who could determine on visibility whether or not there is need, and if it is not visible, then the person could bring a doctor's certificate and establish that need. I think we would have an objective decision there to give these permits only to those who actually need them; otherwise, we are going to erode the very purpose and intent of this law. Therefore, I would ask for the Assembly to support the Greenwood amendment. Thank you very much.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The issue before the House is the amendment offered by Mr. Greenwood.

The Chair recognizes the gentleman from Northampton, Mr. Gruppo.

Mr. GRUPPO. Thank you, Mr. Speaker.

I would like to interrogate the sponsor of the amendment.

The SPEAKER pro tempore. The gentleman indicates he will stand for a period of interrogation, and the gentleman, Mr. Gruppo, is in order and may proceed.

Mr. GRUPPO. Mr. Speaker, in looking at your amendment here, it is my understanding that you simply want a police officer to verify the disability that an individual may have to qualify for a parking permit. Is that correct?

Mr. GREENWOOD. That is correct.

Mr. GRUPPO. Although I agree somewhat with the previous speaker, I have some difficulty in just permitting a police officer to do this verification. I personally had thought along the lines of either having two physicians or a physician and a police officer. That way we can have the medical verification and the physical verification by the police officer.

I was wondering if you would be agreeable to amending your amendment to permit the physician and the police officer to make the verification.

Mr. GREENWOOD. I am not sure about the procedures of that, Mr. Speaker, but what I do think is this, and this may satisfy your concern: This bill, as amended, if we adopt this amendment, does not preclude the police officer, if the police officer feels that in a particular instance he or she cannot make that judgment, to ask the applicant to get a note from their doctor. This simply says that the application must be verified by a police officer. So if a police officer is on duty and someone comes in on crutches or in a wheelchair, obviously handicapped, the police officer simply verifies that application and it goes to PennDOT and they get their plate. If, however, an applicant comes in with no obvious physical disability but perhaps says, I have severe bronchitis, or, I have emphysema, there is nothing in this legislation as amended that would preclude that police officer from saying, go get a note from your doctor and come back.

So I think that amended this way we make it less costly for the handicapped person; we make the services accessible, because remember, police officers still make house calls and physicians rarely do; and thirdly, we put an element of control in there where the police officer is less likely to be talked into something than the doctor would be, but we still have the opportunity for a police officer to ask for a note from the doctor. So I think it is the best of both worlds.

To answer your question, I would have to know more about what the procedures are to amend this amendment. But I probably would not go along with that idea because I think it is duplicative.

Mr. GRUPPO. In other words, Mr. Speaker, you feel fairly certain that we will not have police officers simply rejecting applications of those who truly need them or have individuals walking into the police station who may be temporarily incapacitated obtaining a parking permit and utilizing it for a long period of time? Is there any way the law currently restricts that so that we can establish the length of time that this permit would be in existence?

Mr. GREENWOOD. Mr. Speaker, I had an amendment that was going to clarify the fine issue, and I have withdrawn my amendment in favor of one to be offered by Representative Ryan. Representative Ryan in his amendment will beef up the fine provisions a little bit. So therefore, if someone were to use a placard, for instance, based on a temporary injury beyond the time when they were still injured, they would be subject to a fine which will be significantly stiff, I think, after the Ryan amendment.

Mr. GRUPPO. May I ask another question, Mr. Speaker? Do you know if currently there are time restrictions placed on these permits for an individual who may be temporarily incapacitated?

Mr. GREENWOOD. There are not specific time restrictions, because that would not work. Someone may have a broken leg and they may need a special provision for 3 months; another might have the broken leg persist for 2 years. But what the law does say is that it can only be used while the disability is in effect.

Mr. GRUPPO. Well, I would just like to make a comment, Mr. Speaker.

Although I understand what Representative Greenwood is attempting to do, I would still feel more confortable if we would have the physician approve the request by the individual for a permit and then have that individual bring it to the police officer or police station for approval. I understand what you are saying is the absolute reverse, but nonetheless, I would feel more comfortable having the police officer do it. Well, I will let you have your way, Mr. Speaker, and we will go along with it and see what the House decides to do. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Somerset, Mr. Lloyd.

Mr. LLOYD. Thank you, Mr. Speaker.

I would like to interrogate Mr. Greenwood.

The SPEAKER pro tempore. The gentleman, Mr. Greenwood, indicates he will stand for a period of interrogation. The gentleman, Mr. Lloyd, is in order and may proceed.

Mr. LLOYD. Mr. Speaker, most of the discussion on this amendment has dealt with the question of whether the verification ought to be by a doctor or by a police officer, but there is another change in the law which this amendment is proposing to make that I do not understand. On page 2 of the bill, lines 5 through 7, current law says that special plates for handicapped persons may also be issued for vehicles operated exclusively for the use and benefit of handicapped persons. Now, presumably, Mr. Speaker, that means a van which somebody has in which the person who is driving it is not handicapped but the people being transported are. Mr. Speaker, you are proposing to take from the existing law the sentence which I just read. Could you explain to the House why?

Mr. GREENWOOD. Mr. Speaker, on an amendment that was previously adopted, amendment A0497, we added language that enables a placard to be used for a vehicle that is operated exclusively for the use and the benefit of handicapped persons. The Department of Transportation and many of the advocates that we consulted on this legislation felt that those vehicles should have a placard but not a license plate. Their reasons were varied, but in some cases those vans are used by people apparently at other times than when they are transporting the handicapped, and they should not be parked in handicapped locations at that time.

Mr. LLOYD. Thank you, Mr. Speaker.

Could I be recognized to comment on the amendment?

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. LLOYD. Thank you, Mr. Speaker.

I rise to oppose this amendment. I think if the members want to tighten up the law on the handicapped and who can get handicapped license plates, that is fine, but I have a feeling that a lot of members who voted earlier today do not really realize what the consequences of those votes are. What happens here is, yes, some advocacy group somewhere down in Philadelphia or Bucks County or Harrisburg may say this is a great idea, but when that person in your county who is transporting the handicapped in a van and who now gets a handicapped plate for that no longer is able to get it, and he comes into your office to ask you why you voted to do that, I hope you have a good reason.

Secondly, the notion of having the police departments do the verification, in my opinion, simply is disaster in a rural area. In the southwest corner of my county there are no police departments. There are no police departments in the only small boroughs or in the townships. That means, if this amendment passes, that those people who are handicapped, in order to get a handicapped plate or a handicapped placard, are going to have to go all the way to the county seat 35 miles away to the State Police barracks. I think that is not in the best interests of the handicapped. I understand what the gentleman is trying to do, but I think that in the name of trying to

tighten up the law he is going to really impose severe restrictions on people who should not have those restrictions imposed upon them.

Finally, Mr. Speaker, under this amendment it simply says that a policeman has to verify the application. It does not say whether that has to be a State policeman or a local policeman. It does not tell a municipality whether it is allowed to verify an application for somebody who does not live in that municipality, and if we are going to go in the direction that the amendment proposes to go, then those kinds of questions ought to be answered.

And finally, Mr. Speaker, if in rural areas we are going to have this additional burden placed on the State Police, then I would like to see something done to increase the State Police budget so that they are able to handle all these things in a timely fashion and that I do not start getting all the complaints from people who say, well, I went to the police barracks and they would not do it, or they cannot do it today, or they cannot do it for 2 or 3 weeks.

For all of those reasons, Mr. Speaker, I urge that we defeat this amendment.

The SPEAKER pro tempore. The Chair recognizes, for the second time, the gentleman from Northampton, Mr. Rybak.

Mr. RYBAK. Mr. Speaker, I believe, in my opinion or judgment, that the prior speaker talked about a remote situation of traveling 35 or more miles to find a policeman. I do not think that is realistic. But be that as it may, when this legislation was first proposed that a physician's certificate would be required, I took it personally upon myself, and so did Representative Greenwood, to check out what the people involved think, what the handicapped people who need a plate or a placard intended in the matter, and the response was unanimous that there is too much abuse as is, that practically speaking it is easy to get a doctor to be a nice guy and say okay, even though there might not be a need, and that the only way you can really get an objective position is to go to the police authority in the jurisdiction where you live and get them to approve it.

As far as expertise, if the situation is not apparent whether or not there is need— And certainly it is apparent in such situations where a man is in a wheelchair or where he has two legs off, et cetera and so forth. He can grant that certificate of need. If it is not apparent, very simply he can go to see a doctor. And, of course, the other reason was to save the money it will cost to get a doctor to prepare a certificate of need.

So I think it is in the best interests of the handicapped person that this amendment pass. I believe this is what they want. I think it will do the job, and I ask that this amendment be approved. Thank you.

The SPEAKER pro tempore. The Chair recognizes, for the second time on this issue, the gentleman from Somerset, Mr. Lloyd.

Mr. LLOYD. Mr. Speaker, the comment that it is unrealistic that somebody is going to have to travel half an hour simply does not reflect the understanding of geography in the

western part of this State. I do not know what it is like in Mr. Rybak's district and how many police departments there are per municipality, but in the western rural areas of this Commonwealth we generally do not have police departments in townships, and many of the boroughs have one policeman if any at all. It is absolutely correct that in many corners of my county there is no police department, and if somebody wanted to get it authorized, he is going to have to travel to the county seat, and that is going to take him at least half an hour, whereas he can get to a doctor much more readily than that.

So members can choose how they want, but if they come from rural areas such as mine where we do not have a lot of police protection, they had better give very serious thought to this amendment and vote "no."

The SPEAKER pro tempore. The Chair recognizes, for the second time on this issue, the gentleman from Northampton, Mr. Gruppo.

Mr. GRUPPO. Thank you, Mr. Speaker.

I would like to interrogate Representative Greenwood, please.

The SPEAKER pro tempore. The gentleman indicates he will stand for a period of interrogation, and the gentleman, Mr. Gruppo, is in order and may proceed.

Mr. GRUPPO. Mr. Speaker, if an applicant were to be rejected by a police officer, can he voluntarily go to his physician, obtain approval from the physician, go back to the police officer, and obtain the placard?

Mr. GREENWOOD. If it were my constituent and I were counseling him, I would tell him to go to his doctor and get a letter and find himself another police officer.

Mr. GRUPPO. Well, you know, I think your amendment has a great deal of merit, and I feel personally that something has to be done to address this problem. I just do not think you are going about it the right way with your amendment. I have other people around me who feel the same way. I really hate to ask the House not to vote for your amendment, and I would like to know if you could hold this bill over for a while until some work can be done to clean it up a little bit.

Mr. GREENWOOD. Mr. Speaker, I would certainly have no objection to holding the bill over. It is not my bill; it is Representative Linton's bill, so perhaps he would want to be consulted.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. Linton.

Mr. LINTON. Mr. Speaker, I have had comments from various members who feel very strongly that verification by a physician is appropriate and also adequate. In addition, I also would like to make the members aware that disabled vets currently under the law are required to go to the Veterans' Administration and come up with documentation to verify the fact that they are disabled, using the same application.

I am opposed to tabling the bill or recommitting the bill. As its prime sponsor, I would hope that we would vote and move the bill today.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Northampton, Mr. Gruppo.

Mr. GRUPPO. Just a point of clarification to Mr. Linton.

I was not asking that we recommit the bill. I was simply asking that we hold it over and perhaps the sponsor and Representative Greenwood, and maybe even myself or any other interested Representative, try to do something to improve this amendment, because I would like to see an amendment like this go in, but I am not totally satisfied with this. I was wondering if you would be willing to do that?

Mr. LINTON. Mr. Speaker, as I indicated, I would like to vote the bill as it currently is. I am opposed to the amendment. I am opposed to using police officers to verify handicapped individuals, and I would like us to move forward and vote on the amendment.

The SPEAKER pro tempore. The gentleman, Mr. Greenwood, has already spoken twice on this issue.

Mr. GREENWOOD. Mr. Speaker, I just wanted to make a simple procedural motion.

The SPEAKER pro tempore. The Chair recognizes the gentleman from York, Mr. Bortner.

Mr. BORTNER. Mr. Speaker, I also rise to oppose the Greenwood amendment, and I do so for several reasons. I understand the purpose, but I do not think it is practical, and I think it is ill conceived. If a person presents himself to a police officer in a wheelchair or on crutches or with a cane, a police officer will have no way of verifying whether that person is truly needy. I think a doctor is in a position to better make that determination, and although there may be some abuses, I do not think they would be wholesale. I have some confidence in the medical profession.

I also think that a friendly police officer would be subject to this same kind of abuse, and it does not seem to me that this would correct that situation. I do not think that turning this over to police officers who have their hands full dealing with law enforcement is the right way to approach this problem. Thank you.

BILL RECOMMITTED
