Dear Mr. Myer:

As required by section 14(b) of the Storm Water Management Act, I am pleased to resubmit the proposed Storm Water Management Guidelines and Model Ordinances for consideration by the General Assembly under the procedures provided in the Act of April 7, 1955, P.L. 23, No. 8, known as the Reorganization Act of 1955.

The Storm Water Management Act and program are part of a concerted effort to reduce flood damages throughout the Commonwealth, and to protect public health and safety from the ravages of accelerated storm water runoff. In the past 50 years, Pennsylvania has experienced at least 20 major floods, causing over \$6 billion in property damage. Even with substantial investments in flood control structures, the Commonwealth suffers average annual residual damages due to floods and storm water runoff totalling over \$60,000,000. At the same time, in the absence of proper planning, local and state government confront enormous expenses for post-flood recovery efforts, costly after-the-fact solutions, expensive flood control and storm sewer systems.

The Storm Water Management Act provides a program for planning and local regulation of development to avoid and reduce damages caused by accelerated storm water runoff. The program focuses on watershed planning conducted by counties, with implementing regulation by municipalities.

Stormwater management is concerned with the planning, design, and management of the flow and storage of surface waters resulting from large and small storms including consideration of water quality and interaction with groundwater. The implementation of stormwater management plans will stabilize the quantity and velocity of stormwater which enters our streams. The plans will help to prevent downstream flooding, stream channel erosion and resulting siltation, provide a balance for existing biological habitat in streams, maintain or increase the flow to groundwater and reduce the amount of nonpoint source pollution.

This Administration has made a concerted commitment to implement the storm water program in a step-by-step, cost-effective fashion. The budget for fiscal year 1985-86 includes funding of \$250,000 for storm water management grants to municipalities and counties, to assist them in costs of preparation, administration, enforcement, implementation and revisions of official watershed storm water management plans required under the Act. We realize this is only a beginning, but is an important first step.

In addition to the Storm Water Management Guidelines and Model Ordinances transmitted today, regulations are needed to establish the storm water management grant and reimbursement program. This companion regulatory package has been approved by the Environmental Quality Board as proposed rulemaking and will be transmitted within the next few days for review in accordance with the Regulatory Review Act, the Act of June 25, 1982, P.L. 633, No. 181. The Department will be prepared to implement the reimbursement provision of the Act when both the Guidelines and Model Ordinances and the related regulations are approved in final form.

Approval of these guidelines will give assistance to counties and local governments facing the increasing problems of accelerated stormwater runoff. As the General Assembly itself determined when enacting the Storm Water Management Act, dealing with storm water runoff in a reasonable manner is fundamental to the public health, safety and welfare. We believe that approval of these guidelines is an important step toward the protection of the people of the Commonwealth, their resources and the environment.
