I would like to recognize the very special help of Representative Saurman in this bill in getting it to this point.

Mr. RYAN. Mr. Speaker, would the gentleman consent to brief interrogation?

The question is, shall the bill pass finally?

On final passage, the Chair recognizes the gentleman from Allegheny, Mr. Itkin.

Mr. ITKIN. Mr. Speaker, would the prime sponsor of the bill stand for interrogation?

The SPEAKER. Mr. Dombrowski indicates he will stand for interrogation. You are in order, sir, and you may proceed.

Mr. ITKIN. Mr. Speaker, I have one concern about the legislation and hope that it can be cleared up.

HB 1004 provides that a warning may be given if a service station operator has never had a violation in the preceding 5 years. What happens if the violation is a major one; for an example, forging of inspection station stickers or something like that? Under your legislation would that also require—

Mr. DOMBROWSKI. I think that would be a violation in another section of the law. I think we are merely looking for inspection violations.

Mr. ITKIN. What kind of inspection violations would be covered under this legislation?

Mr. DOMBROWSKI. Well, the legislation refers to minor infractions of the law. There are many times that a person buys a car, and after it has been inspected 6 weeks ago or 8 weeks ago, they report a violation to the State Police. The State Police look at it and say it was indeed a violation. The garage owner says it was not a violation when he inspected the car, and he has never had a violation for 5 years, which indicates he is a good mechanic, a good inspector, yet the law currently states that he must have a 90-day suspension. We are talking about minor violations.

Mr. ITKIN. Yes, but the problem I have with the legislation is it does not specify minor violations, and basically, it says any violation, I think.

Mr. DOMBROWSKI. I would think that is what the legislation says. It is any violation merely because, if a person has not had a violation for 5 years, I would not anticipate that he was a bad mechanic and would have a major violation.

Mr. ITKIN. Mr. Speaker, my question has been answered.

The SPEAKER. The Chair thanks the gentleman.

**BILLS ON THIRD
CONSIDERATION CONTINUED**

The House proceeded to third consideration of **HB 1524, PN 1914**, entitled:

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing correction by telescopic lenses for visual acuity license requirements.

On the question,
Will the House agree to the bill on third consideration?
Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On final passage, the Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, I see the gentleman, Mr. Duffy, is up. I would ask to be recognized after Mr. Duffy.

The SPEAKER. The gentleman, Mr. Duffy, indicates—

Do you wish to interrogate Mr. Duffy, or do you wish to wait until after he has made his statement?

Mr. RYAN. No. I would just as soon wait until he has made his statement.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Duffy, on final passage.

Mr. DUFFY. I would like the support of the House on this measure. One of my constituents has an eye problem, and she wants to use telescopic lenses to drive. Now, this case has gone to common pleas court in Allegheny County. She has gotten an okay to do this. They felt that she was capable of driving. It was appealed by the State to the Commonwealth Court. Now, there she was overturned. They said she could not drive.

Now, I have talked to a doctor who is involved in this field, and there are actually right now 12 States where people with poor vision can use telescopic lenses and they have the right to drive. Now, I am not going to try to put somebody on the road who does not have the ability. This is a responsible person, and also, there are safeguards in the bill where the people from the State have to give the final okay. I just want her to be like everybody else, to have a shot at it, and let the people in the State decide after the ophthalmologist and the optometrist have their say-so.

The SPEAKER. On final passage, the Chair recognizes the gentleman from Warren, Mr. Bowley.

Mr. BOWLEY. Thank you, Mr. Speaker.

Will the maker of this bill stand for brief interrogation?

Mr. DUFFY. Yes.

Mr. BOWLEY. Thank you.

Mr. Speaker, when drafting this legislation or before the Transportation Committee, did the committee hear any testimony on what telescopic lenses will do to a person's peripheral vision?

Mr. DUFFY. No. It was brought up before the committee and passed by the committee onto the floor.

Mr. BOWLEY. As I understand, in caucus yesterday, Mr. Speaker, this bill was brought up before the committee with

very little, if any, discussion and passed unanimously. I question, Mr. Speaker, whether we should be dealing with this piece of legislation without hearing some testimony from some doctors as to what effect telescopic lenses have on a person's peripheral vision.

Mr. DUFFY. I have some information here. If you would like to look it over, I would be glad to let you have it.

Mr. BOWLEY. Thank you.

MOTION TO RECOMMIT

Mr. BOWLEY. Mr. Speaker, may I comment on final passage?

The SPEAKER. The gentleman is in order, and he may certainly proceed.

Mr. BOWLEY. Thank you, Mr. Speaker.

Mr. Speaker, I am going to vote "no" on this, simply for the fact that I do not think we have looked at what effect telescopic lenses do have on a person's peripheral vision.

At this time, Mr. Speaker, I am going to ask for a motion to recommit this bill to the Transportation Committee.

The SPEAKER. It has been moved by the gentleman, Mr. Bowley, that HB 1524, PN 1914, be recommitted to the Committee on Transportation.

On the question,
Will the House agree to the motion?

The SPEAKER. The debate will be on that motion and on that motion alone.

The Chair recognizes the gentleman from Westmoreland, Mr. Hutchinson.

Mr. HUTCHINSON. Mr. Speaker, I am against that motion.

The SPEAKER. Mr. Hutchinson on the motion objects to the motion and is in the negative.

The Chair recognizes the gentleman from Allegheny, Mr. Duffy, on the motion.

Mr. DUFFY. I object to the motion also.

The SPEAKER. Mr. Duffy objects to the motion and is in the negative.

The Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, I heard some of the comments of the gentleman, Mr. Bowley, and he addressed an issue that also was of concern to me. In connection with the recommittal motion, Mr. Speaker, the gentleman preceded his motion by suggesting that there was more testimony or evidence needed with respect to the ability of a person wearing telescopic lenses to see the way a nonvisually handicapped person might be able to see.

It is my understanding that the Commonwealth Court, when it reversed the lower court, said that the regulation did not violate the rehabilitation act, because it was based on a finding that telescopic lenses did not put the visually handicapped on an equal footing with other drivers because of the blind spot left by the lenses.

I do not fully understand the effect of telescopic lenses on the drivers. I think that this is a special situation that Mr.

Duffy has, a special problem, but I believe, because it would turn into a Commonwealth law and could possibly affect the safety of the motorists of this Commonwealth, that we should have more evidence and more information with respect to the safety of the driver wearing such lenses. Because of that, I would join with the gentleman in suggesting that the bill be recommitted to committee for the purpose of gathering that information.

WELCOME

The SPEAKER. The Chair is going to interrupt this debate for a very, very important announcement, far more important than anything we have done so far today.

The Chair is delighted to have a distinguished guest to the left of the Chair. His name is Jared Robert Sweeney. He is being held by his mama, Ann-Marie Sweeney, and his father accompanies him. Will you hold Jared up so they may put him on the record.

I think Jared is probably the youngest visitor we shall have today. We are glad to have him officially on the record, and congratulations to mother and father.

The SPEAKER. The Chair recognizes the gentleman from Butler, Mr. Steighner.

Mr. STEIGHNER. Thank you, Mr. Speaker.

Mr. Speaker, I would also ask for a "no" vote on the recommittal. The fact of the matter is the Transportation Committee did in fact consider the legislation and reported it out. The chairman has also indicated his opposition to recommending it. I would suspect that even if it was recommitted, the committee would simply report it back out again.

Also, Mr. Speaker, a person who uses these telescopic lenses must in fact still pass the Pennsylvania driver's exam.

I would ask for a "no" vote on the recommittal.

The SPEAKER. The Chair thanks the gentleman.

On the motion, the Chair recognizes the gentleman from Northumberland, Mr. Belfanti.

Mr. BELFANTI. Thank you, Mr. Speaker.

I, too, would rise and oppose this motion to recommit. Representative Duffy indicates that 12 States currently allow persons with telescopic lenses to drive. As Representative Steighner just indicated, there are other ways that the Pennsylvania Department of Transportation can keep unsafe drivers off the road, whether they have telescopic lenses or not. If they are in any way visually handicapped and the telescopic lens does not bring their eyesight up to moderate levels, they will still not be issued a license.

I would think that this is a very worthwhile piece of legislation, and we should act on it favorably and therefore defeat the recommittal motion.
