COMMUNICATION FROM GOVERNOR

1985 SURPLUS PROPERTY DISPOSITION PLAN

The Secretary to the Governor presented the following communication from His Excellency, the Governor:

To the General Assembly of the
Commonwealth of Pennsylvania

By the authority vested in me by Article XXIV-4 of the act of July 1, 1981 (P.L. 143, No. 48), entitled "Disposition of Commonwealth Surplus Land," I transmit herewith the 1985 Surplus Property Disposition Plan.

The annual Surplus Property Disposition Plan, required by Act 48 of 1981, provides for the systematic management of Commonwealth-owned real estate assets and the efficient disposition of surplus holdings. The Plan also ensures that all conveyances are made for fair consideration predicated upon fair market value.

Contained in the Plan for 1985 are seven (7) properties whose usefulness to State Government has ceased. However, their desirability and value for other purposes is substantial. The properties vary in size, nature, and geographic locations. Any special considerations, such as zoning restrictions, retention of mineral rights, and easements and leases presently in effect, have been identified for each parcel.

Pursuant to Act 48 of 1981, the Plan has been transmitted to the Chairmen and the Minority Chairmen of the House and Senate State Government Committees. The House and Senate Committees conducted a joint public hearing on September 19, 1985, as a part of their review of the Plan and have advised the Department of General Services of their findings.

The Department of General Services has also invited public comments on the Plan through publication in the Pennsylvania Bulletin, Vol. 15, No. 33, Saturday, August 17, 1985. In addition, pursuant to Act 48, the Department has requested and received the Attorney General's review of the Plan for form and legality.

Legislative consideration of the sale of the properties contained in the Plan will result in substantial benefits to the Commonwealth, including the return of idle real estate to local tax rolls, the reduction of state exposure to liability and other insurance risks, and the elimination of excessive security and maintenance costs.

I, therefore, transmit to you and urge your approval of the 1985 Surplus Property Disposition Plan.

The House proceeded to third consideration of **HB 294, PN 318**, entitled:

An Act amending the act of April 9, 1929 (P. L. 177, No. 175), known as "The Administrative Code of 1929," further providing for grants and contracts made by area agencies on aging.

On the question,

Will the House agree to the bill on third consideration?

Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On final passage, the Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, would the gentleman, Mr. Trello, consent to interrogation on this bill?

The SPEAKER. The gentleman, Mr. Trello, indicates he will stand for interrogation. You are in order, and you may proceed, sir.

Mr. RYAN. Mr. Speaker, would the gentleman explain why he believes we need legislation to give preference to non-profit agencies such as provided in here and describe and give us some examples of the types of contracts he is referring to?

Mr. TRELLO. This deals strictly with the Meals-on-Wheels Program only and nothing else. The reason why we want to give them preference is because back in 1983 a directive was passed by the then Secretary of Aging, Gorham Black - 83-12 was the directive order, which meant that anybody including private enterprise could bid on these contracts for the Meals-on-Wheels Program without any regard to the job that the volunteers are doing. Right now the volunteers are preparing the food and delivering, but the most important thing about this issue is that not only are they delivering the meals to the disadvantaged but they are also making sure that the recipients are well and healthy. In some cases the recipients of the Meals-on-Wheels Program have fallen down and broken a hip and they have not been discovered for days. We feel that if private enterprise gets involved with the Meals-on-Wheels Program, they will not show the love and affection that the volunteers are showing right now.

Mr. RYAN. Mr. Speaker, would the gentleman show me in this particular bill where it restricts the language that he is attempting to insert into the law, where it restricts it to Meals-on-Wheels Programs? I am unable to find that.

Mr. TRELLO. Well, I do not have a copy of the bill with me right now.

Mr. RYAN. Mr. Speaker, I wonder if someone could give Mr. Trello a copy of this bill so that he could answer this question.

The SPEAKER. Mr. Broujos is accommodating Mr. Trello. Now he is giving him a copy of the bill.

Mr. TRELLO. In the language on page 2, it says, "The area agency shall give preference to nonprofit agencies...." The language is not spelled out for Meals on Wheels, but the meetings that we have had with the Department of Aging in Allegheny County and other areas spells out strictly the Meals-on-Wheels Program.

The reason why we could not emphasize the fact on the Meals-on-Wheels Program is because of union contracts. They sort of opposed this until we sat down and explained it to them. But this specifically refers to Meals-on-Wheels Programs and Meals-on-Wheels Programs only.

Mr. RYAN. Mr. Speaker, would the gentleman agree that this bill as it is before us does not restrict the language to Meals-on-Wheels Programs but rather refers to contracts for the provisions of social services? Whatever social services may be, this is what the language refers to.

The SPEAKER. Would the gentleman yield for a moment. We are getting too noisy.

Would you repeat the question, Mr. Ryan?

Mr. RYAN. Mr. Speaker, I am asking if the gentleman agrees that the way the bill is before us, the law would be changed—if adopted, of course—to provide that the preference be given for the provisions of social services, contracts for the provisions of social services—in its broadest sense the word is "social services"—and does not restrict it to simply the Meals-on-Wheels Programs.

Mr. TRELLO. Well, I agree with the gentleman that it does not spell out "Meals-on-Wheels Program." Furthermore, the director of the Finance Committee had a baby last night and she is not here to assist me. This bill was drafted several months ago. But it pertains strictly to volunteers, and I agree with you that it spells out "social services." The only thing that is missing as far as social services are concerned is the volunteer language.

Mr. RYAN. Thank you, Mr. Speaker.

BILL PASSED OVER

The SPEAKER. Now, Mr. Ryan.

Mr. RYAN. Mr. Speaker, it was not until I interrogated the gentleman, Mr. Trello, that I knew or understood that he was attempting to restrict this language to the Meals-on-Wheels Program. I am honestly not sure what my reaction is to that.

However, the way it is presently drafted, I think we are permitting ourselves to get into an area where a great deal of mischief could be caused, and I am wondering if the gentleman would agree that this bill be placed on the table or at least passed over for the day until we have an opportunity to look into it a little bit further.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, I will agree to that, but just let me refer to one item here that is underlined on page 2. It indicates that the area agency shall give preference, and the area agency—meaning the area agency on aging only—shall give preference to nonprofit agencies. But I feel if you want it spelled out better, I see no problem to have it just passed over until an amendment can be drafted.

The driver's manual shall include a section relating to the effects of alcohol and drug use on highway safety, along with the related penalties. A chart which demonstrates the levels of alcohol in a person's bloodstream legally sufficient to constitute intoxication shall be included in this section of the driver's manual.

Section 2. Section 1538 of Title 75 is amended to read:

Amend Sec. 2, page 4, line 15, by striking out "2" and inserting

On the question,

Mr. REINARD. Thank you, Mr. Speaker.

Mr. Speaker, this amendment, A3779, is an amendment which attempts to do a few things. First off, the amendment will require that all applicants for a driver's license, upon being given their oral driver's examination, must be asked at least one question regarding the uses of alcohol or drugs and their effects on highway safety. The amendment also will require that the driver's examination books that all new driver applicants in Pennsylvania get to review for the exam will include a blood-alcohol chart which will demonstrate the effects of alcohol on an individual's weight and height. Also, there will be a provision in the driver's manual which will also state specifically what Pennsylvania's current drunk driving law is so the new drivers in Pennsylvania will become aware of their acts if they violate such law.
