An Act amending the act of July 18, 1935 (P. L. 1314, No. 411 1/2), entitled, as amended, "An act authorizing the utilization of the Pennsylvania State Police Academy for training persons to act as policemen in the political subdivisions of the Commonwealth; prescribing the qualifications for admission of such persons to such school; providing for the payment of certain costs by such students; conferring certain powers upon the Pennsylvania State Police; and making an appropriation," providing for training for response to ethnic tension situations.

On the question,

The House proceeded to the consideration on final passage of HB 294, PN 318, entitled:

An Act amending the act of April 9, 1929 (P. L. 177, No. 175), known as "The Administrative Code of 1929," further providing for grants and contracts made by area agencies on aging.

On the question recurring, Shall the bill pass finally?

DECISION OF CHAIR RESCINDED

The SPEAKER. Without objection, the Chair rescinds its decision that HB 294 was agreed to on third consideration. The Chair hears no objection.

On the question recurring,

Will the House agree to the bill on third consideration?

Mr. TRELLO offered the following amendment No. A4174:

Amend Sec. 1 (Sec. 2207-A), page 2, lines 3 and 4, by striking out "The area agency shall give preference to nonprofit agencies in the awarding of grants and contracts." and inserting The area agency shall give preference in the awarding of grants and contracts to nonprofit agencies which provide tangible client services. For the purposes of this subsection "tangible client services" shall mean congregate meals, transportation to and from the site of such congregate meals and home-delivered meals provided through area agencies on aging.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, the amendment deals with the language in the act dealing with transportation.

Now, as this House is aware, we have already passed two companion bills - HB 293 and HB 690 - with relatively the same language only pertaining to different categories.

I really do not believe this amendment is necessary, but at the insistence of somebody from the other side of the aisle I am offering the amendment that clarifies a transportation problem. This transportation language that I have in here now specifically designates only transportation provided to and from the site of the congregate meals, and I urge everybody to support the amendment.

The SPEAKER. The Chair recognizes the gentleman from York, Mr. Dorr, on the Trello amendment.

Mr. DORR. Mr. Speaker, I am afraid that the amendment as drawn contains the same problem that we have been dealing with for the last couple of days on this bill.

Members are familiar with what we now infamously call the "section 203 program" because of the problems that we have been having with regulations drafted in regard to that program. One of the many things that is provided under that program in services to the aging is transportation, for example, to senior citizen congregate meal programs. Now as the amendment is drafted, as I understand it, the gentleman would require that preference be given to nonprofit transportation providers in regard to the contracts for providing those services to senior citizens, specifically taking them to meals at senior centers, for example. The problem with that is there are numerous providers out in the Commonwealth who are not nonprofit - in other words, profitmaking providers who serve these senior citizens.

In addition to that, the whole thrust of the section 203 regulation problem is to reduce costs. When you go with this particular kind of amendment involving the transportation, not to speak of the problem in the program in general, you add in the problem of potentially increasing costs to the program, because we are in effect giving priority to someone who might in fact be bidding a higher cost than a profitmaking provider could bid.

Mr. Speaker, I reluctantly indicate that my judgment is the gentleman has not solved the problem we have been dealing

with with the language in his amendment, and I would have to recommend a negative vote.

The SPEAKER. For the second time on his amendment, the Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, I agree with the gentleman on the other side of the aisle. I do not believe the amendment is necessary at all. I think the bill in its original form did not require any amendments at all.

The amendment was drafted for the second time at the request of the other side of the aisle, and both times they found fault in it. So I do not believe the amendment is necessary at all, but I think what you do in this amendment is entirely up to you. I am going to vote for it, but I urge that we pass the bill. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the amendment, the Chair recognizes the gentleman from Philadelphia, Mr. Linton.

Mr. LINTON. Thank you, Mr. Speaker.

Mr. Speaker, unfortunately, my interpretation of the amendment is the same as Representative Dorr's, and the concerns that I raised last week in regard to the previous amendment unfortunately have not been addressed, once again, in this amendment.

As has been indicated, we have been working very hard on the shared-ride 203 regulations. I have a concern that in this particular amendment you may in fact escalate the costs of those services, and one of the problems we are having now is the escalating costs within the shared-ride program.

So I once again have strong feelings; in fact, I am opposed to the amendment as it is currently drafted and would have to vote in the negative. Thank you, Mr. Speaker.

The SPEAKER. On the amendment, the Chair recognizes the gentleman from Allegheny, Mr. Preston.

Mr. PRESTON. Thank you, Mr. Speaker.

I am going to support the Trello amendment. I am going to support the Trello amendment because I care about some senior citizens within Allegheny County. There are many people who will lose an awful lot of personal touch, and to vote against the Trello amendment, you will be showing disrespect to an awful lot of senior citizens who will lose an awful lot of personal touch as far as the Meals On Wheels program. It was not our fault, per se, that through a contractual procedure and through a bidding procedure, that for-profit companies - companies that would not give personal attention to an awful lot of people who receive these meals - received the bid; people who just dropped off the meal, left it at the door, did not check upon the people. And we want that personal care within Allegheny County.

I do not know if that exists in your county, but I am asking you for your help. If you care about senior citizens, if you care about the care and the health and the welfare of the senior citizens like I care about those in Allegheny County, you will vote for the Trello amendment. Thank you.

The SPEAKER. The Chair thanks the gentleman.

Will the House agree to the bill on third consideration as amended?

Bill as amended was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On final passage, the Chair recognizes the gentleman from York, Mr. Dorr.

Mr. DORR. Thank you, Mr. Speaker.

Mr. Speaker, the gentleman's concern is, of course, laudable, and I think that is what we are all here about in the process of adopting this bill. The question really becomes, do you want these services provided broadly or do you want them provided somewhat more narrowly? The funds involved in providing these services are limited, like every other program that the Commonwealth provides, to the extent that we increase the cost of providing these services; we decrease the number of services or the amount of services that can be provided. Therefore, fewer senior citizens are going to be able to utilize the services involved if in fact we increase the cost.

Now, I am a booster, as are, I am sure, most of us, of non-profit agencies. I am not sure, however, that it is appropriate for us in these circumstances with limited funds to insist that we give the contracts or even make a preference to nonprofit agencies which may in fact be bidding very substantially more dollars for the same service as some profitmaking—hopefully profitmaking—small business person can provide. If we can provide the services at less cost, we are going to be able to provide more services. So in my judgment, those who want to help our senior citizens will not support this bill as it stands today. Thank you, Mr. Speaker.

The SPEAKER. On final passage, the Chair recognizes the gentleman from Mercer, Mr. Robbins.

Mr. ROBBINS. Mr. Speaker, may I interrogate the maker of this bill?

The SPEAKER. The gentleman, Mr. Trello, indicates he will stand for interrogation. The gentleman, Mr. Robbins, is in order and may proceed.

Mr. ROBBINS. Mr. Speaker, if two nonprofit agencies would bid on this program, say the Meals On Wheels or mental health or community health services or some other agency out there, how would they make the determination at that time who receives the bid?

Mr. TRELLO. That has nothing to do with the original language in the bill. What the original language in the bill deals with is the current Meals On Wheels programs that are in operation today, the volunteers. Under directive 8312 by former Secretary Gorham Black, he issued a directive that would mandate that even those programs must put their programs out for a bid period. The volunteers, if you remember back in 1983, came here in full force saying, you are eliminating the volunteer program.

These series of bills were designated just to help the volunteer programs, period, that do the cooking and delivering of the meal. I certainly believe that this is really getting out of hand, and there is some misunderstanding as to the original intent of the bill. This has nothing to do with what you are saying. It deals directly with the volunteer programs that

deliver the meals on wheels to our senior citizens, period, and it just eliminates them from competitive bidding when they themselves are involved in a dispute such as that.

Mr. ROBBINS. Mr. Speaker, I am well aware of that, but I am still asking the question that if another nonprofit agency came in and in fact was competitive with whatever was being paid and wanted to do it for less, who would make the decision and how would it be made?

Mr. TRELLO. Well, my answer to that is it has never happened, and I would not have any idea what would happen if it did take place. It has never happened before. The Meals On Wheels are in an area all by themselves. Mental health does not deal with delivering meals to senior citizens.

Mr. ROBBINS. Mr. Speaker, may I comment on the bill? The SPEAKER. The gentleman is in order, and he may proceed.

Mr. ROBBINS. Mr. Speaker, in one of my counties the contract for this program was given to another agency which was nonprofit. That agency about 9 months into the year ran out of money, and the county had paid; all the money was supposed to be paid for the annual program. The county then was faced with the problem of paying for the additional Meals On Wheels or whatever other programs were out there for our senior citizens. That caused quite a stir in the local community, and I certainly think we ought to consider that, that in fact there are other agencies out there trying to get into the business and trying to get the money that is available, and I am certainly concerned about that. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Montgomery, Mr. Fox, on final passage.

Mr. FOX. May I interrogate the maker of the legislation?

The SPEAKER. Mr. Trello, the gentleman, Mr. Fox, wishes to interrogate you. The gentleman, Mr. Trello, indicates he will stand for interrogation. You are in order; you may proceed, sir.

Mr. FOX. In relation to the bill, Mr. Speaker, I was wondering, as a followup to Representative Robbins, with regard to Meals On Wheels or any other provider of this particular service, would it not be advisable to add to the provision that it be at the lowest cost?

Mr. TRELLO. I cannot hear you. I am sorry.

The SPEAKER. Restate the question, please.

Mr. FOX. Thank you, Mr. Speaker.

I was stating, with regard to a followup question to Representative Robbins, would it not be advisable to add to the language of the bill where the provider is also at the least cost for the purposes of senior citizens so that they are getting the maximum benefit of service for the least amount of money?

Mr. TRELLO. Well, I think there is a terrible misunderstanding here.

Without the amendment what this bill does, it eliminates the volunteer programs from the competitive bidding process. It leaves that cap, that \$4,000 cap, is what it does. It is a series of bills, and they all come down to maintaining the volunteer program that delivers meals on wheels.

Mr. FOX. Is there no cost for the meals on wheels to the seniors?

Mr. TRELLO. They do not bid. That is what I am trying to tell you. The package of bills that was introduced eliminates the volunteer Meals On Wheels programs from competitive bidding.

Mr. FOX. Okay. I have no further questions, Mr. Speaker. The SPEAKER. On final passage, the Chair recognizes the gentleman from Philadelphia, Mr. Linton.

Mr. LINTON. Thank you, Mr. Speaker.

Would the gentleman, Mr. Trello, stand for a brief period of interrogation, please?

The SPEAKER. The gentleman indicates he will so stand. You are in order, and you may proceed, sir.

Mr. LINTON. Mr. Speaker, it seems to me that your bill as currently drafted, or the bill that we are currently getting ready to vote on, would in fact create a problem for the shared-ride program. I want you to follow my line of reasoning to see if I am accurate on this.

As we have indicated, many of the Triple A's contract for third-party reimbursement with private providers to transport senior citizens back and forth to their various centers for congregate meals. Currently they operate on a low-bid basis. One of the problems we have is escalating costs in the shared-ride program. As we indicated earlier, Mr. Speaker, many of the senior citizen centers, Triple A-authorized agencies, operate congregate meal programs where they transport senior citizens to their various centers utilizing the 203 program. In doing so, they contract out for third-party reimbursement with private providers. Now, under your bill, would those senior citizen centers now have to give preference to nonprofit providers in contracting those services?

Mr. TRELLO. Well, first of all, before I answer your question, the original language in the bill did not deal with transportation at all; in no way did it deal with transportation. The original bill dealt with preparing the meals and delivering them. It had nothing to do with transportation. An argument from the other side of the aisle indicated that we should clarify that language on transportation, and I did it twice, and I did it the best I could, and I just cannot seem to agree. The amendment passed. It would be all right with me if the amendment was taken out, because I am not even dealing with transportation; I am dealing with volunteers who prepare the meals. So to answer your question, you know, I do not know what that does; what the amendment does. You can interpret it any way, you know; you can interpret it both ways, I guess.

Mr. LINTON. Mr. Speaker, but it is my understanding, from reading the section which you are amending, it says—and this is the bill itself, not the amendment, and I guess that is subsection (d)—it says, "The area agency may grant to or contract with any public, private or nonprofit agency for the provisions of social services." Now, in your amended section, "The area agency shall give preference to nonprofit agencies in the awarding of grants and contracts." So it seems to me that that does not eliminate transportation services and that does not only deal with providing meals on wheels, but it is

comprehensive and it would affect any social service connected agency, which would mean transportation.

Mr. TRELLO. Well, it could mean a lot of things, and I guess if you insist that it does, then I am sure it does. But the prime purpose of the bill was to deal with the volunteers who prepare the meals and nothing to do with transportation whatsoever. That is the best I can answer.

Mr. LINTON. Thank you, Mr. Speaker.

May I make a brief statement?

The SPEAKER. The gentleman is in order, and he may proceed.

Mr. LINTON. Mr. Speaker, once again, I support Representative Trello's intent in the legislation, but unfortunately, over the last several months I have chaired a task force of this House to look into the shared-ride 203 program. In chairing that task force, we went around the Commonwealth and we received testimony from senior citizens. Most of you have probably received mail from senior citizens about the potential loss of their shared-ride program, and my concern with that program has to be the escalation of costs. If the costs escalate in that program, then we will be eliminating that program and you are going to have senior citizens once again coming to this legislature pressuring you, all of you, to make sure that their shared-ride program stays in existence.

Now, if this bill is passed, it is my understanding that what you are going to do once again is feed into and contribute to the escalation of those costs. If those costs escalate, once again we are going to be faced with a situation of not having dollars to pay for those services. Once again, that is going to mean that there will be a threat to once again try to come up with some regulations or cost-cutting provisions in the 203 program. My concern is, I do not want to see anything that is going to threaten that lifeline to the senior citizens. So, therefore, I am going to ask for a negative vote on this bill.

The SPEAKER. On final passage, the Chair recognizes the gentleman from Allegheny, Mr. Preston.

Mr. PRESTON. Thank you, Mr. Speaker.

I rise in support of HB 294. You are going to have a choice-either you want to support for-profit corporations, or you can vote for the Trello bill and you can support those volunteer agencies that work hard for the people out there in your area. That is going to be your simple choice. Should anything add on, I think that we in the House should take care of it. However, I agree with Representative Trello. Throughout the bill and throughout the testimony I have heard, all that we have heard about is the lack of concern through an edict by former Secretary Black that willingly gave contracts to forprofit corporations without any consideration at all to the volunteer agencies that were presently doing the job. There was no consideration at all for these contracts, whether or not they could do it cheaper, more efficiently, and with much more attention

Now, that is the question that concerns me as far as HB 294. That is what you are going to be voting on - whether or not we are going to give this business to for-profit corporations or whether or not we are going to give it to those people

who care, the volunteer agencies within your own communities, and that is who you are going to be voting against. To vote against HB 294 is going to be voting against those volunteer agencies that go out and help as far as the Meals On Wheels programs. So I am going to ask you to vote for HB 294. Thank you.

The SPEAKER. On final passage, the Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, HB 294 does the same as two other bills that passed with no negative votes here in this chamber - HB 293 and also HB 690. The purpose of this legislation was due to the number of volunteers who protested a directive, 8312, that would possibly eliminate the volunteer program. I had three hearings on the Meals On Wheels program back in 1984, in Harrisburg, Pittsburgh, and also in eastern Pennsylvania. All the senior citizens who testified—and there were a number; as a matter of fact, in the Harrisburg area there were about 20 or 30 busloads protesting the directive and the possibility of eliminating the volunteer program. And that is all this bill deals with, the volunteer program.

I can understand Representative Linton's problem in regard to shared rides, and I share his sentiments on the shared rides, but my primary concern with this bill is to make sure that we maintain the volunteer program that was in existence 10 years before the government even got into the Meals On Wheels business. What this guarantees is that when a person delivers a meal to our senior citizens, they do not only drop it off at their doorstep but they knock on the door and make sure that they are alive and well and able to receive and eat that meal. That is what the volunteers were concerned about - the health, safety, and welfare of the recipient. This bill will guarantee that the volunteer service programs will still exist as far as the Meals On Wheels program is concerned, and I urge you to vote for the bill. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from York, Mr. Dorr.

Mr. DORR. Mr. Speaker, the amendment clarifies subsection (6) of the bill and basically takes it to a situation where notice is provided to the applicant for a subdivision approval. Under the bill, an applicant for subdivision approval would have had to wait until the Transportation Department acted before the subdivision could be approved, and in a minute we will talk about building permits. This amendment provides adequate notice so that an individual who has to get a driveway permit will know that he has to get a driveway permit, but he will not be held up from going forward if in fact he is certain that his driveways meet warrants and that he can get that permit. He is not going to be held up by the bureaucracy in attempting to get his permit before the subdivision is approved.

I do not know how many of the rest of the members, Mr. Speaker, have been plagued recently by requests from constituents for assistance in moving one department or another in the process of issuing permits of various kinds, but I know that my office faces that constantly and I do not think it is necessary to go to the extent that this bill does in order to solve the problem or whatever problem might be out there with respect to these driveway situations. I think we can do it with a notice, trust that people who are old enough and mature enough to be building developments will have the good sense to know whether or not they should proceed or not

without requiring that they go to the department for a permit in advance.

Mr. Speaker, that is the basis of the amendment. The only other point that I want to make is that in the bill, notices are provided by the department to the municipality in these situations, and the amendment requires that in addition to notifying the municipality, the department will have to also notify the applicant of the action that it has taken. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Will the House agree to the amendment?

The clerk read the following amendment No. A4174:

Amend Sec. 1 (Sec. 2207-A), page 2, lines 3 and 4, by striking out "The area agency shall give preference to nonprofit agencies in the awarding of grants and contracts." and inserting

The area agency shall give preference in the awarding of grants and contracts to nonprofit agencies which provide tangible client services. For the purposes of this subsection "tangible client services" shall mean congregate meals, transportation to and from the site of such congregate meals and home-delivered meals provided through area agencies on aging.

On the question recurring,

Will the House agree to the amendment?

The SPEAKER. This is the amendment which the House had just previously adopted. Unless there is additional debate on it, the question is, will the House adopt the Trello amendment?

The Chair recognizes the gentleman from Allegheny, Mr. Trello, on the amendment.

Mr. TRELLO. Mr. Speaker, the amendment was intended to clarify some language in regard to HB 294, and for some reason or other there was a misunderstanding on the transportation problem. The bill itself does not directly deal with transportation problems; it strictly deals with volunteers and Meals On Wheels. If there is a misunderstanding— I believe the bill would be a better bill without the amendment, and I have no problem with anybody voting against the amendment.

AMENDMENT WITHDRAWN

The SPEAKER. Does the gentleman, Mr. Trello, wish the question to go to a vote? Or is he requesting to withdraw the amendment?

Mr. TRELLO. I request that the amendment be withdrawn and we vote on the bill.

The SPEAKER. The amendment is withdrawn.

On the question recurring,

Will the House agree to the bill on third consideration as amended?

Bill as amended was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On final passage, the Chair recognizes the gentleman from Crawford, Mr. Merry.

Mr. MERRY. I would like to interrogate the maker of the bill, please.

The SPEAKER. Mr. Trello indicates he will stand for interrogation. You may now proceed, Mr. Merry.

Mr. MERRY. Mr. Speaker, in your previous debate you mentioned a number of times that this bill only applies to volunteers. Now, my understanding of a volunteer is somebody who does not accept pay. So how does this equate into language that says that they will be the preferred bidder?

Mr. TRELLO. The language in the bill specifically deals with those volunteer programs and competitive bidding as far as the Meals On Wheels programs are concerned; the volunteers themselves. The other services that are provided by Adult Services, there is no problem with the competitive bidding there, but the language in the series of bills, and you have to have all three bills in front of you to understand what I am talking about - HB 293, HB 294, and HB 690 - but this eliminates the volunteers who deliver the meals from competitive bidding on the meals program. It has nothing to do with transportation or any other program.

Mr. MERRY. I still may have missed the point, or you have missed it. If it has nothing to do with the bidding provision since they are volunteers, why do we have the bill before us?

Mr. TRELLO. Pardon me?

Mr. MERRY. Why do we have the bill before us if it has nothing to do except for volunteers?

Mr. TRELLO. Well, that is why we have the bill before us. It eliminates— Let me read the language to you. "The area agency is authorized to use, with their consent, the services, equipment, personnel and facilities of Federal and State agencies, with or without reimbursement...." It eliminates the volunteer organizations that have been created throughout the State of Pennsylvania from the competitive bidding.

Mr. MERRY. You are saying then that normally there is some provision for expenses or for some remuneration, even though they are volunteers?

Mr. TRELLO. Those programs will go on as the language states in the original act, but what I am directing this bill at is the volunteer services that are provided by the Meals On Wheels program that have these programs from competitive bidding on the meals segment only.

Mr. MERRY. I am still having difficulty. My point of questioning is this: If volunteers are involved, why would they then not normally be the lowest bidder anyhow? Because even if they were getting expenses or a small remuneration, why would they not be the preferred bidder?

Mr. TRELLO. Well, you know, the Federal Government sets aside block grants for each State to be provided to each county to be used for the Meals On Wheels program. What happened was that with directive 8312—this all deals with 8312—the former Secretary indicated that all the Meals On Wheels should be put up for competitive bidding, which in most cases would eliminate the volunteers who deliver the meals, and that is what this language is directed at.

Mr. MERRY. Why would it eliminate the volunteers? Why could they not still put in a zero bid?

Mr. TRELLO. I do not understand what you are saying about a zero bid.

Mr. MERRY. Well, if they are volunteers, they are not being paid.

Mr. TRELLO. That is correct.

Mr. MERRY. And why can they not bid on it as for a dollar per cut?

Mr. TRELLO. It has nothing to do with the volunteers per se; it has something to do with the price per meal that they get from the Lutheran Services that deals with Allegheny County.

Mr. MERRY. Okay. I will accept your word on that.

What about these other two bills? Do they have some relationship to this - HB 293 and HB 690?

Mr. TRELLO. Each bill is directed to a different act as it pertains to counties and local organizations. HB 293 deals with the counties. It amends the County Code and would eliminate the competitive bidding for the Meals On Wheels program.

Mr. MERRY. Why are we not looking at this as a package rather than an individual bill then?

Mr. TRELLO. Pardon me?

Mr. MERRY. Where are the other bills? How come we are not looking at them all at the same time today?

Mr. TRELLO. Well, unfortunately, the three bills went to three different committees and each committee acted on them differently. The Finance Committee bill came out and was passed and was signed by the Governor. The Transportation bill came out and was passed and was signed by the Governor. This bill was assigned to another committee that decided to act on it just several weeks ago.

Mr. MERRY. Okay. Thank you, Mr. Speaker. I have no further remarks.

The SPEAKER. The Chair thanks the gentleman.

On final passage, the Chair recognizes the gentleman from York, Mr. Dorr.

Mr. DORR. Mr. Speaker, I again reluctantly rise to oppose the bill, and it is on the same premise that I did before, so I suppose I do not need to be lengthy.

The point, basically, is this: If you have a limited amount of money, then you provide more services the cheaper you can provide the service. When you limit the ability of the payer to obtain the cheapest bid, as this bill does, then you potentially cost the program more. The result of that is that fewer senior citizens receive the services. So again, if we want to benefit the most senior citizens with these types of programs, my judgment is that we do not limit the ability to take the lowest bid provided, and I reluctantly, therefore, oppose the bill.

The SPEAKER. On final passage, the Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, Representative Dorr is 100 percent right, as far as competitive bidding is concerned. It would provide cheaper meals to the recipients of Meals On Wheels, but here is the problem. The problem is the health, safety, and welfare of the recipient. The senior citizens' organizations throughout Pennsylvania feel that if a caterer or private industry gets the bid to deliver these meals, they will

have no concern for the health, safety, and welfare of the recipient, whereas the volunteers have a code network throughout Pennsylvania that guarantees that when they deliver that meal, the recipient is going to be alive and well and able to receive it. They figure you cannot put a price tag on that type of service, people who care about the recipient, and that is why the bill is drafted - to maintain that line of communication between the recipient of the meal and the person who delivers it.

I encourage everybody to vote for the bill. Thank you.

Shall the bill pass finally?
