COMMUNICATIONS FROM GOVERNOR

BILLS SIGNED BY GOVERNOR

The Secretary to the Governor presented the following communications from His Excellency, the Governor:

APPROVAL OF HBs Nos. 784, 1000, 1345 and 1402.

Commonwealth of Pennsylvania Governor's Office Harrisburg

February 19, 1986

To the Honorable, the House of Representatives of the Commonwealth of Pennsylvania

I have the honor to inform you that I have this day approved and signed House Bill 1000, Printer's No. 2932. This legislation amends the Election Code to eliminate cross-filing by statewide judicial candidates, clarify existing provisions on the creation of new election districts, ballot questions and revise rules for the nomination of certain candidates.

This is the third bill affecting the subject of cross-filing which the General Assembly has passed by overwhelming margins during my current term as governor.

I vetoed both previous bills because they eliminated cross-filing for school directors, local judges and district justices and because they would have allowed political activity by district justices, raising serious constitutional concerns by overriding court rules limiting political activity by judicial officers. I believe cross-filing for these offices has been somewhat successful in providing for non-partisanship and I am pleased that those provisions which I opposed have been removed from this legislation.

The two previous bills which I vetoed also provided, as this legislation does, for the elimination of cross-filing for statewide judicial candidates. I stated in my messages on these bills, and continue to strongly believe, that the preferred way to select all judges and justices is through the merit selection process utilized by the overwhelming majority of states today.

I have advocated this kind of constitutional reform for over 20 years as I believe it would encourage the best-qualified candidates to seek positions on our appellate courts. The enormous costs and rigors of sustaining a statewide election campaign have deterred many of our most capable attorneys and lower court judges from seeking appellate judgeships. The process of gaining political endorsements and raising campaign funds can endanger judicial independence and impartiality and adversely affect public confidence in the judiciary. The current system also poses increased difficulties for minorities, women and those from rural areas who seek statewide seats.

However, as I also explained in my previous messages, I recognize that cross-filing has not worked as effectively for statewide judicial candidates as it has for local offices. Unlike candidates for county and local offices, those seeking statewide office are generally not as well-known to the electorate. Factors such as name recognition, ballot position, regionalism and funds available for campaign advertising have unduly influenced the selection process.

In summary, while I continue to believe merit selection is preferred over any other system for selecting judges and justices and will continue to work for institution of such a system, I believe that elimination of cross-filing for statewide judgeships is to be preferred over the current system. For this reason and because other provisions in this legislation are needed, I am affixing my signature to this bill.

To the Honorable, the House of Representatives of the Commonwealth of Pennsylvania

I have the honor to inform you that I have this day approved and signed House Bill 784, Printer's No. 2848, which reenacts the Regulatory Review Act until December 31, 1986. Although I continue to support regulatory reform vigorously, I feel it is necessary to express two reservations I have regarding this legislation.

First, I am concerned that provisions of the act which allow a single chamber of the General Assembly to veto proposed regulations may violate important provisions of the Pennsylvania Constitution which require legislative action to be taken by both the House and the Senate and which require presentation of legislative resolutions to the governor for review and approval. The United States Supreme Court found similar provisions of federal law to be unconstitutional in Immigration and Naturalization Services v. Chadha, 462 U.S. 919 (1983). These provisions of the law should be revised, together with eliminating other technical deficiencies of the current law, prior to extending the law beyond December 31, 1986.

Secondly, as revised by the state Senate, this legislation now requires that the Independent Regulatory Review Commission shall first and foremost make a determination that [a] . . . proposed regulation is not contrary to the statutory authority of the agency and the intention of the General Assembly in the enactment of the statute upon which the proposed regulation is based." I am concerned that the commission not misconstrue this language to authorize the agency to make determinations regarding the form and legality of regulations which are more properly the function of the General Counsel, the Attorney General and the courts. Instead, the commission should focus its review on the question of whether proposed regulations are in the public interest and are consistent with the overall legislative intent and purpose of enabling statutes. This matter has been discussed with the former and future designated members of the commission. They concur that this language would not authorize the commission to become an arbiter of the form and legality of regulations. Prior to extending the law beyond its December 31, 1986 sunset date, the proper scope of the commission's authority should be carefully defined.

BILL ON FINAL PASSAGE

Agreeable to order,

The House proceeded to the consideration on final passage of **HB 2040**, **PN 2775**, entitled:

An Act authorizing the Department of Labor and Industry to make grants for projects which provide employment opportunities for certain individuals; and making appropriations.

On the question recurring, Shall the bill pass finally?

The SPEAKER. On final passage, the Chair recognizes the gentleman from York, Mr. Dorr.

Mr. DORR. Mr. Speaker, the legislation before the House is basically designed to provide job training for transitionally needy welfare recipients who have multiple barriers to employment. Mr. Speaker, there is an existing program in the Department of Labor and Industry which does exactly the same thing. It works with the local private industry councils, and about 1,300 general assistance recipients have been benefited through this program.

Actually, Mr. Speaker, not only does this particular bill duplicate an existing program in the Department of Labor but it also duplicates programs that were contained in HB 2035, which passed this House the last time we were in session. The legislation requires no coordination, and that is actually a very important part of what we should be doing here.

Lastly, and perhaps most importantly, Mr. Speaker, the legislation is faulty in its requirements as to distribution of the funds. The way this bill is drafted, the funds may very well go into counties which cannot use the funds. It is designed so that the funds will be distributed based on the number of transitionally needy recipients in each district, in each county, and that, Mr. Speaker, does not relate in any way necessarily to the number of persons eligible for this program, which involves multiple-barrier persons.

So, Mr. Speaker, I am asking the members of the House to vote in the negative on the bill.

The SPEAKER. On final passage, the Chair recognizes the gentleman from Allegheny, Mr. Preston.

Mr. PRESTON. Thank you, Mr. Speaker.

Will the gentleman, Mr. Dorr, stand for interrogation? I have some questions.

The SPEAKER. The gentleman, Mr. Dorr, indicates he will so stand. The gentleman may proceed.

Mr. PRESTON. Mr. Speaker, you made a statement concerning that there would be some counties that would get money that could not use the money. Could you elaborate a little bit further on that to me, please?

Mr. DORR. Yes, Mr. Speaker. The bill requires that funds be allocated to service delivery areas approximately in proportion to the relative percentage of the Commonwealth's transitionally needy population residing in that service delivery area. On the other hand, the persons who might benefit from that program are required to have multiple barriers to employment in addition to being in the transitionally needy category. Therefore, we have two separate requirements involved, and the requirement as to disbursement of funds may require funds going into some area that has very few transitionally needy persons with the multiple-barrier requirement.

Mr. PRESTON. I notice that you said "may" versus your first statement that there would be counties that would. In other words, what you are saying now from the questions that I asked is that that might be the case but it does not have to be the case. Am I correct?

Mr. DORR. It depends, Mr. Speaker, on the number of multiple-barrier persons available. The bill requires that the funds go into the counties based on the number of transitionally needy, and we do not know the number of multiple-barrier persons who are in those various districts.

What I said initially was, it is not necessarily proportionate to the number of multiple-barrier candidates.

Mr. PRESTON. Okay. So now you are saying that it is not necessarily or it may happen, but you are not saying that it definitely would happen. Correct? Yes or no, sir.

Mr. DORR. Mr. Speaker, what the gentleman said is correct. I am indicating that the way the bill is drafted, it may require funds to go into some counties which cannot use those funds. It may be important for the members to know that the definition of "transitionally needy" may exclude a good many people who are listed under the multiple-barrier requirements. The two definitions are mutually exclusive in some areas.

Mr. PRESTON. You also mentioned the private industry council and possibly a duplication of services, and I think you mentioned about 1,300 people who had possibly been served by this. Yet I look at my analysis and it says here that it would possibly help 5,100 people. Can you explain to me why you are stating that one is 1,300 people but yet in a sense I am looking here at figures of helping 5,100?

Mr. DORR. Certainly.

Mr. Speaker, the number that the gentleman indicates is a prospective number; that is, the number who may be served under this bill. The number I mentioned - 1,300 people - is the number who have already been served under the existing program.

Mr. PRESTON. Will you tell me how long this existing program has been in existence?

Mr. DORR. I do not have that information in front of me, Mr. Speaker. My guess would be about 2 years.

Mr. PRESTON. So in other words, in 2 years 1,300 people have been processed through this system.

Can you tell me what involvement the private industry council has with the relationship of these programs?

Mr. DORR. As I understand it, Mr. Speaker, in the existing program the private industry councils are utilized to coordinate the servicing of the clients. Private industry councils provide the jobs, provide the processing, and so forth.

Mr. PRESTON. So if the local private industry councils are involved in this, would you not say that the State private industry council also monitors the total system?

Mr. DORR. I am not familiar with how that relationship works, Mr. Speaker, but my assumption would be that you are correct, that the State private industry council would have oversight and would gather statistics and so forth relating to the local private industry council operations.

Mr. PRESTON. Also, would you not probably say, therefore, that the statewide private industry councils would be monitoring the distribution of funds in case those counties that happen to get some money that really cannot use it or they have already had a track record that there are certain sur-

pluses that are available, that these funds would possibly be redistributed?

Mr. DORR. Yes; I would hope so, Mr. Speaker.

Mr. PRESTON. So in other words, what you are saying is in the past where certain counties may get this money there are certain entities appointed by the Governor—as far as a private industry council—to be able to monitor these away from the general administration so that these funds could be more equally distributed should these certain cases happen. Am 1 correct?

Mr. DORR. I am sorry. I could not hear the question, Mr. Speaker.

The SPEAKER. Repeat the question, please.

Mr. PRESTON. Thank you, Mr. Speaker.

In other words, from your previous statements, Mr. Speaker, about where counties may get money that really do not have to use it or do not need it at that time because of certain overages, that with the monitoring of the private industry council—which is appointed primarily by the Governor—and the local filing of the local private industry councils, they would be able to be in touch more with the administration to be able to inform them that certain counties are getting more than they should and these funds should be able to be redistributed so they can monitor themselves more closely. Am I correct in that?

Mr. DORR. If you are advocating that, Mr. Speaker, I agree with you. The problem is the bill is written so that that could not in fact take place. The bill requires that the funds be distributed, and again, Mr. Speaker, if I may read from the bill, "Funds shall be allocated to service delivery areas approximately in proportion to the relative percentage of the Commonwealth's transitionally needy population residing in the service delivery area..."

Mr. PRESTON. Thank you, Mr. Speaker.

May I speak on the bill, please?

The SPEAKER. The gentleman is in order and may speak on final passage.

Mr. PRESTON. Thank you, Mr. Speaker.

I am going to ask the members to support HB 2040. I have heard several statements by my good colleague, Mr. Dorr, that leave an awful lot of gray areas, but truly there are checks and balances to be able to assist these people. I wish the members to note that we are talking about transitionally needy. A lot of these people are people who used to work in your districts; who have been laid off from jobs; who were on unemployment and have run out of unemployment benefits. These are people—a lot of them—who have been in the workforce, who have participated in supporting the tax base of this State of Pennsylvania. I am going to ask you to support these people and to support this bill.

I think that when we can talk about instead of 1,300 people and approximately, who knows, in 2 years when we can clearly define and put enough money in for 5,100 people, which is not an awful lot of people in the Commonwealth of Pennsylvania who are presently in a transitionally needy capability, that we have a chance to vote and appropriate some

funds to be able to help those people who have gone from unemployment; who have gone from needing some form of assistance to put them on a viable marketplace for training, for employment so that they can be back on the tax rolls and support themselves so we can go on to helping some other people. Remember what I am saying - a lot of these people have run out of unemployment benefits. A lot of them are able-bodied and have run out of some of their welfare situations as far as 3 months. So what we are trying to do here is put them in a place where we can help them and put them to be able to help themselves. So let us vote "yes" for HB 2040. Thank you very much.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
