The SPEAKER. The Chair recognizes, from Jefferson County, Representative Smith.

Mr. S. H. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, the amendment before us has to do with the committee approval of regulations. When the regulations come to each standing committee, presently if the committee does nothing, then those regulations are deemed approved. In essence, what I would like to do is say that the committee should be made to make a decision - either approve or disapprove. Now, it should be noted that approval or disapproval of any proposed regulations by, say, just the standing committee in the House or just the standing committee in the Senate would not prohibit or stop those regulations from going into effect. It could if IRRC were to choose to interpret it that way, but by itself it would not singularly prohibit those regulations from taking effect.

I believe that some of the argument might be that we already have enough work on our hands with the regular committee work and by being forced to make a decision on any regulation that comes before the committee, before our respective standing committees, that it would just be an over-

load, and yet I feel that a lot of our problems that we are faced with come because we are not fully aware of the regulations that went into effect. In other words, regulations just keep coming out of the departments. We do not keep track of them until after the fact when our constituents then beat our ears in because of regulations. It is not the laws that were bad; it was the regulations that caused the problems. I think for that reason we need to have a little more not necessarily control but at least have a little more awareness of just what is being proposed in these regulations.

I realize that at this point— And of course, the whole question of IRRC centers around the separation of the two powers in this case, being the legislative powers and the administrative powers within the Constitution, and I suspect that not just the present Governor but all Governors will kind of flinch at the idea of IRRC existing. By my amendment, we might be trying to exert a little more legislative control over what the administrative body is going to deem as their administrative role. To that I would say that we created the law that allowed the department to develop regulations and that I believe we should certainly be able to reserve the right to look at those more closely, which in fact we have, and that by my amendment, we will thereby be forcing ourselves, as it were, to take a closer look at these regulations.

I ask for an affirmative vote on the amendment. The SPEAKER. The Chair thanks the gentleman.

# **CONSIDERATION OF SB 4 CONTINUED**

The SPEAKER. The question is on the amendment. On that question, the gentleman from Westmoreland, Representative Kukovich, is recognized.

Mr. KUKOVICH. Thank you, Mr. Speaker.

I sympathize with the-

Mr. COWELL. Mr. Speaker, point of order.

The SPEAKER. Will the gentleman from Allegheny, Mr. Cowell, state his point of order.

Mr. COWELL. Mr. Speaker, I consider this a fairly important amendment in terms of how this process is going to work, and it is impossible to hear what the speakers are saying.

The SPEAKER. Will the House please be in order. Members are entitled to have the discussion on their amendments heard by the members of the House. Important amendments, all. Members do not introduce unimportant amendments. Each amendment is an important amendment, and each member who introduces an amendment is entitled to be heard. Will conversations please cease. I am going to get myself one of those little laser guns, and I am going to point out who is talking too loudly.

Will members please be in order. I have not heard the level of noise drop at all since I asked for conversations to cease.

The level of conversation just continues. It is as if Representative Cowell had not asked me to ask the House to be in order, and it is as if I did not ask the House to be in order and for conversations to cease. Please be in order.

Members may proceed with the debate.

Mr. KUKOVICH. Thank you, Mr. Speaker.

I do sympathize with the maker of the amendment's intention. However, I cannot agree to this amendment. I am asking for a "no" vote.

I understand his philosophical concern, but the reality is that 88 percent, in the 6-year history of IRRC, 88 percent of the regulations have gone through, been approved, without any committee disapproval. Many of these regulations are tiny, noncontroversial regulations that the departments have to move in order to conduct business and have no real impact on the intention of the legislation of this House. If we mandate that every single one of these regulations must be voted on by the appropriate standing committee, we will bog down the process, and it will just implode on itself. We do not have the wherewithal. There are certain committees, especially Health and Welfare, which deal with a myriad of regulations constantly. They simply cannot deal with the noncontroversial ones also. The system will no longer work, and the very important issues, the controversial issues, that we might want to block, we will not be able to put in the work effort to deal with those. So although I understand the philosophical leanings of the gentleman on this amendment, the pragmatic reality is that we would destroy the IRRC process.

I would ask for a negative vote.

The SPEAKER. The question is, will the House agree to the amendment? On that question, the gentleman from Allegheny County, Representative Cowell, is recognized.

Mr. COWELL. Would the maker of the amendment stand for interrogation, please?

The SPEAKER. The maker indicates he will stand for interrogation. You may proceed.

Mr. COWELL. Thank you, Mr. Speaker.

Mr. Speaker, it was very difficult to follow your explanation because of the noise in this room. However, if you could clarify, would the impact of your amendment be such that a veto of a proposed regulation would have to be precipitated by similar action by standing committees in both chambers rather than action by a single committee in either chamber?

Mr. S. H. SMITH. My understanding, Mr. Speaker, is that with my amendment, it will simply force the standing committee in the House and the standing committee in the Senate to vote one way or the other and that by that singular action of each respective body, that would not stop the regulations or have any direct cause of action. I believe, Mr. Speaker—and I could be mistaken on this—I believe even if both standing committees in the House and the Senate disapproved regulations, that even with that, I do not believe IRRC would absolutely have to disapprove regulations.

Mr. COWELL. Mr. Speaker, explain to me how my interpretation is wrong, and if you will follow with me my interpretation. I am on page 17, line 25.

The current law says that failure of both standing committees to disapprove a regulation will constitute approval thereof, of the proposed regulation. The legislation before us would change that so that disapproval by a single committee would constitute disapproval. You want to go back to the language that is found in current law. Is that correct?

Mr. S. H. SMITH. I am not sure if I understand exactly what you mean, Mr. Speaker. Essentially, what my amendment would do is, on line 25, it would remove the sentence, "Failure of a standing committee to disapprove a regulation within the 20 calendar days shall constitute approval thereof." It would remove that sentence, thereby leaving the law to read, the critical sentence being, "The standing committee shall notify the commission of approval or disapproval. Along with a notification of approval or disapproval the committee shall convey to the commission and the agency a report which includes,..." and it goes on. So in essence, the law will simply state that the committee is responsible to tell IRRC, we agree or, no, we do not agree with these proposed regulations. It does not, in my interpretation, and it was not my intention to put any additional power into one committee, be it the House or the Senate committee, because of the fact that if, say, the House committee disapproved regulations and the Senate committee approved, IRRC is still free to do whatever it wants anyhow.

The intention of the amendment is to force the committee to make a decision so that we are more aware, so that we are having a little more control over the volume of regulations that come through IRRC, to force us to be aware of that, of the nature and the impact of those regulations, and to make a decision, because of the fact that presently no action indicates approval, and I think that because of the volume that are going through that we are not aware of, certain regulations go into effect that we really were not aware of because of our inaction.

Mr. COWELL. Thank you very much, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Jefferson, Mr. Smith.

Mr. S. H. SMITH. Thank you, Mr. Speaker.

Just one final point. The previous speaker had mentioned that the volume of regulations that were promulgated would bog down the system, and I do not mean this necessarily in a critical fashion of the departments of the State, but I almost believe that if in fact it did bog it down, maybe that would be a benefit of this piece of legislation, because I really think that we are missing a lot of the action that is going on here and that we need to be more aware of these regulations and that the fact that they may bog down the system is not a good enough reason to vote against this amendment. I also believe that in the timeframe that is built into the provision, there is a 20-day requirement to react, so that the committees are thereby forced to take action within a 20-day period in either case.

So I would on those grounds ask for an affirmative vote on the amendment.

The SPEAKER. The question is on the amendment. On that question, the gentleman from Westmoreland, Mr. Kukovich, is recognized.

Mr. KUKOVICH. Mr. Speaker, just finally, very simply, this is going to create a lot of unnecessary work; it is going to take away the discretion from the committee chairs as to what is important and what they should handle and what they should not. We cannot afford to do those things. It is self-defeating. It is even self-defeating to the intention of the maker of the amendment. I think common sense dictates that we vote "no" on this amendment.

The way the bill is drafted presently, it states that the commission, either on its own motion or at the request of any individual, agency, corporation, member of the General Assembly, or other entity, could ask that a regulation or administrative procedure be reviewed, essentially. Then it goes on to say that whenever a committee of the Senate or the House of Representatives shall request a review of a regulation, the commission shall make that review a high priority. I would like to insert after "regulation" that when a committee, a standing committee of the House or the Senate, requests a review of a regulation or an administrative procedure, that the commission will make that a high priority. I just feel that it was a consistent request to ask that the standing committee have, as opposed to just any individual, agency, or corporation. Thank you, Mr. Speaker.

The SPEAKER. The question is on the amendment. The gentleman from Westmoreland, Mr. Kukovich, on the amendment.

Mr. KUKOVICH. Thank you, Mr. Speaker.

In essence, what this amendment does is give the House and the committees a little more power to review these administrative procedures, and the language is such that it will not bog us down. There is still discretion left to the committee chairs. I think that is reasonable.

I would ask for a "yes" vote on this amendment.
