The SPEAKER. The number of members indicating their presence on the master roll call indicates, as well as the minority whip indicates, that there are no leaves of absence from the minority party.

The Chair thanks the minority whip.

#### **BILLS ON THIRD CONSIDERATION**

The House proceeded to third consideration of **HB 952**, **PN 1070**, entitled:

An Act designating the mushroom as the official State vegetable of the Commonwealth.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The lady from Centre, Representative Rudy, seeks recognition and is in order on final passage.

Mrs. RUDY. Mr. Speaker, I would like to speak on final passage.

I rise to bring to the attention of this body several letters that I am in receipt of that are in opposition to the mushroom being the State vegetable. One of the letters is from the Pennsylvania Growers Association, another is from the chairman of the Pennsylvania Commodity Marketing Board, and the other is from the Pennsylvania Department of Agriculture, who also expressed their opposition to the matter.

At this time I would like to read some excerpts from these letters, and the first letter that I am reading an excerpt from is—

The SPEAKER. Will the lady suspend.

Will this House please be in order. There is entirely too much commotion in the aisleways. Members are to take their seats. Conversations are to cease. The lady is entitled to the attention of the House.

You may proceed.

Mrs. RUDY. Thank you, Mr. Speaker.

The first letter is from the Pennsylvania Vegetable Growers Association, and it states:

The Pennsylvania Vegetable Growers Association is opposed to designating the mushroom as the state vegetable. We recognize that Pennsylvania is the leading mushroom producing state and the importance of the mushroom industry to the Commonwealth. However, we do not feel the mushroom is truly a vegetable and therefore should not represent the state's vegetable industry. Mushroom growers are not a part of our association nor do they contribute to Vegetable Marketing and Research Program.

The second letter is from the chairman of the Pennsylvania Commodity Marketing Board, who is Dan Schantz, and this letter states:

As Chairman of the Pennsylvania Commodity Marketing Board, I am very concerned with the suggestion by some to make the mushroom the "State Vegetable". I want it to be on the record that I am totally against this suggestion. A few of my objections are as follows:...Mushroom growers are opposed to joining forces in any way with the Pennsylvania Vegetable Growers. They do not pay any dues to either the Pennsylvania Commodity Marketing Board or the Pennsylvania Vegetable Growers Association which leaves me to believe that they do not consider themselves to be vegetable growers.

The other letter is from the Pennsylvania Department of Agriculture.

The SPEAKER. Will the lady suspend.

This House must be in order. I cannot hear the lady. Her voice will come up here sooner than it will travel to the members to her side.

Mrs. RUDY. As I had stated, the third letter is from the Pennsylvania Department of Agriculture, and an excerpt from that reads:

The Department of Agriculture does not wish to get involved in a scientific debate as to whether a mushroom qualifies as a vegetable. There is no question that the mushroom industry is important to Pennsylvania; and, for that matter, Pennsylvania's growers are world leaders. However, by refusing to be a part of the vegetable marketing program, mushroom growers themselves have cast doubt as to the product's qualifications as a legitimate member of our Commonwealth's vegetable community.

This fact, combined with the strong objection of the above referenced organizations have led us to the conclusion that we cannot support H.B. 952.

And I would like to say that I concur with these groups' thinking on this matter, and I urge the defeat of HB 952. Thank you.

The SPEAKER. The Chair recognizes, from Chester County, Representative Morris.

Mr. MORRIS. I would like to yield to Representative Pitts, Mr. Speaker, and then I would like to speak after that.

The SPEAKER. The Chair recognizes Representative Pitts from Chester County.

Mr. PITTS. Thank you, Mr. Speaker.

Just briefly to respond. As to the one allegation that mushroom growers have not contributed to research, for the lady's information, research on the mushroom industry and on mushrooms has been done by Penn State since 1925, and the mushroom industry has been very cooperative and supportive of these research efforts.

They do have their own trade organization. They do not belong to this small group, the Vegetable Growers Association, but I might point out that they have never been asked to join. I talked to a representative of the American Mushroom Institute, which is the trade organization for the mushroom industry, and they said they would certainly be happy to join if they were asked to join. But they certainly do support marketing to a great degree and research to a great degree and have for many years. In fact, it has been the researchers, the experts at Penn State, for years who have been leading the effort to have consumers call the mushroom and consider it a vegetable, as they do.

The bill is not about symbolism; the bill is about marketing a product, a Pennsylvania product, and as the lady noted, Pennsylvania is number one in the world in producing mushrooms. As you know, the agricultural industry is number one in Pennsylvania. It is more than steel, more than tourism, and the number-one cash crop in Pennsylvania is the mushroom. It is, I think, the only agricultural product that we lead the Nation in. So this industry, having been devastated by foreign imports, with the canning aspect of the industry being almost totally devastated—I think we used to have something like 20 canneries; there are about 4 left—they have had to go to marketing fresh mushrooms. They have done a good job. The last year I have figures for, I think, is 1987. The value of the cash crop then was \$670 million. Now, that is a good, substantial portion of our agricultural economy. This will help them market their product, a unique product that Pennsylvania leads in, and help them promote and market a Pennsylvania product.

So for these reasons, Mr. Speaker, I would urge the House to adopt the bill, even over the objections of a few individuals. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes, from Chester County, Representative Morris.

Mr. MORRIS. Thank you, Mr. Speaker.

I agree with Representative Pitts. The industry has had hard times. This would be one good way to honor it and get more people to eat mushrooms - fresh mushrooms.

I personally am very fond of mushrooms. We do need some marketing help. Mushrooms are good for you. The people that eat food on their table I do not think get into the involvement of Latin names or in whether something is a fungus, a fruit, or a vegetable. The tomato, for instance, is classed as a fruit. I think that all these things are vegetables. They certainly are not animals. They are not running around. We do not carve them up like a beefsteak.

I urge my colleagues on both sides of the aisle to help us out a little bit for a very fine industry in my home county and Mr. Pitts' and several other legislators. Thank you.

The SPEAKER. The Chair recognizes, from Chester County, Representative Hershey.

Mr. HERSHEY. Thank you, Mr. Speaker. I just want to comment on the bill.

I have been involved in the agricultural community for 30 years in various organizations. I want the General Assembly to know that the letters we got from the Vegetable Growers the last day has been a subject of sour grapes for 20 or 30 years, and that should not deter us from voting for this bill to make the mushroom the State vegetable.

I urge your support - an affirmative vote on HB 952. Thank you very much.

The SPEAKER. The Chair recognizes the lady, Representative Rudy, from Centre for the second time.

Mrs. RUDY. Thank you, Mr. Speaker.

In reference to Representative Pitts' remark that the mushroom growers' association has never been asked to be a part of the vegetable marketing program, I consider that to be a fallacy, because the letter that I received from the Pennsylvania Department of Agriculture definitely states that the mushroom growers refused to be a part of the vegetable marketing program of this State of Pennsylvania.

Also, in reference to the fact that Pennsylvania is one of the largest growers of mushrooms in the world, this is probably true, but it involves only a fraction of the number of people compared to the large number of families and individuals involved in growing fresh for market and processing other types of vegetables here in this Commonwealth. Thank you.

The SPEAKER. The question is on final passage. The Chair recognizes the gentleman from Columbia, Representative Stuban, on final passage.

Mr. STUBAN. Thank you, Mr. Speaker.

I rise to oppose the mushroom being the State vegetable of our State. I believe what we are doing here today is— And I would like to say that I eat as many mushrooms as anybody else in the State of Pennsylvania and possibly eat more than a lot of people do; I love them, but I do not believe it is a vegetable. I have had the opportunity to pick wild mushrooms. I believe it is a fungus. I think that is what it should be.

I think what we should do here, if we are going to name a State vegetable, we ought to name something that you could raise across the State of Pennsylvania. Most of the State items that we have named here as State items, we can find them in almost every county in the State. A mushroom is something that is grown in a house somewhere; it is not something that is growing in our environment. I believe it is grown in a controlled environment, and I do not believe it is a vegetable.

So I oppose this piece of legislation and would like to ask for a "no" vote on it.

The SPEAKER. The Chair recognizes, from Montgomery County, Representative Fox.

Mr. FOX. Thank you, Mr. Speaker.

The mushroom has been much maligned this morning. It is a vegetable that grows in the dark and it cannot be here to defend itself, so some of us are here on the floor to speak about its positive aspects.

Let it be clear that a mushroom is eaten as a vegetable. It tastes like a vegetable, it looks like a vegetable, and therefore, it is a vegetable.

Pennsylvania does not have a bigger cash crop than the mushroom. I have received hundreds of petitions from students asking that the mushroom be made the State vegetable, and because it does so much for the economy—even the Department of Agriculture acknowledges it—I ask you to support the bill. Thank you, Mr. Speaker.

The SPEAKER. On final passage, the Chair recognizes, from Luzerne County, Representative Jarolin.

Mr. JAROLIN. Thank you, Mr. Speaker.

Would the maker of the bill please stand for a little interrogation?

The SPEAKER. The gentleman, Mr. Pitts, indicates he will stand for interrogation.

Mr. JAROLIN. Mr. Speaker, is there a scientific name for the mushroom that you are designating as the vegetable?

Mr. PITTS. Mr. Speaker, I cannot hear him. I am sorry.

The SPEAKER. You cannot hear him, and I would venture to say that most members on the floor cannot hear him.

To the right of the Speaker is the mace, and that mace is going to march out of this House in front of the Speaker when the Speaker is unable to hear, and that is about to happen. I cannot believe that members on the floor of the House are not willing to pay more attention to the goings-on on the floor of the House. I have watched on television the Canadian Parliament, and I do not see anyone opening their mouth when speeches are made on the floor of the House. No one is conversing. We have gotten into the habit of conversing on the floor of the House while people are speaking and making points, and that in itself is discourteous. It is certainly discourteous to speak in the loud tones that members of the House speak in. I can hear many of the conversations that go on on the floor of the House, and I can probably repeat some verbatim. This is discourteous to members. I find members on the floor of this House who, when they speak, kind of look up to the Speaker and say, will you please have this House in order, but when somebody else is speaking, they are the worst offenders in the conversations that take place.

Now, let us all be courteous to one another. Let us, if we must speak to our neighbor or to another Representative on the floor of this House, let us do it in voices that do not disrupt, because when everyone does it in voices that do not disrupt, that in itself creates a murmur that is difficult to hear above. I would expect that not everyone will find it necessary to be carrying on conversations at the same time. Now, let us please try to be in order.

The member may proceed with the colloquy and the interrogation.

Mr. JAROLIN. Thank you, Mr. Speaker.

Once again, Mr. Speaker, does this particular mushroom have a scientific name?

Mr. PITTS. Which species?

Mr. JAROLIN. Yes.

Mr. PITTS. There are a number of species.

Mr. JAROLIN. Well, how can you possibly in any way designate a State mushroom if you do not know the name of it?

Mr. PITTS. Well, we are designating a classification. There is no scientific determination of what constitutes a vegetable. As I mentioned to you, the scientific experts at Penn State have been urging this to be considered and do consider it for consumer purposes a vegetable. There are many plant groups that are considered vegetable. Technically, you could say that the tomato is a fruit, but I would suppose you would consider that a vegetable. Technically, the mushroom is a fungus, but it is one of the plant groups considered as a vegetable because we do consume them.

Mr. JAROLIN. During the course of the year, I happen to get out into the woods and pick a lot of different mushrooms, and each and every mushroom that I have ever run across had a specific scientific name. I personally believe that if we are going to designate a mushroom as the State vegetable, it should have a scientific name so we can identify the particular one that the people are growing. I think this would constitute naming the mushroom as a State vegetable.

Mr. PITTS. There is more than one that is cultivated, Mr. Speaker, so you cannot just pick one.

Mr. JAROLIN. Thank you, Mr. Speaker.

I just do not believe there has been enough research on this as a vegetable.

Thank you. I vote "no" against the mushroom.

The SPEAKER. On final passage, does the lady, Mrs. Harper, request recognition on final passage?

Mrs. HARPER. Yes, Mr. Speaker.

The SPEAKER. She is in order.

Mrs. HARPER. Thank you, Mr. Speaker.

I rise to oppose this legislation on making the mushroom the official State vegetable.

I can think of so many vegetables that are far superior in nutrition to the mushroom. Say, for instance, just one; I would just name one vegetable - the cabbage. All of these—Absolutely. Cabbages are grown across this State, and there is no question about the nutrition in cabbage.

We know that the green leafy vegetables are nutritional. I will mention just a few more - the collards, mustard; I can go on and on - but certainly not the mushroom. Thank you, Mr. Speaker.

The SPEAKER. On final passage of the bill, from Cambria County, the Chair recognizes Representative Wozniak.

Mr. WOZNIAK. Thank you, Mr. Speaker.

I rise to oppose the mushroom as the State vegetable. Number one, the mushroom is a fungus, and number two, when you look at all the State things we have, one of the

They are ubiquitous across the State. If we are going to have a State vegetable, let us have it be something that is in the backyard gardens of Pennsylvania and not in some caves.

I oppose it because it is not a vegetable and it is not ubiquitous throughout Pennsylvania. Thank you, Mr. Speaker.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

Section 8. Sections 2702, 2703 and 2711(a) and (b) of Title 30 are amended to read:

§ 2702. Nonresident and tourist licenses.

(a) Nonresident licenses.—For the purposes of this chapter any person 16 years of age or older is entitled to a "Nonresident Fishing License" if:

- (1) He is not a bona fide resident of this Commonwealth.
- (2) He has applied to an issuing agent or to the commission.
- (3) He has paid the issuing agent or the commission a license fee of \$20 plus a service fee of 50¢ to the issuing agent.
- (b) Nonresident junior licenses.—For the purposes of this chapter any person who has reached his 12th birthday but has not reached his 16th birthday prior to the date of application is entitled to a "Nonresident Junior Fishing License" if:
  - (1) He is not a bona fide resident of this Commonwealth.
  - (2) He has applied to an issuing agent or to the commission.
  - (3) He has paid to the issuing agent or the commission a license fee of \$12 plus a service fee of 50¢ to the issuing agent.
  - (4) The age and residency of the applicant is proven by the attestation of a parent or guardian.
- [(b)] (c) Tourist licenses.—For the purposes of this chapter any person 16 years of age or older is entitled to a "Seven Day Tourist Fishing License," valid for a period of seven consecutive days, if:
  - (1) He is not a bona fide resident of this Commonwealth.
  - (2) He has applied to an issuing agent or to the commission.
  - (3) He has paid the issuing agent or the commission a license fee of \$15 plus a service charge of 50¢ to the issuing agent.

On the question,

Will the House agree to the amendments?

The SPEAKER. On the question, the Chair recognizes the gentleman from Perry, Mr. Noye.

Mr. NOYE. Thank you, Mr. Speaker.

Mr. Speaker, my amendment is an issue that we have kicked around this hall for a number of years, and I think now the time has come for us to address this issue. That is the issue of establishing a junior fishing license in Pennsylvania.

The amendment calls for a junior fishing license of \$5. The regulations and the criteria surrounding it are parallel with what is already in law as it relates to a junior hunting license. For years the Game Commission has had the ability not only to license its young hunters but also to acquire Federal dollars, matching dollars, for those licenses sold. The Fish Commission has never had that ability. It is estimated that

338,000 junior licenses will be sold at \$5 each and that for each junior license sold, the Fish Commission will be entitled to \$3.50 in matching Federal dollars per license. The total package would yield just shy of \$3 million in needed revenue by the Pennsylvania Fish Commission.

Mr. Speaker, I urge the adoption of the amendment.

The SPEAKER. The Chair recognizes the gentleman from Erie, Mr. Dombrowski, on the amendment.

Mr. DOMBROWSKI. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose the Noye amendment. I have a serious concern that we are taking the children between the ages of 12 and 16 and now we are making them buy a license. In several of the urban areas, many of these kids do not have much entertainment, and the only entertainment they have now is getting a fishing rod and going down to the dock and throwing the line into the water, and it keeps them busy in the day and it keeps them out of mischief. And for the people in the farm areas, the little kids are going to be going out in the creek and they are going to be fishing now, and all of a sudden some fish warden is going to come along and arrest this little 13-year-old boy or girl for fishing in a creek on his own property.

I think it is a bad amendment, and I think, as the Representative said, for several years they have tried to get this amendment passed and finally maybe they think it is a good time now because they need a little bit of money, but I think there are various other ways to raise money, like in increasing the fines or increasing the fee of the regular fishing license, and try to take care of these children and give these children something to do, and I am just going to ask for a negative vote. Thank you, Mr. Speaker.

The SPEAKER. The Speaker thanks the gentleman.

The Chair recognizes the gentleman from Centre County, Representative Letterman.

Mr. LETTERMAN. Thank you, Mr. Speaker.

Mr. Speaker, I rise to support this legislation. I think the year has come and the time has come when we finally start to realize that we have got to put the license fee on these 12- to 15-year-old young people. They are the ones that kill the fish. They never put anything back. They catch the fish; they kill them. They have not learned respect for the resource, and I think it is time we put a license on them to maybe teach them the respect of the resource that they need. I think that if we do not do this, we are looking at a \$5 increase on a resident fishing license for the other people, and that is unfair also, that they continue to pay for everybody else to fish in this State. I believe that if you go out and you look— And I pity Benny Dombrowski; he has always cried this same game, but Benny forgets that kids today 12 to 15 are committing the most crimes, they are out there with the fishing rod that costs \$60 to \$70, probably have enough dope money in their pockets to buy as much crack as they want, and they cannot afford a \$5 fishing license.

I think it is time we start to realize what this country is all about, and I ask you for an affirmative vote.

The SPEAKER. From Montgomery County, the Chair recognizes Representative Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

I would like to interrogate the maker of the amendment, please.

The SPEAKER. Will the author of the amendment consent to interrogation?

Mr. GODSHALL. Thank you, Mr. Speaker.

Mr. Speaker, this amendment would create a new license category, right?

Mr. NOYE. Yes, Mr. Speaker.

Mr. GODSHALL. What would the fines and penalties be under the new bill for a kid between 12 and 16 for violating this, fishing without a license? Would it be the same as the bill?

Mr. NOYE. It would be the same as the bill, the same as it applies to anybody in violation of the fishing laws of the Commonwealth.

Mr. GODSHALL. I do have a concern about that. As I read the bill, I believe, on page 12, fishing without a license is a summary offense of the third degree, which would be a \$25 fine, and then going to page 4, an additional penalty for fishing without a license is two times the license fee, which would be another \$10, and an additional penalty of \$10 imposed for each fish taken. So if you have a kid along the stream who is 12 years old, went out with his bike and has three or four sunfish, he could have a \$40 fine for having the sunfish or suckers in his possession; he could have another \$10 fine—it would double the license fee, which would be \$5—so that would be \$50, plus an additional \$25 for fishing without a license, which adds up to approximately \$75, plus the cost of prosecution. So a kid who has never had to have a license before, violating this, could be faced with costs of upwards to \$100, very easily, or more, and I do have a concern about that. As I said, since we are establishing a new license category, I think we may have a lot of people, a lot of kids, going out to the streams fishing, that they just do it out of habit and out of force of habit, and with a fee for fishing without a license this large, I think there could be a lot of bad effects, and I probably will oppose this amendment on that basis. Thank you.

The SPEAKER. The Chair recognizes, from Lackawanna County, Representative Staback.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, I stand in opposition to the amendment.

In my area a junior fishing license has become both an emotional and controversial issue, coupled with the fact that this initiative is not something that the Fish Commission is asking for right now, and I think the issue should be dealt with solely on its own merit. I think by attempting to amend HB 650 with this language, you are going to turn a good bill into something totally controversial.

With that thought in mind, I am voting "no," and I ask my colleagues to do the same.

The SPEAKER. The Chair recognizes the minority leader, Matthew Ryan, from Delaware County.

Mr. RYAN. Mr. Speaker, I was going to vote in favor of the Noye amendment, and now I am against it, and I will tell you why.

I have never heard such convoluted reasoning in my life as I heard from the gentleman, Mr. Letterman, in support of an amendment. To suggest that kids from the age of 12 to 16 can afford to pay a licensing fee because they are selling dope and crack and making money at it, I think is an insult not becoming to you and really out of character for you of all these young people. I have always felt and I think you have always felt that you let these youngsters get out into the woods hunting, let them get into the streams fishing, and they are going to have a better life and be better citizens. To suggest that they can afford to pay a fee simply because they are all selling crack and dope and they have plenty of money is absolutely outrageous, and for that reason and that reason only, I am voting against the amendment, because of the words of support offered by the gentleman, Mr. Letterman.

The SPEAKER. On the question of agreeing to the amendment, the Chair recognizes, from Indiana County, Representative Wass.

Mr. WASS. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose the amendment.

HB 650 is a freestanding bill, a bill that is geared to deter violations and not make money. I believe that bill is in order for passage, and I would not want to impact the bill with such an amendment.

Mr. Speaker, I congratulate the maker of the amendment. He is concerned about the funding and the funds that the commission has. The commission is a very, very valuable part of our State, our State's economy, and so I am very appreciative of the amendment, but this is not the time to inject such an amendment.

Mr. Speaker, if the maker of this amendment truly feels that this is the time to add a fee to the young folks that are fishing, let him get a free-standing bill; let him get a free-standing bill and solicit our support, and let us go out and do the job that we should do selling this bill on its merit. It is time and I agree that it is time to take another look at our young people being licensed for many reasons - the benefits that come from the funds and also the supplemental funds as given by the act.

Mr. Speaker, the story has not been told. It is an emotional issue. We must do this correctly. We must tell our people how this impacts. So, Mr. Speaker, I trust that the floor, my colleagues in the House of Representatives, will vote against this legislation at this time, and those of us who are supporting an increase for the Fish Commission, let us stand tall; let us walk tall and get on a freestanding bill, and let us take it out on the road and sell it the way we should in a very educational manner.

The SPEAKER. The Chair recognizes from Berks County, on the amendment, Representative Gallen.

Mr. GALLEN. Thank you, Mr. Speaker.

Would Representative Noye stand for interrogation?

The SPEAKER. The Representative indicates that he will stand for interrogation. You may proceed.

Mr. GALLEN. Mr. Speaker, is this amendment directing that anyone 12 years of age who wants to go fishing must buy a license?

Mr. NOYE. Yes, Mr. Speaker.

Mr. GALLEN. It does not say that, Mr. Speaker. I have to quarrel with that. It says he is entitled to a license. Does that mean that he cannot fish without one? The language of this amendment says he is entitled to a license, entitled to if he pays \$5 plus 50 cents. It does not say that he is required to purchase a license. Is that right?

Mr. NOYE. I stand corrected, Mr. Speaker. That is what it says.

Mr. GALLEN. I suggest, Mr. Speaker, that we have reached a new level of outrageousness in this chamber when we are trying to call a mushroom a vegetable and we are trying to say that little kids have to buy fishing licenses. I think it is ridiculous. I strongly suggest that this amendment be withdrawn if we are at all interested in the bill.

I violently oppose this amendment. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes, from Allegheny County, Representative Levdansky.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, I, too, rise to oppose the Noye amendment. I do so because of two reasons: Number one, if this amendment is passed, it is likely to jeopardize final passage of a very much needed piece of legislation for the Fish Commission. Secondly, if it is true that the Fish Commission needs a revenue enhancement, I think members ought to be aware of the current process that is being undertaken by the Fish Commission to raise revenues. There is presently under discussion a regulation that will put in place a trout and salmon stamp in Pennsylvania to be phased in, if approved, next year. Under that trout-salmon stamp proposal, the Fish Commission will derive significant revenues. I think we ought to wait for that trout-salmon-stamp revenue increase to take effect and to be implemented before we consider legislation such as this.

For those reasons, Mr. Speaker, I oppose this legislation and ask my colleagues for a negative vote.

The SPEAKER. The Chair thanks the gentleman.

#### WELCOMES

The SPEAKER. While the members of the House are deciding whether or not this amendment needs additional debate, let me introduce some guests who are with us and who will probably be leaving for lunch.

The Chair welcomes the Summit Hill Senior Citizens, who are in the balcony, and they are the guests of Representative Keith McCall.

The Chair welcomes Marie Louise Hoyer and Erin Yost. Both are with the "Up With People" group, and they are the guests of Representative Bortner. Will they please stand. In the balcony we have guest Gary Maine, who is the husband and, I guess, the guest of Representative Connie Maine. Will he please stand.

To the left of the Speaker, the majority whip, Mr. DeWeese, has guests Lloyd "Odie" Rohanna, a commissioner in Greene County, and Steven Love, the Greene County business administrator. Will they please stand.

The SPEAKER. I am hoping that all of you took heed of that message and that all of you have this week filed your ethics statement with the Ethics Commission and with the Chief Clerk of the House of Representatives.

The SPEAKER. The gentleman from Perry, Mr. Noye, seeks recognition. For what purpose does the gentleman rise?

Mr. NOYE. Thank you, Mr. Speaker.

Obviously, this is going to create some kind of controversy with the bill. The bill is very important, that we get it through and get it to the Senate, and to avoid Mr. Gallen becoming violent, I will at this time withdraw the amendment.

The SPEAKER. Without objection, Representative Noye, the author of the amendment, asks that the amendment be withdrawn. The Chair hears no objection. The amendment is withdrawn.

On the question recurring,

Will the House agree to the bill on third consideration?

Amend Sec. 8, page 13, line 21, by inserting after "3102," 3106,

Amend Sec. 8, page 15, by inserting between lines 25 and 26 § 3106. Classification of lakes.

- (a) Class A.—A lake that is wholly opened to the general public for fishing and is operated solely as a commercial venture may be issued a Class A regulated fishing lake license. Persons patronizing a Class A regulated fishing lake may catch, kill and possess fish without regard to any size, season or possession limit and need not possess a Pennsylvania fishing license. All other provisions of this title are applicable.
  - (b) Class B.-
  - (1) Lakes that meet all other requirements of this section but are not open to the general public or operated as a commercial venture may be issued a Class B regulated fishing lake license. [Persons patronizing a Class B lake may catch, kill and possess fish taken therefrom without regard to size, season or possession limitation. A fishing license is required to fish in a Class B lake.]
  - (2) Lakes which meet all the requirements of this paragraph shall be classified as Class B lakes. The requirements are:
    - (i) The lake is privately owned.
    - (ii) The lake is either:
      - (A) not open to the general public; or
      - (B) not operated as a commercial venture.
    - (iii) The lake is totally man-made with no surface inlet or outlet.
    - (iv) The lake was constructed privately without the use of any Federal, State or local funds.
    - (v) Other than obtaining necessary construction permits, the lake required no other Federal, State or local action.

(vi) The lake is privately stocked with fish.

- (3) Persons using any Class B lake may catch, kill and possess fish taken therefrom without regard to size, season or possession limitation.
- (4) A fishing license is required for a person to fish in a Class B lake under paragraph (1). No fishing license shall be required for a person to fish in a Class B lake which complies with paragraph (2).

(5) The fee for a Class B lake under paragraph (2) shall not exceed \$25.

#### BILL REPORTED FROM COMMITTEE, CONSIDERED FIRST TIME, AND TABLED

HB 1062, PN 1210

An Act amending the act of December 31, 1965 (P. L. 1257, No. 511), known as "The Local Tax Enabling Act," providing that farmers shall not be required to make quarterly payments of tax on earned income under certain conditions.

#### **CONSIDERATION OF HB 650 CONTINUED**

The SPEAKER. The question before the House is the amendment offered by Representative Chadwick to HB 650, PN 718, and the question is, will the House agree to the amendment?

On that question, the author of the amendment, Representative Chadwick, from Bradford is recognized.

Mr. CHADWICK. Thank you, Mr. Speaker.

This amendment is drawn in response to a problem that was brought to my attention by one of my constituents who owns and operates a private campground. Under current law, if you own a lake which you want to allow people to fish in, you have two choices: You can either classify it a class A lake, which means that you must open it up to the general public, and in that case, the fishermen at that lake need not possess a Pennsylvania fishing license; or you can classify it a class B lake, which means you can restrict fishing to only the people you want to fish, but they must obtain a Pennsylvania fishing license.

Now, the situation with my campground owner is this: He had a campground, and he built a pond with his own money. There was no inlet or outlet stream preexisting. He built this pond with his own money at the campground, and he would like to allow just his campers to fish there, but here is his dilemma: Either he must open his private campground to the general public, to anybody and everybody who wants to fish there, which interferes with the enjoyment of the campground by his campers, or if he wants to allow only his campers to fish—and why should he not, because it is his campground and his pond—his campers have to go out and buy a Pennsylvania fishing license and comply with all the other rules and regulations.

Now, why should that campground owner be faced with that dilemma? The pond is located on his own private property. He built the pond with his own money. It is totally manmade. There was no Federal, State, or local government money involved. There is no surface inlet or outlet into the pond, and he stocked it himself with his own fish and his own money. Under those very limited circumstances, this amendment would allow that campground owner to limit fishing to his campers and not require those campers to buy a fishing license.

Now, I have also introduced this in bill form, and many of you are cosponsors of that bill. I would really appreciate a "yes" vote. Thank you, Mr. Speaker.

The SPEAKER. On the question of agreeing to the amendment, the Chair recognizes, from Montgomery County, Representative Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

I also rise to support the amendment. For many, many years people could hunt on their own ground without buying a hunting license, taking game, and at the same time if a farmer put in a pond and stocked it with fish, his own fish with his own money, he then had to buy a license to catch those same fish that he put in the pond. It really does not make a lot of sense.

This amendment is a lot more narrow than what I just illustrated here as far as a farm pond goes, but I have absolutely no problem with the amendment and rise to support it.

The SPEAKER. The question is on the amendment, and on that question, the gentleman from Indiana County, Representative Wass, is recognized.

Mr. WASS. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose the amendment. I can appreciate what the Representative is trying to accomplish. It is an isolated case. But, Mr. Speaker, it is really a confusing issue and it should appear in a freestanding bill, which the gentle-

man in April has proposed. HB 650 is a bill that should stand alone. It is a bill that this amendment again would bring another controversy about, possibly in the other body.

Inasmuch as the gentleman himself has admitted that he does have a freestanding bill, he does have sponsors, and I could join him in that sponsorship, I would trust that he would withdraw the amendment or that we would vote the amendment down.

The SPEAKER. The question is, will the House agree to the amendment? On that question, the gentleman from Centre County, Representative Letterman, is recognized.

Mr. LETTERMAN. Mr. Speaker, I rise to oppose this amendment.

In the bill what we are doing is reclassifying and making two classes of lakes instead of six classes. What we do is, under class A it is open to the general public for fishing and is operated as a commercial venture, and people may take as many fish as they want and people do not need a fishing license. For lakes less than 30 acres, we would charge them \$200, and more than 30 acres we charge them \$500.

Under the class B lake, it is not open to the general public for fishing, not operated as a commercial venture, people may take as many fish as they want, and people do need a fishing license. Less than 30 acres we charge them \$50, and more than 30 acres, \$100.

We have already cut the fishing fee, and if Mr. Chadwick's amendment goes in, he just disrupts everything that is in the bill that we have thought out for quite some time. The Fish Commission is opposed to this amendment, and they say that it would completely overturn the distinction between the class A and class B regulated fishing lakes. Also, they question how a fishing lake that supports trout could be done without water running in and water running out, because we all know that it takes oxygen to keep trout. Some fish could live in a stream where you get very little water coming in and very little going out, but not trout.

This is something that we do not understand where he is coming off from and would ask that you oppose his amendment.

Mr. LETTERMAN offered the following amendments No. A1034:

Amend Sec. 9, page 16, line 16, by inserting after "Sections" 5104,

Amend Sec. 9, page 16, by inserting between lines 17 and 18 8 5104. Fees.

The following fees apply to registrations, licenses, permits and capacity plates issued under this part and the fees collected shall be deposited in the State Treasury in the Boat Fund:

- (1) Owner registration (boats less than 16 feet in length), \$4 per year.
- (2) Owner registration (boats 16 feet or longer), \$6 per year.
  - (3) Duplicate owner registration, \$1 each.
  - (4) Dealer registration, \$15 per year.
  - (5) Additional dealer registration, \$5 each.
- (6) License for operator of passenger-carrying boat, \$5 each.
  - (7) Capacity plate, \$2 each.
- (8) [Permit for special marine event, \$2 each] <u>Transfer</u> of a multi-year boat registration, \$5.

On the question,

Will the House agree to the amendments?

The SPEAKER. On that question, Mr. Letterman from Centre is recognized.

Mr. LETTERMAN. Mr. Speaker, for the first time we have allowed the Fish Commission to issue a multiple-year license for boats, and because we do not have any kind of a transfer fee in there, I have placed a \$5 transfer fee in case someone would want to sell that boat.

I think this is really fair and it should be a pass. Thank you.

Mr. Speaker, to explain the amendment, if I might briefly explain the bill.

HB 570 changes Pennsylvania's evidentiary law with regard to spouses. Currently, in a criminal case spouses cannot testify against each other. We are one of only two States in the United States that retain this very old prohibition against spouses testifying. HB 570 provides that in cases of murder, involuntary deviate sexual intercourse, and rape, spouses can be compelled to testify against each other and for all other crimes may waive the privilege to do so.

This amendment takes out a provision in the bill which would allow spouses to testify to communications between each other. The amendment makes sure that communications between the spouses still remain privileged.

The amendment also insures that since this is simply a law of evidence, that it will apply to pending cases. Thank you, Mr. Speaker.

Mr. McNALLY. May I interrogate the gentleman, Mr. George?

The SPEAKER. The gentleman indicates he will consent to interrogation.

Mr. McNALLY. Mr. Speaker, I would have brought this up earlier to the gentleman, but just looking at the resolution, while I agree with the intent of the resolution, it seems to me that there were a number of very brave young men who were fatally injured on the U.S.S. Iowa, and it would be appropriate, in my mind, that a resolution offering condolences to all of the families who lost sons on the Iowa ought to be brought before the House. I was wondering if the gentleman, Mr. George, might be able to accommodate that.

Mr. GEORGE. Let me say, Mr. Speaker, at the start that I would have no objection, being very much aware that other young men had laid down their lives in this incident - I think one from Westmoreland and a couple out in Washington County and one in Lancaster County.

The reason that I took the initiative here is a year ago, unfortunately, when I lost a constituent in the service in the same type of incident, there were individual resolutions that were drafted and also a resolution for the entire group that was lost on that ship. I have no reservations and neither would I decline to allow any other legislator who wanted to either join with this or if they wanted to get one together, I would be happy to join with them. The purpose of this was just moving on an individual basis to let the family know just what we in the legislature felt about an individual who was willing to serve his country and lay down his life, and therefore, there is no objection from this legislator any more than there would be from you or any other member.

Mr. McNALLY. Mr. Speaker, I would simply ask one other question of the gentleman.

The SPEAKER. The gentleman is in order.

Mr. McNALLY. Mr. Speaker, would the gentleman join me and I hope the rest of the House in cosponsoring a resolution offering condolences to the rest of the families who lost sons, and perhaps we can take care of that promptly.

Mr. GEORGE. Mr. Speaker, I am sure every member of this body in some way would join with you to do just that, and I congratulate you on the thought.

#### PARLIAMENTARY INQUIRY

The SPEAKER. The question is on the adoption of HR 96, and on that question, the gentleman, Mr. Davies, is recognized from Berks County.

Mr. DAVIES. Mr. Speaker, I guess a parliamentary inquiry.

Would it not be proper, if we are going to pay honor and show respect, that we do that to all of these young men who served from the Commonwealth at the same time? Would it be possible that we could in some way or another delay that action until we could so address that?

The SPEAKER. The resolution before the House at this time is HR 96. I have heard no delaying suggestion by the sponsor.

Is the sponsor willing to delay the passage of this resolution so that an expanded resolution can be adopted under the authorship of Representative George?

Mr. GEORGE. Mr. Speaker, the reason the sponsor of this resolution proceeded in the manner in which I did was because I did not want to violate the very personal touch of any other legislator who would be involved in his district with having lost one of these young men through this accident. That is the only reason that I chose to go in this direction. As the Speaker knows, we did the same thing when we had that incident last year.

If the Speaker feels that it would be inappropriate for me to pursue this, I would certainly withhold the resolution at this time and allow the rest of the legislators who have the same involvement. I just did not want to preclude anyone. That is the reason I pursued, Mr. Speaker, on my own for the constituent who is involved in my district.

The SPEAKER. My understanding is that there were four Pennsylvanians who suffered the same fate on the Iowa. I would suggest to those members who have a death of a serviceman in their district that they sponsor separate resolutions. The gentleman is sponsoring a resolution for that in his district and I think that he is in order. I would suggest that we are able to take up the other resolutions the first part of the next day we are in session.

Kennedy Award for distinguished service in human relations; and

WHEREAS, In 1975 the Pittsburgh Board of Education named Reizenstein Middle School in her honor; and
