The SPEAKER. The Chair is happy to welcome to the hall of the House this morning Pennsylvania's Miss Pennsylvania. Her name is Denise Meyer. She is here to be introduced to the House by Representative Dave Mayernik and Representative Rick Geist. Will those two gentlemen please come to the podium with Miss Pennsylvania. Welcome.

Mr. GEIST. Thank you, Mr. Speaker.

It certainly is a pleasure for me, representing the city of Altoona, to have the privilege every year of bringing our Miss Pennsylvania to the General Assembly of Pennsylvania.

Before introducing Miss Pennsylvania, I would like to introduce some folks who came along down with her. First of all, I would like to introduce Don and Joan Meyer, her parents, and they should get a special hand for spending all that money on all the music lessons and everything else that went into making this woman Miss Pennsylvania; Mary Graham, her aunt; a very special, nice lady from Altoona, who is the chaperon for Miss Pennsylvania, Patty Harp; and now to make about half of you guys jealous, Miss Pennsylvania's close, personal friend, John Valentine.

I am not going to tell you a lot of the personal facts about Miss Pennsylvania. She is going to do that herself in her remarks. I can tell you this, that this woman from Pittsburgh is one especially accomplished person. When you hear what she has accomplished, you will know. On top of that, she is a well-rounded person and will plan to go on and finish two degrees at Carnegie-Mellon University.

I give you our reigning Miss Pennsylvania, Denise Meyer.

Miss MEYER. Thank you, Mr. Speaker, Representative Geist, honorable members of the House, and distinguished guests.

Because I was born and raised here in Pennsylvania, I am especially honored to be here to speak to you, the men and women who govern this great State.

I grew up in a little town outside the city of Pittsburgh called Avalon, graduated from Northgate High School in 1985, and am currently attending Carnegie-Mellon University where I am studying vocal performance. When I receive my bachelor's degree next spring, I plan to pursue a career in television broadcasting, hopefully in the Pittsburgh area. My ambition was always to become a professional entertainer, but through the opportunities and experiences of the Miss America program, there are so many new doors that have opened for me and career possibilities.

I began competing for the Miss Pennsylvania title 2 years ago when I was a sophomore in college, and I became Miss Allegheny County 1987. I went on to the Miss Pennsylvania Pageant in Altoona where I placed in the top 10, but not in the top 5. But being very determined, I did not give up, and I went back this past year representing Bedford County.

I am primarily a singer, although I also dance and play flute and saxophone, so I sang "Over the Rainbow" for my talent presentation, and I am very proud to say that I became Miss Pennsylvania 1988 on June 11.

Being Miss Pennsylvania has been an incredible experience for me. In the 11 months that I have worn the crown, I have traveled through nearly every county of Pennsylvania and visited as many as five States in the country meeting thousands of people, cutting ribbons, opening malls, waving in parades, and performing. I also have become a Dale Carnegie graduate and appeared on the front page of U.S.A. Today in September.

But probably the most exciting part of my reign this year was competing for the title of Miss America in Atlantic City. And even though I did not place in the top 10 there, I loved spending time and getting to know 50 of the most talented and intelligent young women across the country.

The Miss America Pageant is very unique in that it is a talent competition and a scholarship pageant. Talent is extremely important in the Miss America program, because out of the four phases of competition of swimsuit, evening gown, talent, and interview, talent is weighed most heavily, being 50 percent of your total score.

Being a scholarship pageant shows that young women of today are very well educated and are furthering that education with the help of Miss America scholarship moneys that they have received under local, State, and national levels, and this year alone the Miss America program has donated over \$6 million to women between the ages of 17 and 26 all across the United States.

As I mentioned earlier, I am attending Carnegie-Mellon University where I will be a senior this fall, and I selected this school not only because of its location but also because of its fine music and drama programs. But to be honest, it is very expensive, and coming from a middle-income family, I knew that I would be responsible for helping to put myself through school. Student loans and State grants help, but before entering the Miss Pennsylvania Pageant, I was working as many as three jobs at one time to keep up with the bills. Thank God for the Miss America program, because now I will be able to

finish my degree and look forward to a bright and beautiful future, and I believe, as I am sure that many of you do here today, that education is the key to the future. But due to the rising costs of post-high-school education, it is difficult for young people like myself to obtain a college degree. This is why national and State Government financial aid is so important, and I know that without the State grants and scholarships that I received, I would not be able to finish my education.

As a representative of young people all across Pennsylvania, I urge you to continue your support and help to finance the education for those who cannot afford it. We must help those people obtain that education that they need to become the future leaders of tomorrow, and this in turn will build and strengthen our Commonwealth and our country as well as insure you and myself a better and prosperous future.

As my reign comes to an end next Saturday night, I will have so many fond memories of a very special and exciting year, and today will certainly be one of them. Thank you for your support of the Miss Pennsylvania Scholarship Pageant and inviting me here to speak with you today. It has truly been a pleasure. Thank you.

Mr. MAYERNIK. Denise, as a Representative from the 29th Legislative District, it is truly an honor and a pleasure to have you representing us and all of Pennsylvania.

I would like to tell the members of the General Assembly a little bit about Denise. She is not only attractive and talented, but she is also intelligent. She graduated fourth in her high school class and she is pursuing two degrees - a master's degree in management and public relations and one in vocal. She also has a 3.59 average from Carnegie-Mellon University, which is excellent.

So, Denise, we wish you the best of luck, and I have a legislative citation sponsored by myself and Representative Geist that I would like to present to you.

The SPEAKER. Denise, we thank you for visiting us on your tour of Pennsylvania and in your reign this year, and we thank the Representatives who have brought you into the House and to the members' attention.

**BILLS ON THIRD
CONSIDERATION CONTINUED**

The House proceeded to third consideration of **HB 1392, PN 1709**, entitled:

An Act amending the act of July 10, 1986 (P. L. 1263, No. 116), known as the "Community Services Act," further providing for community action agencies and the board, for funding eligibility for block grants, for apportionment of appropriations, and for monitoring and remedies for block grant contracts; and extending the sunset provision.

On the question,

Will the House agree to the bill on third consideration?

Mr. PISTELLA offered the following amendment No. A1482:

Amend Sec. 1 (Sec. 6), page 5, by inserting after line 30

(6.1) (i) Notwithstanding any other provision of this section, if the total amount of Federal and State funds available for distribution to community action agencies for the fiscal year beginning July 1, 1989, and thereafter, is the same or greater than the total amount of Federal and State funds available for distribution during the 1988-1989 fiscal year, no community action agency shall receive an allocation that is less than the amount it received during the 1988-1989 fiscal year.

(ii) Notwithstanding any other provision of this section, if the total amount of Federal and State funds available for distribution to community action agencies for the fiscal year beginning July 1, 1989, and thereafter, is less than the total amount of Federal and State funds available for distribution during the 1988-1989 fiscal year, each community action agency shall receive the same percentage reduction in its allocation.

On the question,

Will the House agree to the amendment?

The SPEAKER. Does the gentleman from Allegheny, Mr. Pistella, request recognition for the purpose of complying with the rules of the House to explain the amendment? The gentleman indicates that he does so require recognition and is recognized.

Mr. PISTELLA. Thank you, Mr. Speaker.

Mr. Speaker, this amendment that I am offering today provides a floor for the distribution of State and Federal funds to community action agencies across the State. No community action agency is to receive, in the event that there would be

less State and Federal dollars available, less than the amount of money that they are receiving in the current year unless there is an equal distribution of less moneys across the State. Concurrently, any provision for an increase in the future would in fact do the same thing.

I would appreciate the support of the members for this amendment.

The SPEAKER. The question is, will the House agree to the amendment? On that question, the gentleman, the minority whip, is recognized, Mr. Hayes.

Mr. HAYES. Thank you, Mr. Speaker.

I understand the Pistella amendment to be essentially a hold-harmless amendment, but I wonder if either he or the prime sponsor of the bill, the gentleman from Dauphin County, Mr. Wambach, could indicate to the membership whether they have for distribution a set of figures as to what this amendment and the bill itself would mean with regard to individual community action groups. Just by way of information; it is not to be contentious.

Mr. PISTELLA. I apologize, Mr. Speaker. You were asking for—

Mr. HAYES. It is not my purpose to be contentious, Mr. Speaker, but I wonder if either the gentleman, Mr. Pistella, who has offered essentially a hold-harmless amendment, or the gentleman, Mr. Wambach, who serves as prime sponsor of this bill, could provide for distribution and information an indication of what dollar amounts we are talking about with regard to individual community action agencies.

The SPEAKER. Do either of the gentlemen wish to respond?

Mr. WAMBACH. Mr. Speaker?

The SPEAKER. The gentleman from Dauphin, Mr. Wambach, has asked for recognition.

Mr. WAMBACH. Mr. Speaker, the only thing I can address to the minority whip is not specific figures regarding individual community action agencies. I know the program in the past was worth about \$18 million in totality. The hold harmless for Allegheny County— They were at \$1.5 million. They would be about \$875,000 on a hold harmless, which also means, by the way, Mr. Minority Whip, that if in fact there is an increase in the program, because they are held harmless at, say, \$860,000 or \$875,000 when they should be at \$500,000, they would not benefit from those increased dollars as well. They would be held harmless at the amendment stage, and if in fact there is a decrease, that decrease shall be shared across the State.

Mr. HAYES. Thank you, Mr. Speaker.
